WEST BANK

All Districts	 At 24:00 on October 2nd 2014, the Israeli Military closed all crossings in the West Bank for Passover Holiday and prevented residents from entering Israel except those with permits, Diplomatic missions and Humanitarian cases and the closure of crossings will continue until 24:00 on October 4th 2014. 				
JERUSALEM	 Closure: On October 2nd 2014 The Israeli army, intensified their restrictions at the entrance to Jerusalem city for Passover holiday, set up several flying checkpoints on the main road leading to the city and prevented worshipers under the age of 50 from conducting prayers at Al-Aqsa mosque compound. The Israeli army continues to close the 'demarcation area' along the Wall in the area surrounding occupied East Jerusalem and restricts access to local residents as well as to civilians holding special permits. The Israeli army continues to impose a blockade and deny civilian access to a hill between Biddu and Beit Iksa villages. Closure of Main Roads:				

	Abu Dis town. (ii) The Israeli army continues to deny civilian access through the Wall gate on Al-Shayyah road in the area between Al-Sawahira Al-Sharqiya and Al-Slewahira Al-Gharbiya villages, only allowing civilians holding Jerusalem IDs to cross, after subjecting them to thorough searches using electronic devices. • Closure of Main Roads:
RAMALLAH & AL BIREH	 (i) The Israeli army continues to close the entrances to Sinjil village well as the junction to Kafr Malik and 'Ein Samiya villages. (ii) Since September 3rd 2013, Israeli forces closed the north east entrance of Al-Mughier village with dirt mounds. Flying Checkpoint: At 18:30, Israeli forces set up a checkpoint near Atarah bridge until 19:40. Physical Assault: At 21:35, Israeli forces positioned near Beit Sira village assaulted Amir Al-Khatib (A resident of Hebron) and as a result, left him hospitalised with contusions after confiscating a financial amount of 10000 NIS approximately \$2750.
JENIN	 Closure of Main Road: (i) The Israeli army continues to close with dirt mounds the road leading to the town of 'Arraba east of the illegal settlement Dotan. (ii) Since the evening of November 25th 2012, Israeli forces closed the western entrance of Ya'bad. Detention: At 02:40 on October 2nd 2014, Israeli forces detained Shafe' Al-Sa'di after storming his home in Jenin camp as mentioned in the previous report.
TULKAREM	 Closure of Main Roads: The Israeli army continues to close with dirt mounds the road connecting Kafr Al-Labad town to Shufa village. The Israeli army continues to close with dirt mounds the detour road leading to Ramin village along the Tulkarem-Nablus main road. On August 5th 2014, Israeli forces closed the main steel gate and placed cement block along the road connecting Shufa and Izbit Shufa villages near "Aveni Hivits". At 12:10 on September 2nd 2014, Israeli forces closed the main road leading to Al-Nabi Eliyas village and the agricultural road located between Qalqiliya and Nablus with cement blocks. Checkpoint: At 12:20, Israeli forces intensified their restrictions at "Eniv" checkpoint and impeded the free flow of traffic until 19:20. Temporary Detention At 18:40, Israeli forces temporary detained Jihad Al ali at the entrance of the village Shoufa.
QALQILIYA	 Closure of Roads: (i) Israeli forces continue to close with cement blocks agricultural roads east of Azzun town. (ii) In addition to closing the gate installed since the outbreak the second Intifada, the Israeli army continues to close with dirt mounds the eastern entrance to Kafr Qaddum village. (iii) At 12:10 on September 2nd 2014, Israeli forces closed the main road connecting Qalqiliya and Nablus near Al-Nabi Eliyas village with cement blocks. Raid: At 24:00, Israeli forces raided Qalqiliya. Wall Gates: (i) The Israeli army continues to restrict access at 'Azzun 'Atma Wall gate and impeded the free flow of traffic. The Israeli army continues to close with an iron gate the entrance to the village of Wadi Al- Rasha and to

	• <u>Temporary Detention:</u> At 19:20, Israeli forces positioned near "Ariel" settlement

JERICHO	 Closure of Boarder Crossing: Allenby bridge border crossing is closed for Eid Al-Adha holidays. Checkpoints: Israeli forces intensified its restrictions at Al-Hamra checkpoint set up along the road connecting Jericho and Nablus District. Flying Checkpoint: (i) At 21:30, Israeli forces set up a checkpoint at "Malee Ofrim" settlement junction, temporarily detained Mahmoud Barham (A resident of Kafr Qaddum) then released him at a later time (ii) At 00:55, Israeli forces set up a checkpoint at Dead Sea junction until
	02:05.
	 Closure: The Israeli army continues to close roads to An Nu'man village, with the exception of the road leading to the Wall gate in the south-eastern area of the village. Since 15 September 2007, the Israel army has prevented civilians from accessing or staying on 22 dunumes of confiscated land in Al Mazmuriya area in Beit Sahur and Bethlehem cities.
	• Closure of Main Roads: (i) The Israeli army continues to close the Beit Jala-Wadi Ahmed road; a road between Um Tuba and Al-Jass; a road between Um Tuba and Khilat Nu'man: a road between Um Tuba and the wall; a road between Al-Khas village and the wall; the 2 by pass roads located south of Al-Walaja; a road between Talita Qumi and Nazlat Al-Sider in Beit Jala; the eastern road of Al-Khader; the road
	between Al-Khader and Beit Jala; Wadi Rahal road near "Ifrat" settlement ,the road between Al-Khader and road #60 which lead to the eastern neighbourhoods of Bethlehem; a road leading to Wadi Rahal, and a road east of Beit Fajjar town with dirt mounds. (ii) The Israeli army continues to close the road leading to "Newe Daniyyel" settlement and agricultural land in Al-Khader; a road between Um Tuba and
BETHLEHEM	Wadi Al-Hums: Wadi Fukin, Al-Jaba, the Green Line; a road between Za'tara and a detour road, and a road between Taqou and Khirbet Al-Deir with cement blocks.
	 (iii) Since August 2nd 2012, Israeli forces closed a road leading to Beit Jalla. (iv) Since May 8th 2013, Israeli forces closed the road connecting Al-Carmisan area in Beit Jalla and Al-Walaja with a steel gate and barbed wires. (v) Since June 3rd 2013, the Israeli army closed the road connecting Nihalin and
	road 60 with dirt mounds. (vi) Since 13:20 on September 29 th 2013, the Israeli army closed a road leading to 50 acres of agricultural land in Wadi Salem area in Al-Khadr with dirt mounds.
	(vii) Israeli forces closed the main road connecting Surif and Al-Jub'a village with
	dirt mounds. (viii) On January 28 th 2014, Israeli forces closed the steel gate at the entrance of Nihalin { replacing the dirt mounds placed at the entrance since the year 2002} and placed time schedule for opening the gate from 06:00 until 14:00 on a daily bases.
	 Flying Checkpoint: At 14:50, Israeli forces set up a checkpoint at the entrance of Asakra village until 15:30. At 20:45, Israeli forces set up a checkpoint near Dar Salah village (located at the east entrance of Beit Sahur) until 22:00.

(ii) At 08:15, Israeli forces raided Al-Khader, set up a checkpoint near a local school then withdrew at 12:30.

Detention:

- (i) At 24:00, Israeli forces positioned at Container checkpoint detained Alaa Taroush (A resident of Bethlehem camp).
- (ii) Israeli forces detained Mohammad Khalil in Harmalah village.

Closure:

- (i) The Israeli army continues to close Al-Shuhada' Street, Al-Sahleh and Khuzq Al-Far areas, as well as the old gold market in Hebron's Old City. In addition to closing the entrance to Al-Qeisi neighbourhood, the Israeli army continues to close the entrances to the area of Al-Hisba (the fruits and vegetables market) with an electronic gate; Al-Laban Market also remains closed.
- (ii) Since 05 January 2009, the Israeli army has closed the area located along the Green Line south of the town of Yatta. Having seized land for Wall construction, the Israeli army evicted the Palestinian residents and denied them access to the area.

• Closure of Main Roads:

- (i) The Israeli army continues to close the entrances to Al-Thahiriya and Al-Samoa' towns, Al-'Arrub refugee camp, and Al-Tuwani and Al-Karmil villages.
- (ii) The Israeli army continues to prohibit Palestinian vehicles from travelling along the old Al-Shalala Street leading to Hebron's Old City.
- (iii) The Israeli army continues to close all roads leading to Road # 60 as well as detour roads along the settler bypass road leading to Yatta town.
- (iv) The Israeli army continues to close with dirt mounds a detour road leading to e to Al-Simiya village, the southern entrance of Al-Samou' and the entrance of Beit Annun with cement blocks.
- (v) Since July 25th 2012, Israeli forces closed the road connecting Al-Safa and Al-Dirat and closed the entrance of south Yatta with cement blocks.
- (vi) On September 4th 2014, Israeli forces closed a road in Eiwn Al-Bas and Al-Bayda and Al-Ras area in Ithna locat6ed near the wall gate.

HEBRON

(vii)At 13:40 on September 16th 2014, Israeli forces closed the main road leading to Al-Ibrahim mosque in the old city of Hebron.

Raid:

- (i) On the morning of October 2nd 2014, Israeli forces raided Assfi village located in south east Yatta, served demolition orders for a barracks owned by Ismail Makhamreh and gave him 7 days for implementation.
- (ii) At 12:15, Israeli forces raided Deir Razah village served two demolition orders for water wells owned by Othmant Amro and Bassam Amro.
- (iii)At 17:30, Israeli forces raided Al-Tabaga village and stormed a home.
- (iv) At 24:00, Israeli forces raided Surif village and stormed a home.
- (v) At 01:05, Israeli forces raided Hebron, stormed several homes then withdrew at 02:30.
- (vi)At 01:05, Israeli forces raided Yatta and stormed four homes.

At 18:55, Israeli forces shot fir at civilians near the village of El tabaga.

Settler Violence: At 18:00, an Israeli settler's vehicle ran over the child Mays Al-Razam (8 years old) and as a result left her hospitalised with contusions.

At 19:00 on August 26th 2014, Palestinian Gunmen and the Israeli military agreed to a cease fire agreement (brokered by the Arab Republic of Egypt) which includes the opening of border crossings to allow the entry of emergency supplies and humanitarian goods as well as construction material and agreed to increase the ALL DISTRICTS fishing limit to 6 nautical miles with possibility of increase to 12 nautical miles by the end of the year and to decrease the Military area to 100 meters, allow freedom of movement and a halt to targeted killings and assassinations and negotiations will be held for discussion on rebuilding the sea port and airports in the coming month. Closure of Crossing Point: Beit Hanun (Erez) is open for the passage of critical **NORTHERN** patients, journalists, NGO staff, businessmen and passengers travelling abroad **GAZA** through Al-Karama crossing with previous coordination. **Closure of Crossing Points:** (i) Al-Muntar (Karni) Crossing is closed. Beginning on 02 March 2011, the Crossing has been effectively closed following a unilateral Israeli decision. **GAZA** (ii) Al-Shija'iya (Nahal 'Oz) Crossing is closed. Beginning on 04 January 2010, the Crossing has closed following a unilateral Israeli decision. **Closure of Crossing Points:** (i) Yasser 'Arafat International Airport remains closed. (ii) Rafah (Al 'Awdah) Crossing is open for the entry and exit of residents, students, tourists and businessmen **RAFAH** (iii) Sufa Crossing is closed. (iv) Karm Abu Salem (Karem Shalom) Crossing is open for the entry of tourist and foreign diplomats and the entry of Humanitarian assistance and construction
