WEST BANK

• Closure:

- (i) On October 2nd 2015, the Israeli army, intensified their restrictions at the entrance to Jerusalem city, set up several flying checkpoints on the main road leading to the city and prevented worshipers under the age of 50 from conducting prayers at Al-Aqsa mosque compound, which forced residents to conduct prayers near checkpoints located outside Al-Aqsa mosque compound.
- (ii) The Israeli army continues to close the 'demarcation area' along the Wall in the area surrounding occupied East Jerusalem and restricts access to local residents as well as to civilians holding special permits.
- (iii) The Israeli army continues to impose a blockade and deny civilian access to a hill between Biddu and Beit Iksa villages.

• Closure of Main Roads:

- (i) The Israeli army continues to close with cement blocks and dirt mounds the entrance to Jaba' village.
- (ii) The Israeli army continues to close with an iron gate the eastern entrance to Beit Iksa village and forces civilians to access Jerusalem city through Qalandiya checkpoint.

• Checkpoints:

- (i) Israeli authorities continue to consider Qalandiya checkpoint a "border crossing point" and designate a special crossing lane for holders of Jerusalem IDs and another for those possessing permits to access Jerusalem city.
- (ii) On September 19th 2012, Israeli forces closed Ras Khamis checkpoint near Shu'fat camp and impeded the free flow of traffic in order to construct the wall.
- Flying Checkpoint: At 14:00, Israeli forces set up a checkpoint near Bir Nabalah.
- Raid: At 23:00, Israeli forces raided Al-Ram, clashed with several residents as they stormed and searched a home.

• Attack:

- (i) At 13:30, Israeli forces positioned near Qalandiya checkpoint and near Qalandiya airport road, fired rubber coated steel bullets, stun and tear gas grenades towards several residents for alleged stoning.
- (ii) At 13:30, Israeli forces positioned near North Anata junction fired stun and tear gas grenades towards several residents for alleged stoning.
- (iii) At 14:00, Israeli forces positioned in Hata and Al-Absat gates (Main gate entrances leading to Al-Aqsa mosque compound) and near Al-Massarah neighbourhood in Jerusalem fired stun and tear gas grenades towards several residents for alleged stoning.
- (iv) At 14:40, Israeli forces positioned near the North entrance of Al-Ram fired stun and tear gas grenades towards several residents for alleged stoning.
- (v) At 18:00, Israeli forces positioned near the entrance of Al-Eisawiya village fired live ammunition; rubber coated steel bullets, stun and tear gas grenades towards several residents for alleged stoning.
- (vi) At 18:00, Israeli forces positioned near AlJabal and Ras Al-Kabsa area junctions in Abu Dis fired rubber coated steel bullets, stun and tear gas grenades towards several residents for alleged stoning.

Detention:

JERUSALEM

- (i) On October 2nd 2015, Israeli forces positioned in Al-Tur neighbourhood detained Ahmad Abu Ghannam for allegedly stoning a settler's vehicle.
- (ii) At 08:00, Israeli forces positioned near Bab Al-Salaslah gate (A Main gate entrance leading to Al-Aqsa mosque compound) in the old city of Jerusalem detained Ahmad Al-Hindi (A resident of Al-Eisawiya village).

• Wall Gates:

- (i) The Israeli army continues to close with cement blocks the Wall gate in Abu Dis town.
- (ii) The Israeli army continues to deny civilian access through the Wall gate on Al-Shayyah road in the area between Al-Sawahira Al-Sharqiya and Al-Slewahira Al-Gharbiya villages, only allowing civilians holding Jerusalem IDs to cross, after subjecting them to thorough searches using electronic devices.
- <u>Closure of Main Roads:</u> The Israeli army continues to close the entrances to Sinjil village well as the junction to Kafr Malik and 'Ein Samiya villages.
- **Flying Checkpoint:** At 22:30, Israeli forces set up a checkpoint near Atarah Bridge and imped the free flow of traffic until 23:00.

• Raid:

- (i) At 17:10, Israeli forces raided Silwad, clashed with several residents then withdrew at 20:30.
- (ii) At 17:10, Israeli forces raided Al-Bireh city, clashed with several residents and as a result injured 3 residents including 2 children: Mohammad Abu Muslim (15 years old), Mohammad Al-Shafi'I (15 years old) and Raed Al-Hatouri during which Israeli forces stopped a Palestinian Red Crescent ambulance as it was transporting an injured resident and temporarily detained Raed Al-Hatouri then released him to be transported to a hospital and withdrew at 20:00.
- <u>Detention:</u> On September 30th 2015, Israeli forces detained two children: Ameer Hijjaji (17 years old) and Usayed Omar (17 years old) {both residents of Qarwat Bani Zied village}.

• Attack:

- (i) At 13:25, Israeli forces positioned near Budrous village fired rubber coated steel bullets, stun and tear gas grenades towards several residents for alleged stoning and as a result injured Mahoud Aliyan.
- (ii) At 14:00, Israeli forces positioned near Al-Jalazoun camp fired live ammunition rubber coated steel bullets, stun and tear gas grenades towards several residents for alleged stoning and as a result injured Issa Safi.
- (iii) At 14:20, Israeli forces positioned near the entrance of "Ofar" Military Base / Prison fired rubber coated steel bullets, stun and tear gas grenades towards several residents for alleged stoning.
- (iv) At 16:30, Israeli forces positioned near the entrance of Silwad fired rubber coated steel bullets, stun and tear gas grenades towards several residents for alleged stoning.
- (v) At 16:30, Israeli forces positioned near the entrance of "Pesagout" settlement located in the east area of Al-Bireh city fired stun and tear gas grenades towards several children for alleged stoning.
- (vi) At 21:40, Israeli forces positioned near Atarah bridge located in North Bir Ziet fired rubber coated steel bullets, stun and tear gas grenades towards several residents for alleged stoning.

• Settler Violence:

- (i) At 13:10, Israeli settlers positioned near "Pesagout" settlement located in the east area of Al-Bireh city attacked Jamal Qatamish's home near the settlement.
- (ii) At 14:00, Israeli settlers stormed Nab' Al-Miyah area located in Al-Nabi Saleh village then withdrew at 16:05.

• Settler Violence:

- (i) At 13:00, Israeli settlers positioned near "Karni Shamron" settlement stoned residents and vehicles passing along the main road connecting Qalqiliya and Nablus.
- (ii) At 17:00, a group of Israeli settlers positioned near Jinsafout village assaulted Jawdat Bashir and as a result left him hospitalised from contusions and fainting then withdrew at 18:20.
- **Demonstration:** At 13:00, a demonstration took place in Kafr Qaddum against the closure of the east entrance during which they clashed with Israeli forces who raided the village, occupied the rooftops of several homes and converted them into military posts and tried to disrupt the demonstration by firing live ammunition, rubber coated steel bullets, stun and tear gas grenades towards demonstrators who attempted to reach they demonstration site and as a result injured 4 residents including 2 children: Araf Ali (17 years old), Raed Jum'a (15 years old), Ahmad Mansour and Nasser Jum'a as well as leaving several others suffocated from tear gas inhalation.

• Wall Gates:

- (i) The Israeli army continues to restrict access at 'Azzun 'Atma Wall gate and impeded the free flow of traffic. The Israeli army continues to close with an iron gate the entrance to the village of Wadi Al- Rasha and to deny civilian access.
- (ii) The Israeli army allows residents to access the village through Gate #109. Having removed the gate at the entrance to the village of Ras Atiya; the Israeli army only allows students to cross to their schools outside the village through the Habla gate.
- <u>Closure:</u> Since December 17th 2013, Israeli forces ordered the closure 500 dunumes of land in Qusra village as a closed military area.

• Closure of Main Roads:

- (i) The Israeli army continues to close the roads of Til-Burin and Beit Furik-Salem; the settler bypass road connecting the village of Deir al Hatab to the settlement of Alon Moreh; the road connecting the town of 'Aqraba to the village of Osrin; and the detour road between the town of Qabalan and the village of Osrin.
- (ii) The Israeli army continues to close the northern entrance to Qabalan town; the southern entrances to the town of Jamma'in and the villages of Duma and Qaryut.
- <u>Checkpoint:</u> At 12:15 and again at 18:15, Israeli forces closed Huwara checkpoint and impeded the free flow of traffic entering Nablus then reopened it 18:50.

• Flying Checkpoint:

- (i) At 10:55, Israeli forces set up a checkpoint near "Yitsahar" settlement located in North Huwara and prevented residents from accessing the bypass road leading to Jit village junction in Qalqiliya.
- (ii) At 11:00, Israeli forces set up a checkpoint at the entrance of Beit Dajjan village.
- (iii) At 13:50, Israeli forces set up a checkpoint at the entrance of Duma village.
- (iv) At 13:50 and again at 07:00, Israeli forces set up a checkpoint at Deir Sharaf village junction located along the main road connecting Nablus and Tulkarem and prevented residents from leaving Nablus.

Raid: At 04:25, Israeli forces raided Nablus, Askar camp and Rujieb village, and occupied a home and converted it into a military post and stormed and searched several other homes and as a result injured 12 residents including child: Jihad Shakhshier (5 years old), Mohammad Kusa, Eyad Hashash, Ahmad Hazim, Abdul-Nassar Muna, Suliman Al-Sharif, Sami Obied, Diya Aqoub, Hisham Antar, Nathmi Hatab, Ziyad Antar and Mahmoud Abu Rawash and injured 3 residents: Ahmad Bushiya, Hanan Thiyab and Mohammad Abdallah after Israeli forces assaulted

- them in Al-Askar camp and detained 12 residents and served a military order for the demolition of Nour Al-Din Abu Hashiya's family home then withdrew at 08:00.
- <u>Detention:</u> Israeli forces detained 12 residents: Samir Qusa, Ragheb Alawi, Abdel Karim Muna, Bassam Abu Ghazaleh, Rashid Obied, Issa Ghalini, Abdel-Rahman Hamad, Yahya Mohammad, Rasem Khatab, Zahi Qusa, Ma'en Qusa and Abdallah Qusa.
- <u>Temporary Detention:</u> At 11:20, Israeli forces temporarily detained two residents: Khaled Jabara and Mohammad Musa as they stormed a farm and inspected surveillance camera footage then released them later.
- Attack: At 18:00, Israeli forces positioned at the entrance of Beit Furiq fired stun and tear gas grenades towards several residents for alleged stoning and as a result injured Yahya Hanini.
- <u>Installation of Military Post:</u> At 11:45, Israeli forces stormed the area between "Yitmar" and "Alon Mariya" settlements {where the 2 Israeli settlers where killed as mentioned in the previous report} and levelled a plot of land, installed several tents and mobile caravans and placed cement blocks in order to install a military post in the area.

• <u>Settler Violence:</u>

- (i) At 12:20, Israeli settlers stormed Beit Dajjan village then withdrew at a later time.
- (ii) At 12:00, Israeli settlers stormed Burin village, set fire to agricultural land then stoned Palestinian Civil Defence forces as they were extinguishing the fire
- (iii) At 24:00, Israeli settlers stormed Al-Dahiya area in Nablus then withdrew at 00:50.

• Closure of Main Roads:

- (i) The Israeli army continues to close with dirt mounds the entrance to two detour roads connecting Marda village to its farmland.
- (ii) On 15.04.2012, the Israeli army has opened the northern entrance to Salfit city to civilian which was closed since the year 2000 and prevented access from 08:00 until 09:20.
- (iii) Since 11:00 on July 30th 2012, Israeli forces have closed two roads leading to Abu Nasar and Qatan Al-Jama' located in western area of Deir Istiya with cement blocks.
- <u>Checkpoint:</u> At 18:50, Israeli forces intensified their restrictions at Za'tara checkpoint and impeded the free flow of traffic until 21:50.

• Flying Checkpoint:

- (i) At 13:05, Israeli forces set up a checkpoint at Deir Ballout junction and prevented residents from travelling to Kafr Al-Dik because of Israeli settler presence in the area.
- (ii) At 00:30, Israeli forces positioned at the entrance of Al-Zawiya.
- **Raid:** At 17:45, Israeli forces raided Kafil Harris.

• Settler Violence:

- (i) At 09:45, a group of Israeli settlers stormed the entrance of Kafr Al-Dik, stoned residents and vehicles during which they withdrew under the protection of Israeli forces who prevented residents from leaving the area until 15:30.
- (ii) At 11:40, a group of Israeli settlers stormed the main road near Harris village and waved signs with Anti-Arab slogans.
- (iii) At 12:30, a group of Israeli settlers positioned at the entrance of Deir Isatiya near "Yakir" settlement and waved signs with Anti-Arab slogans.
- (iv) At 14:20, a group of Israeli settlers stormed the entrance of Yasouf village, stoned residents and vehicles and as a result damaged a Governmental

	hospital of Salfit owned Ambulance and as a result damaged the vehicle and injured the driver who was hospitalised with contusions. (v) At 15:00, a group of Israeli settlers attacked a car, and damaged it front window near "Areil".

	 (i) The Israeli army continues to close roads to An Nu'man village, with the exception of the road leading to the Wall gate in the south-eastern area of the village. 	 Flying Checkpoint: At 13:15, Israeli forces set up a checkpoint near Al-Nashash junction area (located at the south entrance of Bethlehem). At 22:30, Israeli forces set up a checkpoint in Al-Sharafa area located near the entrance of Husan village until 22:50. Raid:

- (i) At 13:15, Israeli forces raided Husan village until 14:45.
- (ii) At 18:00, Israeli forces raided Wadi Fuqin village, temporarily detained several residents then released them at 18:15.

Attack:

- (i) At 13:20, Israeli forces positioned near Um Al-Rakaba area in Al-Khader fired stun and tear gas grenades towards several residents for alleged stoning.
- (ii) At 15:20, Israeli forces positioned near Billal Bin Rabah mosque located in North Bethlehem fired stun and tear gas grenades towards several residents for alleged stoning.
- (iii) At 18:20, Israeli forces positioned near Al-Ayda camp in Bethlehem fired stun and tear gas grenades towards several residents for alleged stoning.
- Settler Violence: At 12:30, a Israeli settler positioned near "Kafr Itsiyon" settlement junction opened fire towards Waleed Fawaz (A resident of Al-Ayda camp) and left him hospitalised with gunshot wounds

Closure:

- (i) The Israeli army continues to close Khuzq Al-Far areas, as well as the old gold market in Hebron's Old City. In addition to closing the entrance to Al-Qeisi neighbourhood, the Israeli army continues to close the entrances to the area of Al-Hisba (the fruits and vegetables market) with an electronic gate; Al-Laban Market also remains closed.
- (ii) Since 05 January 2009, the Israeli army has closed the area located along the Green Line south of the town of Yatta. Having seized land for Wall construction, the Israeli army evicted the Palestinian residents and denied them access to the area.

Closure of Main Roads:

- (i) The Israeli army continues to close the entrances to Al-Tuwani and Al-Karmil villages.
- (ii) The Israeli army continues to prohibit Palestinian vehicles from travelling along the old Al-Shalala Street leading to Hebron's Old City.
- (iii) The Israeli army continues to close all roads leading to Road # 60 as well as detour roads along the settler bypass road leading to Yatta town.
- (iv) The Israeli army continues to close with dirt mounds a detour road leading to e to Al-Simiya village, the southern entrance of Al-Samou' and the entrance of Beit Annun with cement blocks.
- (v) Since July 25th 2012, Israeli forces closed the road connecting Al-Safa and Al-Dirat and closed the entrance of south Yatta with cement blocks.
- (vi) At 11:00 on August 6th 2015, Israeli forces closed the entrance of Al-Hajara village located in south Dura with cement blocks.

Flying Checkpoint:

- (i) At 11:20, Israeli forces set up a checkpoint at the entrance of Beit Ummar.
- (ii) At 15:45, Israeli force set up two checkpoints at the entrance of Al-Urub camp and Al-Huwar junction (located at the North entrance of Halhoul).

Raid:

- (i) At 13:00, Israeli forces raided Hebron as they escorted a group of Israeli settlers who stormed "Anatole" tomb) clashed with several residents and as a result injured 3 residents including a child: Ousay Danhash (17 years old), Anas Oawasmeh and Ahmad Farihat then withdrew at 20:30.
- (ii) At 22:25, Israeli forces raided Halhoul, stormed, and searched several homes.

Detention:

HEBRON

- (i) At 18:25, Israeli forces detained Mohammad Khamasiya (A resident of Tafouh) in the old city of Hebron.
- (ii) At 20:20, Israeli forces detained Minthir Al-Ra'I in Al-Oroub camp,
- Attack: At 13:20, Israeli forces positioned near Tariq bin Zied school in the old city of Hebron and at the entrances of Beit Ummar and Al-Oroub camp fired live ammunition, rubber coated steel bullets, stun and tear gas grenades towards several residents for alleged stoning and as a result injured Ahmad Al-Qawasmi and Arafat Ghayth after he was struck by a tear gas grenade canister leaving them hospitalised with serious contusions.

• Settler Violence:

- (i) At 10:00, a group of Israeli settlers positioned near Al-Nabi Younis area junction(located along the main road connecting Hebron and Bethlehem), Wadi Qaboun and Al-Quba area'(located in North and east Hebron), near "Hagi","Tajahot" and "Atana'il" settlements stoned residents and vehicles.
- (ii) At 16:50, a group of Israeli settlers positioned in the old city of Hebron set fire to an abandoned home owned by Issam Abu Hadid.

GAZA STRIP

At 19:00 on August 26th 2014, Palestinian Gunmen and the Israeli military agreed to a cease fire agreement (brokered by the Arab Republic of Egypt) which includes the opening of border crossings to allow the entry of emergency supplies and humanitarian goods as well as construction material and agreed to increase the fishing limit to 6 nautical miles with possibility of increase to 12 nautical miles by the end of the year and to decrease the Military area to 100 meters, allow freedom of **ALL** movement and a halt to targeted killings and assassinations and negotiations will be held for discussion on rebuilding the sea port and airports in the coming month. DISTRICTS Israeli forces broke the ceasefire agreement by raiding and opening fire towards Khan Yunis. Israeli forces broke the cease-fire agreement by opening fire from their positions behind the Green Line towards Central Gaza. Israeli Naval vessels broke the ceasefire agreement by opening fire towards Palestinian fishing boats off the shores of Gaza.
