Closure: On the morning of October 2nd 2012, the Israeli army increased its restrictions (i) at checkpoints located at the entrance to Jerusalem city, set up several flying checkpoints on the main road leading to the city entrance and only allowed the entrance of those residents aged 45 and older to enter the Old City for Friday prayers because of the Jewish holiday.
