WEST BANK

• Closure:

- (i) Since dawn on October 4th 2015, the Israeli army, intensified their restrictions at the entrance to Jerusalem city, set up several flying checkpoints on the main road leading to the city and prevented worshipers under the age of 50 from conducting prayers at Al-Aqsa mosque compound.
- (ii) The Israeli army continues to close the 'demarcation area' along the Wall in the area surrounding occupied East Jerusalem and restricts access to local residents as well as to civilians holding special permits.
- (iii) The Israeli army continues to impose a blockade and deny civilian access to a hill between Biddu and Beit Iksa villages.

• Closure of Main Roads:

- (i) The Israeli army continues to close with cement blocks and dirt mounds the entrance to Jaba' village.
- (ii) The Israeli army continues to close with an iron gate the eastern entrance to Beit Iksa village and forces civilians to access Jerusalem city through Qalandiya checkpoint.
- (iii) At -2:00 on October 5th 2015, Israeli forces closed the north junction of Al-Ram with cement blocks.

JERUSALEM

Checkpoints:

- (i) Israeli authorities continue to consider Qalandiya checkpoint a "border crossing point" and designate a special crossing lane for holders of Jerusalem IDs and another for those possessing permits to access Jerusalem city.
- (ii) On September 19th 2012, Israeli forces closed Ras Khamis checkpoint near Shu'fat camp and impeded the free flow of traffic in order to construct the wall.

• Flying Checkpoint:

- (i) At 09:40, Israeli forces set up a checkpoint at the entrance of Anata.
- (ii) At 09:50, Israeli forces set up a checkpoint near Jaba' village roundabout.
- Raid: At 10:00 and again at 03:20 on October 5th 2015, Israeli forces raided Abu Dis until 07:45.

• Attack:

- (i) At 10:00, Israeli forces positioned at Bab Hata gate {A Main gate entrance leading to Al-Aqsa mosque compound} and near Wadi Al-Joz neighbourhood fired stun and tear gas grenades towards several residents for alleged stoning.
- (ii) At 11:30 and again at 21:50, Israeli forces positioned in Abu Dis fired rubber coated steel bullets, stun and tear gas grenades towards several residents for alleged stoning.
- (iii) At 13:20, Israeli forces positioned in Ras Al-Kabsa area in Abu Dis fired rubber coated steel bullets, stun and tear gas grenades towards several residents for alleged stoning.

- (iv) At 15:00 and again at 18:00, Israeli forces positioned near the North entrance of Al-Ram fired stun and tear gas grenades towards several residents for alleged stoning.
- (v) At 15:30 and again at 21:00, Israeli forces positioned at Qalandiya checkpoint fired rubber coated steel bullets, stun and tear gas grenades towards several residents for alleged stoning and as a result injured 8 residents including a child: Abdel-Rahman Al-Araj (15 years old), Samih Hamad, Tuhdi Al-Toukhi, Ahmad Zahar, Ibrahim Al-Rashid, Mohammad Abu Owiek, Ahmad Wahdan and Anas Shadim.
- (vi) At 17:00, Israeli forces positioned near the entrance of Anata and Shu'fat checkpoint fired rubber coated steel bullets, stun and tear gas grenades towards several residents for alleged stoning.
- (vii) At 19:20, Israeli forces positioned near Bab Al-Majlis gate {A main gate entrance leading to Al-Aqsa mosque compound in the old city of Jerusalem}, in Al-Sa'yada, Al-Tur and Ras Al-Amoud neighbourhoods fired rubber coated steel bullets, stun and tear gas grenades towards several residents for alleged stoning.
- (viii) At 20:00, Israeli forces positioned near the entrance of Al-Eisawiya village fired rubber coated steel bullets; stun and tear gas grenades towards several residents for alleged stoning and as a result injured an unidentified resident.
- (ix) At 20:30, Israeli forces positioned in Ain Al-Louza area in Silwan neighbourhood fired stun and tear gas grenades towards several residents for alleged stoning.
- (x) At 21:00, Israeli forces positioned in Al-Thuri neighbourhood and at the entrance of Shu'fat camp fired rubber coated steel bullets, stun and tear gas grenades towards several residents for alleged stoning and as a result injured Mohammad Burqan who detained and then hospitalised with critical head injury.

• Detention:

- (i) On the evening of October 3rd 2015, Israeli forces detained Layth Rayan (A resident of Beit Duqu).
- (ii) At 02:55 on October 4th 2015, Israeli forces detained Abdallah Hushiyeh during their raid into Qutna village as mentioned in the previous report.
- (iii) At 19:00, Israeli forces positioned along Al-Wad road in the old city of Jerusalem detained Oday Fatriji.
- (iv) At 19:45, Israeli forces detained Abdel-Afo Abu Rabaya (A resident of Al-Ram).
- (v) At 21:00, Israeli forces detained Mohammad Awadallah (a resident of Shu'fat camp).
- (vi) At 21:15, Israeli forces detained 2 residents: Mohammad Adiqat and Hussein Sab Laban in Wadi Al-Joz neighbourhood in Jerusalem.
- (vii)Israeli forces detained Mohammad Bruqan (Critically injured) in AL-Thuri neighbourhood.
- <u>Injury:</u> At 03:00 on October 4th 2015, Hanna Mahamid (A Journalist) was injured during confrontations between residents and Israeli forces during their raid into Al-Eisawiya village as mentioned in the previous report.
- Physical Assault: At 19:25, Israeli forces positioned near Bab Al-Sahara gate {A main gate entrance leading to Al-Aqsa mosque compound in the old city of Jerusalem} assaulted Ameer Farahat (A resident of the old city of Jerusalem).
- <u>Assault on Places of Worship:</u> At 08:00, a group of Israeli settlers under the protection of Israeli military and Police forces stormed Al-Aqsa mosque compound in the old city of Jerusalem and provoked worshipers.
- Settler Violence:

- (i) At 10:15, a group of Israeli settlers positioned in Al-Sheikh Jarrah neighbourhood stoned residents and vehicles and as a result damaged 3 vehicles owned by Al-Muhisien family.
 (ii) At 11:15, a group of Israeli settlers armed with knives positioned near Bab.
- (ii) At 11:15, a group of Israeli settlers armed with knives positioned near Bab Al-Magharbneh gate (A main gate entrance leading to Al-Aqsa mosque compound in the old city of Jerusalem) assaulted and stabbed Taysir Abu Ramouz leaving him hospitalised with stab wounds and contusions.
- (iii) At 12:15, a group of Israeli settlers positioned in Jerusalem assaulted Ahmad Al-Malahi (A resident of Shu'fat) leaving him hospitalised with contusions.
- (iv) At 20:55, a group of Israeli settlers positioned in Jerusalem assaulted Ibrahim Aliyan (A resident of Beit Safafa village).
- (v) At 22:50, a group of Israeli settlers positioned in Jerusalem assaulted Abu Tawfiq Dandis (A resident of Ras Al-Amoud neighbourhood).

• Wall Gates:

- (i) The Israeli army continues to close with cement blocks the Wall gate in Abu Dis town.
- (ii) The Israeli army continues to deny civilian access through the Wall gate on Al-Shayyah road in the area between Al-Sawahira Al-Sharqiya and Al-Slewahira Al-Gharbiya villages, only allowing civilians holding Jerusalem IDs to cross, after subjecting them to thorough searches using electronic devices.

• Closure of Main Roads:

- (i) The Israeli army continues to close the entrances to Sinjil village well as the junction to Kafr Malik and 'Ein Samiya villages.
- (ii) On October 3rd 2015, Israeli forces closed the main road located near "Bet El" settlement and leading to Al-Jalazoun camp with cement blocks.
- <u>Checkpoints:</u> At 23:35, Israeli forces closed Al-Mahakma checkpoint located near "Bet El" settlement in North Al-Bireh city and impeded the free flow of traffic until reopening it at a later time.
