	(i) The Israeli army, intensified their restrictions at the entrance to Jerusalem city, set up several flying checkpoints on the main road leading to the city and prevented worshipers under the age of 50 from conducting prayers at Al-Aqsa mosque compound.
	(ii) The Israeli army continues to close the 'demarcation area' along the Wall in the area surrounding occupied East Jerusalem and restricts access to local residents as well as to civilians holding special permits.
	(iii) The Israeli army continues to impose a blockade and deny civilian access to a hill between Biddu and Beit Iksa villages.

	(i) The Israeli army continues to close with cement blocks and dirt mounds the entrance to Jaba' village.

	Destruction of Property: At 10:00, Israeli forces stormed Bruqin village and served a demolition order to demolish a barracks and uproot several Olive trees
	owned by Ziyad Barakat.
	<u>Settler Violence:</u> At 05:50, Israeli settlers under the protection of Israeli forces stormed Kafil Harris, provoked several residents then withdrew at 06:05.
	<u>Checkpoints:</u> Israeli forces intensified its restrictions at Al-Hamra checkpoint set up along the road connecting Jericho and Nablus District.
	• Flying Checkpoint:
JERICHO	(i) At 16:15 and again at 18:00, Israeli forces set up a checkpoint at the south

- (ii) The Israeli army continues to close the road leading to "Newe Daniyyel" settlement and agricultural land in Al-Khader; a road between Um Tuba and Wadi Al-Hums: Wadi Fukin, Al-Jaba, the Green Line; a road between Za'tara and a detour road, and a road between Taqou and Khirbet Al-Deir with cement blocks.
- (iii) Since August 2nd 2012, Israeli forces closed a road leading to Beit Jalla.
- (iv) Since May 8th 2013, Israeli forces closed the road connecting Al-Carmisan area in Beit Jalla and Al-Walaja with a steel gate and barbed wires.
- (v) Since June 3rd 2013, the Israeli army closed the road connecting Nihalin and road 60 with dirt mounds.
- (vi) Since 13:20 on September 29th 2013, the Israeli army closed a road leading to 50 acres of agricultural land in Wadi Salem area in Al-Khadr with dirt mounds.
- (vii) Israeli forces closed the main road connecting Surif and Al-Jub'a village with dirt mounds.
- (viii) On January 28th 2014, Israeli forces closed the steel gate at the entrance of Nihalin { replacing the dirt mounds placed at the entrance since the year 2002} and placed time schedule for opening the gate from 06:00 until 14:00 on a daily bases.
- <u>Flying Checkpoint:</u> At 21:55, Israeli forces set up a checkpoint at the West entrance of Taqou 'until 22:30.

• Raid:

- (i) At 15:55 and again at 04:10, Israeli forces raided Taqou', occupied Mohammad Adibs home and converted its rooftop into a military post, during which Israeli forces clashed with several residents and as a result injured 2 residents including a child: Ahmad Al-Amour(17 years old) and Ahmad Abu Mifrih, detained a resident then withdrew at 05:00.
- (ii) At 02:35, Israeli forces raided Husan village, detained two residents then withdrew at 03:35.

• Detention:

- (i) Israeli forces detained Zakariya Sabah in Tagou'.
- (ii) Israeli forces detained two residents: Amir Hamarat and Miras Hamarat in Husan village.

• Closure:

- (i) The Israeli army continues to close Al-Shuhada' Street, Al-Sahleh and Khuzq Al-Far areas, as well as the old gold market in Hebron's Old City. In addition to closing the entrance to Al-Qeisi neighbourhood, the Israeli army continues to close the entrances to the area of Al-Hisba (the fruits and vegetables market) with an electronic gate; Al-Laban Market also remains closed.
- (ii) Since 05 January 2009, the Israeli army has closed the area located along the Green Line south of the town of Yatta. Having seized land for Wall construction, the Israeli army evicted the Palestinian residents and denied them access to the area.

Closure of Main Roads:

(i) The Israeli army continues to close the entrances to Al-Thahiriya and Al-Samoa' towns, Al-'Arrub refugee camp, and Al-Tuwani and Al-Karmil villages.

- (ii) The Israeli army continues to prohibit Palestinian vehicles from travelling along the old Al-Shalala Street leading to Hebron's Old City.
- (iii) The Israeli army continues to close all roads leading to Road # 60 as well as detour

HEBRON

- roads along the settler bypass road leading to Yatta town.
- (iv) The Israeli army continues to close with dirt mounds a detour road leading to e to Al-Simiya village, the southern entrance of Al-Samou' and the entrance of Beit Annun with cement blocks.
- (v) Since July 25th 2012, Israeli forces closed the road connecting Al-Safa and Al-Dirat and closed the entrance of south Yatta with cement blocks.
- (vi) On September 4th 2014, Israeli forces closed a road in Eiwn Al-Bas and Al-Bayda and Al-Ras area in Ithna locat6ed near the wall gate.
- (vii)At 13:40 on September 16th 2014, Israeli forces closed the main road leading to Al-Ibrahim mosque in the old city of Hebron.
- Raid: At 02:15, Israeli forces raided Hebron, stormed and searched a home then withdrew at 03:30.
- <u>Attack:</u> At 15:15, Israeli forces positioned at Al-Shalashleh road in the old city of Hebron fired stun and tear gas grenades towards several residents for alleged stoning.

GAZA STRIP

At 19:00 on August 26th 2014, Palestinian Gunmen and the Israeli military agreed to a cease fire agreement (brokered by the Arab Republic of Egypt) which includes the opening of border crossings to allow the entry of emergency supplies and humanitarian goods as well as construction material and agreed to increase the fishing limit to 6 nautical miles with possibility of increase to 12 nautical miles by the end of the year and to decrease the Military area to 100 meters, allow freedom of movement and a halt to targeted killings and assassinations and negotiations will be held for discussion on rebuilding the sea port and airports in the coming month. Israeli Naval vessels broke the cease-fire agreement by opening fire towards

Israeli Naval vessels broke the cease-fire agreement by opening fire towards Palestinian fishing boats off the shores of North Gaza.

NORTHERN GAZA	 Closure of Crossing Point: Beit Hanun (Erez) is open for the passage of critical patients, journalists, NGO staff, businesspersons and passengers travelling abroad through Al-Karama crossing with previous coordination. Attack: On the morning of October 7th 2014, Israeli Naval vessels opened fire towards Palestinian fishing boats off the shores of Al-Waha area located in west Beit Lahiya.
GAZA	Closure of Crossing Points: (i) Al-Muntar (Karni) Crossing is closed. Beginning on 02 March 2011, the Crossing has been effectively closed following a unilateral Israeli decision. (ii) Al-Shija'iya (Nahal 'Oz) Crossing is closed. Beginning on 04 January 2010, the Crossing has closed following a unilateral Israeli decision.
RAFAH	 Closure of Crossing Points: (i) Yasser 'Arafat International Airport remains closed. (ii) Rafah (Al 'Awdah) Crossing is closed (iii) Sufa Crossing is closed. (iv) Karm Abu Salem (Karem Shalom) Crossing is closed.
