JERUSALEM	<ul style="list-style-type: none"> • <u>Closure:</u> <ul style="list-style-type: none"> (i) On October 10th 2014 The Israeli army, intensified their restrictions at the entrance to Jerusalem city, set up several flying checkpoints on the main road leading to the city and prevented worshipers under the age of 50 from conducting prayers at Al-Aqsa mosque compound. (ii) The Israeli army continues to close the ‘demarcation area’ along the Wall in the area surrounding occupied East Jerusalem and restricts access to local residents as well as to civilians holding special permits. (iii) The Israeli army continues to impose a blockade and deny civilian access to a hill between Biddu and Beit Iksa villages. • <u>Closure of Main Roads:</u> <ul style="list-style-type: none"> (i) The Israeli army continues to close with cement blocks and dirt mounds the entrance to Jaba’ village. (ii) The Israeli army continues to close with an iron gate the eastern entrance to Beit Iksa village and forces civilians to access Jerusalem city through Qalandiya checkpoint. • <u>Checkpoints:</u> <ul style="list-style-type: none"> (i) Israeli authorities continue to consider Qalandiya checkpoint a “border crossing point” and designate a special crossing lane for holders of Jerusalem IDs and another for those possessing permits to access Jerusalem city and closed the checkpoint at 01:20 and impeded the free flow of traffic until 04:05. (ii) On September 19th 2012, Israeli forces closed Ras Khamis checkpoint near Shu’fat camp and impeded the free flow of traffic in order to construct the wall. (iii) At 17:00, Israeli forces intensified their restrictions at Jaba’ checkpoint located along the main road connecting Ramallah, Jericho and Jerusalem. • <u>Raid:</u> At 20:50, Israeli forces raided Beit Ijza village and clashed with its residents. • <u>Attack:</u> <ul style="list-style-type: none"> (i) At 17:00, Israeli forces positioned near Al-Ram junction fired stun and tear gas grenades towards several residents for alleged stoning (ii) On the evening of October 10th 2014, Israeli forces positioned in Silwan neighbourhood in Jerusalem fired stun and tear gas grenades towards several residents for alleged stoning and as a result injured 3 residents including a child • <u>Wall Gates:</u> <ul style="list-style-type: none"> (i) The Israeli army continues to close with cement blocks the Wall gate in

	<p>Abu Dis town.</p> <p>(ii) The Israeli army continues to deny civilian access through the Wall gate on Al-Shayyah road in the area between Al-Sawahira Al-Sharqiya and Al-Slewahira Al-Gharbiya villages, only allowing civilians holding Jerusalem IDs to cross, after subjecting them to thorough searches using electronic devices.</p>
<p>RAMALLAH & AL BIREH</p>	<ul style="list-style-type: none"> • <u>Closure of Main Roads:</u> <ul style="list-style-type: none"> (i) The Israeli army continues to close the entrances to Sinjil village well as the junction to Kafr Malik and ‘Ein Samiya villages. (ii) Since September 3rd 2013, Israeli forces closed the north east entrance of Al-Mughier village with dirt mounds. • <u>Raid:</u> <ul style="list-style-type: none"> (i) At 01:10, Israeli forces raided Awarta until 02:45. (ii) At 03:00, Israeli forces raided Beituniya, summoned Ghalib Hamad to report to Israeli intelligence for questioning the withdrew at 03:15 • <u>Attack:</u> <ul style="list-style-type: none"> (i) At 18:05, Israeli forces positioned at the entrance of “Ofar” Military Base/Prison fired stun and tear gas grenades towards several residents for alleged stoning and as a result injured two residents including a child: Salah Al-Din Nazal (15 years old) and Hussein Al-Shawamra. (ii) At 18:15, Israeli forces positioned at the entrance of Silwad fired stun and tear gas grenades towards several residents for alleged stoning. • <u>Temporary Detention:</u> At 15:50, Israeli forces positioned near “Bet El” settlement temporarily detained the child: Ali Najlah (16 years old){A resident of Al-Jalazoun camp} for alleged stoning then released him at a later time • <u>Demonstrations:</u> <ul style="list-style-type: none"> (i) At 13:40, a demonstration took place in Bil’in protesting against the construction of the wall during which they clashed with Israeli forces and as a result suffocated several residents from tear gas inhalation. (ii) At 13:40, a demonstration took place in Ni’lin protesting against the construction of the wall during which they clashed with Israeli forces and as a result suffocated several residents from tear gas inhalation. (iii) At 13:40, a demonstration took place in Al-Nabi Saleh village protesting against land confiscation for the purpose of Israeli settlement construction during which they clashed with Israeli forces and as result injured the child: Karim Al-Tamimi, and an International Peace Activist and also left several others suffocated from tear gas inhalation during which Israeli forces assaulted and sprayed pepper spray onto the face of Billal Al-Tamimi (A journalist)

(ii) Since the evening of November 25th 2012, Israeli forces closed the western entrance of Ya’bad. • <u>Raid:</u> At 09:30, Israeli forces raided Al-Atarah village until 10:00.
<p>TUBAS</p>	<ul style="list-style-type: none"> • <u>Flying Checkpoint:</u> At 08:50, Israeli forces set up a checkpoint at the entrance of Bardala village until 09:00
<p>TULKAREM</p>	<ul style="list-style-type: none"> • <u>Closure of Main Roads:</u> <ul style="list-style-type: none"> (i) The Israeli army continues to close with dirt mounds the road connecting Kafr Al-Labad town to Shufa village. (ii) The Israeli army continues to close with dirt mounds the detour road leading to Ramin village along the Tulkarem-Nablus main road. (iii) On August 5th 2014, Israeli forces closed the main steel gate and placed cement block along the road connecting Shufa and Izbit Shufa villages

	<p>near “Aveni Hivits”.</p> <p>(iv) At 12:10 on September 2nd 2014, Israeli forces closed the main road leading to Al-Nabi Eliyas village and the agricultural road located between Qalqiliya and Nablus with cement blocks.</p> <ul style="list-style-type: none"> • Checkpoint: Israeli forces continue to intensify their restrictions at “Eniv” checkpoint and impeded the free flow of traffic.
<p>QALQILIYA</p>	<ul style="list-style-type: none"> • Closure of Roads: <ul style="list-style-type: none"> (i) Israeli forces continue to close with cement blocks agricultural roads east of Azzun town. (ii) In addition to closing the gate installed since the outbreak the second Intifada, the Israeli army continues to close with dirt mounds the eastern entrance to Kafr Qaddum village. (iii) At 12:10 on September 2nd 2014, Israeli forces closed the main road connecting Qalqiliya and Nablus near Al-Nabi Eliyas village with cement blocks. • Demonstration: At 13:00, a demonstration took place in Kafr Qaddum against the closure of the east entrance during which they clashed with Israeli forces who tried to disrupt the demonstration and left several demonstrators suffocated from tear gas inhalation. • Wall Gates: <ul style="list-style-type: none"> (i) The Israeli army continues to restrict access at ‘Azzun ‘Atma Wall gate and impeded the free flow of traffic. The Israeli army continues to close with an iron gate the entrance to the village of Wadi Al- Rasha and to deny civilian access. (ii) The Israeli army allows residents to access the village through Gate #109. Having removed the gate at the entrance to the village of Ras Atiya; the Israeli army only allows students to cross to their schools outside the village through the Habla gate.
<p>NABLUS</p>	<ul style="list-style-type: none"> • Closure: Since December 17th 2013, Israeli forces ordered the closure 500 dunumes of land in Qusra village as a closed military area. • Closure of Main Roads: <ul style="list-style-type: none"> (i) The Israeli army continues to close the roads of Til-Burin and Beit Furik-Salem; the settler bypass road connecting the village of Deir al Hatab to the settlement of Alon Moreh; the road connecting the town of ‘Aqraba to the village of Osrin; and the detour road between the town of Qabalan and the village of Osrin. (ii) The Israeli army continues to close the northern entrance to Qabalan town; the southern entrances to the town of Jamma’in and the villages of Duma and Qaryut. • Checkpoint: At 23:00, Israeli forces intensified their restrictions at Huwara checkpoint and impeded the free flow of traffic until 23:30 • Raid: At 01:30, Israeli forces raided Zuwata village, detained five residents then withdrew at 02:40. • Detention: Israeli forces detained 5 residents: Moyad Hamdi, Mu’tasim Hamdi,,Mohammad Hamdi, Sadam Hamdi and Ahmad Hamdi in Zuwata village
<p>SALFIT</p>	<ul style="list-style-type: none"> • Closure of Main Roads: <ul style="list-style-type: none"> (i) The Israeli army continues to close with dirt mounds the entrance to two detour roads connecting Marda village to its farmland. (ii) On 15.04.2012, the Israeli army has opened the northern entrance to Salfit city to civilian, which was closed since the year 2000 and prevented access from 08:00 until 09:20. (iii) Since 11:00 on July 30th 2012, Israeli forces have closed two roads leading to Abu Nasar and Qatan Al-Jama’ located in western area of Deir Istiya with cement blocks.

	<ul style="list-style-type: none"> • <u>Checkpoints:</u> Israeli forces intensified their restrictions at Za'tara checkpoint and impeded the free flow of traffic. • <u>Settler Violence:</u> At 15:00, Israeli settlers stormed Marda village and set fire to agricultural land located near the wall gate near "Ariel" settlement and as a result destroyed 100 Olive trees owned by Wasif Juhier.
<p style="text-align: center;">JERICHO</p>	<ul style="list-style-type: none"> • <u>Closure of Boarder Crossing:</u> Allenby bridge border crossing is closed for Eid Al-Adha holidays. • <u>Checkpoints:</u> Israeli forces intensified its restrictions at Al-Hamra checkpoint set up along the road connecting Jericho and Nablus District. • <u>Flying Checkpoint:</u> <ul style="list-style-type: none"> (i) At 10:10 and again at 18:05, Israeli forces set up a checkpoint at the Dead Sea junction until 19:05. (ii) At 17:30, Israeli forces set up a checkpoint along the main road in Al-Oja village until 17:45. • <u>Detention:</u> At 18:40, Israeli forces positioned at Allenby Bridge detained Amjad Yahya (A resident of Al-Arqa village in Jenin).
<p style="text-align: center;">BETHLEHEM</p>	<ul style="list-style-type: none"> • <u>Closure:</u> <ul style="list-style-type: none"> (i) The Israeli army continues to close roads to An Nu'man village, with the exception of the road leading to the Wall gate in the south-eastern area of the village. (ii) Since 15 September 2007, the Israel army has prevented civilians from accessing or staying on 22 dunumes of confiscated land in Al Mazmuriya area in Beit Sahur and Bethlehem cities. • <u>Closure of Main Roads:</u> <ul style="list-style-type: none"> (i) The Israeli army continues to close the Beit Jala-Wadi Ahmed road; a road between Um Tuba and Al-Jass ; a road between Um Tuba and Khilat Nu'man: a road between Um Tuba and the wall; a road between Al-Khas village and the wall; the 2 by pass roads located south of Al-Walaja; a road between Talita Qumi and Nazlat Al-Sider in Beit Jala; the eastern road of Al-Khader; the road between Al-Khader and Beit Jala ; Wadi Rahal road near "Ifrat" settlement ,the road between Al-Khader and road #60 which lead to the eastern neighbourhoods of Bethlehem; a road leading to Wadi Rahal, and a road east of Beit Fajjar town with dirt mounds. (ii) The Israeli army continues to close the road leading to "Newe Daniyyel" settlement and agricultural land in Al-Khader; a road between Um Tuba and Wadi Al-Hums: Wadi Fukin, Al-Jaba, the Green Line; a road between Za'tara and a detour road, and a road between Taqou and Khirbet Al-Deir with cement blocks. (iii) Since August 2nd 2012, Israeli forces closed a road leading to Beit Jalla. (iv) Since May 8th 2013, Israeli forces closed the road connecting Al-Carmisan area in Beit Jalla and Al-Walaja with a steel gate and barbed wires. (v) Since June 3rd 2013, the Israeli army closed the road connecting Nihalin and road 60 with dirt mounds. (vi) Since 13:20 on September 29th 2013, the Israeli army closed a road leading to 50 acres of agricultural land in Wadi Salem area in Al-Khadr with dirt mounds. (vii) Israeli forces closed the main road connecting Surif and Al-Jub'a village with dirt mounds. (viii) On January 28th 2014, Israeli forces closed the steel gate at the entrance of Nihalin { replacing the dirt mounds placed at the entrance since the year 2002} and placed time schedule for opening the gate from 06:00 until 14:00 on a daily bases. • <u>Flying Checkpoint:</u> <ul style="list-style-type: none"> (i) At 15:45, Israeli forces set up a checkpoint at the north entrance of Taqou'

<p>HEBRON</p>	<ul style="list-style-type: none"> • <u>Closure:</u> <ul style="list-style-type: none"> (i) The Israeli army continues to close Al-Shuhada' Street, Al-Sahleh and Khuzq Al-Far areas, as well as the old gold market in Hebron's Old City. In addition to closing the entrance to Al-Qeisi neighbourhood, the Israeli army continues to close the entrances to the area of Al-Hisba (the fruits and vegetables market) with an electronic gate; Al-Laban Market also remains closed. (ii) Since 05 January 2009, the Israeli army has closed the area located along the Green Line south of the town of Yatta. Having seized land for Wall construction, the Israeli army evicted the Palestinian residents and denied them access to the area. • <u>Closure of Main Roads:</u> <ul style="list-style-type: none"> (i) The Israeli army continues to close the entrances to Al-Thahiriya and Al-Samoa' towns, Al-'Arrub refugee camp, and Al-Tuwani and Al-Karmil villages. (ii) The Israeli army continues to prohibit Palestinian vehicles from travelling along the old Al-Shalala Street leading to Hebron's Old City. (iii) The Israeli army continues to close all roads leading to Road # 60 as well as detour roads along the settler bypass road leading to Yatta town. (iv) The Israeli army continues to close with dirt mounds a detour road leading to e to Al-Simiya village, the southern entrance of Al-Samou' and the entrance of Beit Annun with cement blocks. (v) Since July 25th 2012, Israeli forces closed the road connecting Al-Safa and Al-Dirat and closed the entrance of south Yatta with cement blocks. (vi) On September 4th 2014, Israeli forces closed a road in Eiw Al-Bas and Al-Bayda and Al-Ras area in Ithna located near the wall gate. (vii) At 13:40 on September 16th 2014, Israeli forces closed the main road leading to Al-Ibrahim mosque in the old city of Hebron. • <u>Flying Checkpoint:</u> <ul style="list-style-type: none"> (i) At 15:10, Israeli forces set up a checkpoint along the road near Wadi Sa'ir until 16:20. (ii) At 15:10, Israeli forces set up a checkpoint at the entrance of Al-Samou' until 16:30. (iii) At 15:40, Israeli forces set up a checkpoint at the North entrance of Hebron until 16:50. (iv) At 16:35, Israeli forces set up a checkpoint at the entrance of Yatta until 17:30. (v) At 20:00, Israeli forces set up a checkpoint at Al-Fuwar junction until 21:00. (vi) At 24:00, Israeli forces set up a checkpoint near Sheyukh Al-Urub village

(ii) At 18:05, Israeli forces positioned near Al-Tabaqa village fired live ammunition, rubber coated steel bullets stun and tear gas grenades towards several residents for alleged stoning and as a result injured 2 children: Riyad Abu Ras (16 years old) and Moath Al-Shahaytat (17 years old). • <u>Destruction of Property:</u> On October 10th 2014, Israeli force stormed east Yatta, served a demolition order for a barracks owned by Ismail Makaharat and a tent owned by Ali Awad.

Beginning on 04 January 2010, the Crossing has closed following a unilateral Israeli decision. • <u>Killing:</u> On October 10th 2014, Suhayel Tafish (A resident of Al-Shuja'ya neighbourhood) died of injuries sustained from the Israeli assault on the Gaza Strip.

(ii) Rafah (<i>Al 'Awdah</i>) Crossing is open for the entry and exit of residents, students, tourists and businesspersons. (iii) Sufa Crossing is closed. (iv) Karm Abu Salem (Karem Shalom) Crossing is closed
