- Since August 2<sup>nd</sup> 2012, Israeli forces closed a road leading to Beit Jalla. (iii)
- Flying Checkpoint: At 18:00, Israeli forces set up a checkpoint Al-Nashash iunction (the southern entrance to Bethlehem).
- Raid: At 02:05, Israeli forces raided Beit Sahur.

#### **Settler Violence:**

- (i) On October 15th 2012, Israeli settlers stormed agricultural land in Al-Khadr and uprooted 20 olive trees and 15 Grape vines owned by Riziq
- (ii) At 23:00, Israeli settlers closed Al-Nashash junction, chanted racist slogans against Arabs then withdrew at 23:45.
- Wall Construction: Wall construction continued northwest of Beit Jala town.

#### **Closure:**

- (i) The Israeli army continues to close Al-Shuhada' Street, Al-Sahleh and Khuzq Al-Far areas, as well as the old gold market in Hebron's Old City. In addition to closing the entrance to Al-Qeisi neighbourhood, the Israeli army continues to close the entrances to the area of Al-Hisba (the fruits and vegetables market) with an electronic gate; Al-Laban Market also remains closed.
- Since 05 January 2009, the Israeli army has closed the area located along the (ii) Green Line south of the town of Yatta. Having seized land for Wall construction, the Israeli army evicted the Palestinian residents and denied them access to the area.

#### **Closure of Main Roads:**

- The Israeli army continues to close the entrances to Al-Thahiriya and Al-(i) Samoa' towns, Al-'Arrub refugee camp, and Al-Tuwani and Al-Karmil villages.
- The Israeli army continues to prohibit Palestinian vehicles from travelling (ii) along the old Al-Shalala Street leading to Hebron's Old City.
- The Israeli army continues to close all roads leading to Road # 60 as well as (iii) detour roads along the settler bypass road leading to Yatta town.
- (iv) The Israeli army continues to close with dirt mounds a detour road leading to the entrance to Al-Simiya village, the southern entrance of Al-Samou' and the entrance of Beit Annun with cement blocks.
- On July 25th 2012, Israeli forces closed the road connecting Al-Safa and Al-Dirat (v) and also closed the entrance of south Yatta with cement blocks.

#### **Flying Checkpoint:**

- (i) At 08:35, Israeli forces set up a checkpoint at Al-Nabi Yunis junction.
- (ii) At 17:30, Israeli forces set up a checkpoint at Beit Annun junction.
- Attack: At 13:00, Israeli forces positioned at the entrance of Beit Ummar fired tear gas grenades towards residents participating in a funeral at Beit Ummar cemetery for alleged stoning leaving several residents suffocating from tear gas inhalation.
- Physical Assault: At 20:20, Israeli forces positioned at the entrance of Beit Ummar assaulted and injured Ashraf Sabarna as he was returning home leaving him hospitalised with contusions for allegedly throwing a Molotov bomb towards a military post.
- **Destruction of Property:** On October 15<sup>th</sup> 2012, Israeli forces positioned at the wall gate near Beit Ulla served demolition orders for 2 water wells and levelled 12 dunumes of land on agricultural land and uprooted several olive trees during which Israeli forces refused to allow Abdel Salam Nasar and Khalil Al-Lama from entering their land for a period of 2 weeks.
- Settler Violence: On October 15<sup>th</sup> 2012, Israeli settlers stormed agricultural land in Al-Qumsa area and damaged several olive tree owned by Abdallah
