<p style="text-align: center;">JERUSALEM</p>	<ul style="list-style-type: none"> • <u>Closure:</u> <ul style="list-style-type: none"> (i) On October 17th 2014 The Israeli army, intensified their restrictions at the entrance to Jerusalem city, set up several flying checkpoints on the main road leading to the city and prevented worshipers under the age of 50 from conducting prayers at Al-Aqsa mosque compound. (ii) The Israeli army continues to close the ‘demarcation area’ along the Wall in the area surrounding occupied East Jerusalem and restricts access to local residents as well as to civilians holding special permits. (iii) The Israeli army continues to impose a blockade and deny civilian access to a hill between Biddu and Beit Ikksa villages. • <u>Closure of Main Roads:</u> <ul style="list-style-type: none"> (i) The Israeli army continues to close with cement blocks and dirt mounds the entrance to Jaba’ village. (ii) The Israeli army continues to close with an iron gate the eastern entrance to Beit Ikksa village and forces civilians to access Jerusalem city through Qalandiya checkpoint. • <u>Checkpoints:</u> <ul style="list-style-type: none"> (i) Israeli authorities continue to consider Qalandiya checkpoint a “border crossing point” and designate a special crossing lane for holders of Jerusalem IDs and another for those possessing permits to access Jerusalem city and closed the checkpoint at 01:20 and impeded the free flow of traffic until 04:05. (ii) On September 19th 2012, Israeli forces closed Ras Khamis checkpoint near Shu’fat camp and impeded the free flow of traffic in order to construct the wall. • <u>Flying Checkpoint:</u> At 15:30, Israeli forces set up a checkpoint at Jaba’ junction. • <u>Attack:</u> At 21:00, Israeli forces positioned in Al-Salasla Gate (which leads to Al-Aqsa mosque compound in the old city of Jerusalem) fired rubber coated steel bullets, stun and tear gas grenades towards several residents for alleged stoning during which they stormed several homes, assaulted several residents and detained two residents including one with severe head injuries. • <u>Detention:</u> Israeli forces positioned near Al-Salasleh gate (which leads to Al-Aqsa mosque compound in the old city of Jerusalem) detained two residents: Mohammad Sharha and Hamza Khalaf. • <u>Injury:</u> On the evening of October 18th 2014, Ala-Al-Din Sharabati fractured his arm after an Israeli Military Jeep rammed him as he was riding his motorcycle near Wadi Al-Joz neighbourhood in Jerusalem. • <u>Home Demolition:</u> On October 18th 2014, Israeli forces forced Amin Abdel-Haq to demolish his own home and imposed a hefty financial penalty for allegedly being built without a proper licence. • <u>Wall Gates:</u> <ul style="list-style-type: none"> (i) The Israeli army continues to close with cement blocks the Wall gate in Abu Dis town. (ii) The Israeli army continues to deny civilian access through the Wall gate on Al-Shayyah road in the area between Al-Sawahira Al-Sharqiya and Al-Slewahira Al-Gharbiya villages, only allowing civilians holding Jerusalem IDs to cross, after subjecting them to thorough searches using electronic devices.

(ii) Since September 3rd 2013, Israeli forces closed the north east entrance of

	<p>Al-Mughier village with dirt mounds.</p> <ul style="list-style-type: none"> • <u>Flying Checkpoint:</u> At 18:55, Israeli forces set up a checkpoint at the east entrance of Al-Mughier and impeded the free flow of traffic.
JENIN	<ul style="list-style-type: none"> • <u>Closure of Main Road:</u> <ol style="list-style-type: none"> (i) The Israeli army continues to close with dirt mounds the road leading to the town of ‘Arraba east of the illegal settlement Dotan. (ii) Since the evening of November 25th 2012, Israeli forces closed the western entrance of Ya’bad.
TUBAS	<ul style="list-style-type: none"> • <u>Raid:</u> At 17:00, Israeli forces raided Ibbiq village and served Imad Nasr-Allah a military order to leave the area and remove his barrack’s then withdrew at 17:30.
TULKAREM	<ul style="list-style-type: none"> • <u>Closure of Main Roads:</u> <ol style="list-style-type: none"> (i) The Israeli army continues to close with dirt mounds the road connecting Kafr Al-Labad town to Shufa village. (ii) The Israeli army continues to close with dirt mounds the detour road leading to Ramin village along the Tulkarem-Nablus main road. (iii) On August 5th 2014, Israeli forces closed the main steel gate and placed cement block along the road connecting Shufa and Izbit Shufa villages near “Aveni Hivits”. (iv) At 12:10 on September 2nd 2014, Israeli forces closed the main road leading to Al-Nabi Eliyas village and the agricultural road located between Qalqiliya and Nablus with cement blocks. • <u>Checkpoint:</u> At 09:30, the Israeli Military continues to intensify their restrictions in the area between Bal’a and Bazariya.
QALQILIYA	<ul style="list-style-type: none"> • <u>Closure of Roads:</u> <ol style="list-style-type: none"> (i) Israeli forces continue to close with cement blocks agricultural roads east of Azzun town. (ii) In addition to closing the gate installed since the outbreak the second Intifada, the Israeli army continues to close with dirt mounds the eastern entrance to Kafr Qaddum village. (iii) At 12:10 on September 2nd 2014, Israeli forces closed the main road connecting Qalqiliya and Nablus near Al-Nabi Eliyas village with cement blocks. • <u>Flying Checkpoint:</u> At 22:30, Israeli forces set up a checkpoint at the east entrance of Qalqiliya until 23:30. • <u>Raid:</u> <ol style="list-style-type: none"> (i) At 21:40, Israeli forces raided Azzun. (ii) At 01:40, Israeli forces raided Qalqiliya, detained a resident then withdrew at 20:20. • <u>Detention:</u> Israeli forces detained Nidal Al-Jabr in Qalqiliya. • <u>Temporary Detention:</u> At 13:30, Israeli forces temporarily detained Nasser Barham as he was harvesting Olives in agricultural land in Kafr Qaddum village then released him later. • <u>Wall Gates:</u> <ol style="list-style-type: none"> (i) The Israeli army continues to restrict access at ‘Azzun ‘Atma Wall gate and impeded the free flow of traffic. The Israeli army continues to close with an iron gate the entrance to the village of Wadi Al- Rasha and to deny civilian access. (ii) The Israeli army allows residents to access the village through Gate #109. Having removed the gate at the entrance to the village of Ras Atiya; the Israeli army only allows students to cross to their schools outside the village through the Habla gate.
	<ul style="list-style-type: none"> • <u>Closure:</u> Since December 17th 2013, Israeli forces ordered the closure 500 dunumes of land in Qusra village as a closed military area. • <u>Closure of Main Roads:</u>

<p style="text-align: center;">NABLUS</p>	<ul style="list-style-type: none"> (i) The Israeli army continues to close the roads of Til-Burin and Beit Furik-Salem; the settler bypass road connecting the village of Deir al Hatab to the settlement of Alon Moreh; the road connecting the town of ‘Aqraba to the village of Osrin; and the detour road between the town of Qabalan and the village of Osrin. (ii) The Israeli army continues to close the northern entrance to Qabalan town; the southern entrances to the town of Jamma’in and the villages of Duma and Qaryut. • Checkpoint: At 18:40, Israeli forces intensified their restrictions at Huwara checkpoint until 20:10. • Flying Checkpoint: <ul style="list-style-type: none"> (i) At 10:50, Israeli forces set up a checkpoint in the area between Aqraba and Osirin village until 12:00. (ii) At 11:05, Israeli forces set up a checkpoint at “Yitsahar” settlement junction located in North Huwara until 12:00. (iii) At 13:30, Israeli forces set up a checkpoint at Qabalan junction until 15:30. (iv) At 19:50, Israeli forces set up a checkpoint at Beit Dajjan village junction until 20:45. • Raid: At 03:05, Israeli forces raided Azmout village, stormed two homes then withdrew at 05:10.

(ii) On 15.04.2012, the Israeli army has opened the northern entrance to Salfit city to civilian, which was closed since the year 2000 and prevented access from 08:00 until 09:20. (iii) Since 11:00 on July 30th 2012, Israeli forces have closed two roads leading to Abu Nasar and Qatan Al-Jama’ located in western area of Deir Istiya with cement blocks. • Checkpoints: At 22:05, Israeli forces intensified their restrictions at Za’tara checkpoint and impeded the free flow of traffic until 23:00. • Settlement Activity: <ul style="list-style-type: none"> (i) At 17:00, the Israeli military began levelling plots of land near “Brujin” settlement which is located between Bruqin and Deir Istiya in order to build new settlement unites. (ii) At 17:00, the Israeli Military began levelling plots of land near “Amanwa’el” settlement which is located on land in Deir Istiya in order to pave a road connecting “Krani Shomron” settlement which is located on land in Azzun in Qalqiliya with Amanwa’el” settlement .

(ii) At 15:30 and again at 00:35, Israeli forces set up a checkpoint at the south entrance of Jericho until 00:55. (iii) At 03:25, Israeli forces set up a checkpoint at the Dead Sea junction until 03:35
<p style="text-align: center;">BETHLEHEM</p>	<ul style="list-style-type: none"> • Closure: <ul style="list-style-type: none"> (i) The Israeli army continues to close roads to An Nu’mān village, with the exception of the road leading to the Wall gate in the south-eastern area of the village.

	<p>(ii) Since 15 September 2007, the Israel army has prevented civilians from accessing or staying on 22 dunums of confiscated land in Al Mazmuriya area in Beit Sahur and Bethlehem cities.</p> <ul style="list-style-type: none"> • <u>Closure of Main Roads:</u> <ul style="list-style-type: none"> (i) The Israeli army continues to close the Beit Jala-Wadi Ahmed road; a road between Um Tuba and Al-Jass ; a road between Um Tuba and Khilat Nu'man: a road between Um Tuba and the wall; a road between Al-Khas village and the wall; the 2 by pass roads located south of Al-Walaja; a road between Talita Qumi and Nazlat Al-Sider in Beit Jala; the eastern road of Al-Khader; the road between Al-Khader and Beit Jala ; Wadi Rahal road near "Ifrat" settlement ,the road between Al-Khader and road #60 which lead to the eastern neighbourhoods of Bethlehem; a road leading to Wadi Rahal, and a road east of Beit Fajjar town with dirt mounds. (ii) The Israeli army continues to close the road leading to "Newe Daniyyel" settlement and agricultural land in Al-Khader; a road between Um Tuba and Wadi Al-Hums: Wadi Fukin, Al-Jaba, the Green Line; a road between Za'tara and a detour road, and a road between Taqou and Khirbet Al-Deir with cement blocks. (iii) Since August 2nd 2012, Israeli forces closed a road leading to Beit Jalla. (iv) Since May 8th 2013, Israeli forces closed the road connecting Al-Carmisan area in Beit Jalla and Al-Walaja with a steel gate and barbed wires. (v) Since June 3rd 2013, the Israeli army closed the road connecting Nihalin and road 60 with dirt mounds. (vi) Since 13:20 on September 29th 2013, the Israeli army closed a road leading to 50 acres of agricultural land in Wadi Salem area in Al-Khadr with dirt mounds. (vii) Israeli forces closed the main road connecting Surif and Al-Jub'a village with dirt mounds. (viii) On January 28th 2014, Israeli forces closed the steel gate at the entrance of Nihalin { replacing the dirt mounds placed at the entrance since the year 2002} and placed time schedule for opening the gate from 06:00 until 14:00 on a daily bases. • <u>Raid:</u> <ul style="list-style-type: none"> (i) At 21:20, Israeli forces raided Al-Khadr, opened fire towards several residents for alleged firebombing of a settler's vehicle as it passed near road 60. (ii) At 00:20, Israeli forces raided Taqou', clashed with its residents then withdrew at 00:45. (iii)At 02:10, Israeli forces raided Bethlehem, Al-Duhisheh camp and Irtas village, stormed several homes in the camp, summoned Mohammad Al-Ja'farawi to report to Israeli intelligence for questioning then withdrew at 05:30. (iv)At dawn on October 19th 2014, Israeli forces raided Husan village, detained 2 residents after storming their homes • <u>Detention:</u> Israeli forces detained Majdi Hamarah and Nassri Hamarah in Husan village.
	<ul style="list-style-type: none"> • <u>Closure:</u> <ul style="list-style-type: none"> (i) The Israeli army continues to close Al-Shuhada' Street, Al-Sahleh and Khuzq Al-Far areas, as well as the old gold market in Hebron's Old City. In addition to closing the entrance to Al-Qeisi neighbourhood, the Israeli army continues to close the entrances to the area of Al-Hisba (the fruits and vegetables market) with an electronic gate; Al-Laban Market also remains closed. (ii) Since 05 January 2009, the Israeli army has closed the area located along the Green Line south of the town of Yatta. Having seized land for Wall construction, the Israeli army evicted the Palestinian residents and denied them access to the

Beginning on 02 March 2011, the Crossing has been effectively closed following a unilateral Israeli decision. (ii) Al-Shija'iyah (Nahal 'Oz) Crossing is closed. Beginning on 04 January 2010, the Crossing has closed following a unilateral Israeli decision.
