Closure:

- On October 18th 2015, the Israeli army, continues to intensify their (i) restrictions at the entrance to Jerusalem city, set up several flying checkpoints on the main road leading to the city and prevented worshipers from conducting prayers at Al-Agsa mosque compound and prevented residents entering the
- The Israeli army continues to close the 'demarcation area' along the Wall in the (ii) area surrounding occupied East Jerusalem and restricts access to local residents as well as to civilians holding special permits.
- The Israeli army continues to impose a blockade and deny civilian access to a (iii) hill between Biddu and Beit Iksa villages.

Closure of Main Roads:

- The Israeli army continues to close with cement blocks and dirt mounds the (i) entrance to Jaba' village.
- The Israeli army continues to close with an iron gate the eastern entrance to Beit (ii) Iksa village and forces civilians to access Jerusalem city through Oalandiya checkpoint.
- On October 14th 2015, Israeli forces closed the main road leading to Al-(iii) Eisawiya village with cement blocks.
- On October 14th 2015, Israeli forces closed the 4 entrances of Jabal Al-Mukabir (iv) neighbourhood with cement blocks.
- On October 14th 2015, Israeli forces closed the three entrances of Sur Bahar with (v) Cement blocks.
- On October 14th 2015, Israeli forces closed the entrance of Al-Tur (vi) neighbourhood (leading to Al-Za'im village in Jericho and Al-Eizariya) and Suliman French road with cement blocks.
- On October 14th 2015, Israeli forces closed the entrance of Wadi Al-Rabaybeh (vii) area in Silwan neighbourhood in Jerusalem with cement blocks.

Checkpoint:

- (i) Israeli forces considers Qalandiya checkpoint to be a border crossing point and only allows residents with Jerusalem Identification cards to enter the checkpoint.
- (ii) Since September 19th 2012, Israeli forces closed Ras Khamis and Shu'fat checkpoints and impeded the free flow of traffic in order to complete the construction of the wall.
- (iii) At 14:00, Israeli forces intensified their restrictions at Qalandiya, Shu'fat, Hizma and Al-Za'im checkpoints and impeded the free flow of traffic.
- Raid: At 20:00, Israeli forces raided Abu Dis until 20:50.
- Attack: At 20:50, Israeli forces positioned at Al-Jabal area junction stun and tear gas grenades towards residents for alleged stoning.

Detention:

- (i) At 05:40 on October 18th 2015, Israeli forces positioned in Bab Hata gate (A Main gate entrance leading to Al-Aqsa mosque compound) in the old city of Jerusalem detained 2 residents Mahmoud Jodat Al-Shawish and Ma'moun Ghayth.
- (ii) At 13:10, Israeli forces detained Mohammad Eyad Salaymeh in the old city of Jerusalem.
- (iii) At 17:20, Israeli forces detained 3 children: Imad Khaled Abu Ghannam (15 years old), Maher Ahmad Sabri Al-Sayad (15 years old) and Mohammad Samir Abu Al-Hawa (14 years old).

The Israeli army continues to close the northern entrance to Qabalan town; the (ii) southern entrances to the town of Jamma'in and the villages of Duma and **NABLUS** Qaryut. At 22:00, Israeli forces closed the North entrance of Awarta with dirt mounds. (iii) Flying Checkpoint: (i) At 12:20, Israeli forces set up a checkpoint at the entrance of Yatma village. (ii) At 22:40, Israeli forces set up a checkpoint at the entrance of Jama'in. Raid: (i) At 02:15, Israeli forces raided Assira Al-Shimaliya until 05:35. (ii) At 02:40, Israeli forces raided Beit Furiq until 05:35. (iii) At 02:45, Israeli forces raided Beit Dajjan village, stormed several homes and summoned 5 residents: Harbi Abu Jish, Ahmad Abdel-Rahman Abu Jish, Abdalllah Jamal Hanni, Adli Amari and Mohammad Salah Hanni to report to Israeli intelligence for questioning then withdrew at 05:35. (iv) At 03:40, Israeli forces raided Nablus and clashed with several residents and as a result injured the child Bara' Musa Fayez Zahiman leaving hospitalised. **Temporary Detention:** At 15:30, Israeli forces positioned at Huawara checkpoint temporarily detained 2 PLC {Palestinian Legislative Council} members: Hassan Khurisheh and Hassan Yusef. **Settler Violence:** (i) At 21:15, a group of Israeli settlers stormed Huwara and damaged several merchant shops for alleged shooting of an Israeli settler vehicle by unknown assailants. (ii) At 21:15, a group of Israeli settlers stormed Rujieb village during which local residents were able to prevent the settler attack and forced them to leave the area at 01:50. (iii) At 23:00, a group of Israeli settlers positioned at Huwara checkpoint stoned residents and vehicles passing through the checkpoint. **Closure of Main Roads:** The Israeli army continues to close with dirt mounds the entrance to two detour (i) roads connecting Marda village to its farmland. On 15.04.2012, the Israeli army has opened the northern entrance to Salfit city (ii) to civilian which was closed since the year 2000 and prevented access from 08:00 until 09:20. Since 11:00 on July 30th 2012, Israeli forces have closed two roads leading to (iii) Abu Nasar and Qatan Al-Jama' located in western area of Deir Istiya with cement blocks. At 09:20 on October 13th 2015, Israeli forces closed the west entrance of Kafr (iv) Al-Dik with cement blocks. **SALFIT** Checkpoint: Israeli forces intensified their restrictions at Za'tara checkpoint and impeded the free flow of traffic. **Flying Checkpoint:** (i) At 20:25, Israeli forces set up a checkpoint in the area between Bruqin and Kafr Al-Dik, assaulted Ismail Eyad Ali Ahmad (A resident of Kafr Al-Dik) then withdrew at 22:00. (ii) At 20:45, Israeli forces set up a checkpoint in the area between Kafil Harris and Harris villages. **Raid:** At 01:00, Israeli forces raided Al-Zawiya, stormed 2 homes then withdrew at

02:20.

	• <u>Temporary Detention:</u> At 23:10, Israeli forces positioned at Allenby Bridge temporarily detained two residents including a woman and her son: Ra'siya Mohammad Abu Ayash and Omar Kamal Abu Ayash as they were returning from Jordan then released them at 24:00.
	• Closure:
	(i) The Israeli army continues to close roads to An Nu'man village, with the exception of the road leading to the Wall gate in the south-eastern area of the village.
	(ii) Since 15 September 2007, the Israel army has prevented civilians from accessing or staying on 22 dunumes of confiscated land in Al Mazmuriya area in Beit Sahur and Bethlehem cities.
	Closure of Main Roads:

	• Flying Checkpoint: (i) At 17:00, Israeli forces set up a checkpoint at the North West entrance of Beit Jallah.

- (ii) At 21:10, Israeli forces set up a checkpoint in Aqbat Hasnah area located near Husan.
- (iii) At 23:05, Israeli forces set up a checkpoint beneath Za'tara bridge until 02:10.
- Raid: At 01:10, Israeli forces raided Taqou', stormed and searched four homes and detained 6 residents including 4 children.
- <u>Detention:</u> Israeli force detained 6 residents including 4 children: Ma'moun Rateb Hamoud Al-Amour (15 years old), Mo'ayad Abdallah Al-Amour (14 years old), Musa Jawdat Al-Amour (14 years old), Haleel Ali Abu Mifrih (15 years old), Mohammad Ribhi Saber Al-Amour and Jabis Dkhlalah Ahmad Al-Amour during their raid into Taqou'.

• Attack:

- (i) At 08:00, Israeli forces positioned near "Murad Tourist Resort" located near Dar Salah village near the east entrance of Beit Sahour fired rubber coated steel bullets, stun and tear gas grenades towards several residents for alleged stoning.
- (ii) At 11:10, Israeli forces positioned near Dar Salah village near the east entrance of Beit Sahour fired rubber coated steel bullets, stun and tear gas grenades towards several residents for alleged stoning and as a result injured Ahmad Nidal Al-Hazibi after he was struck by a tear gas grenade canister to the head.
- (iii) At 16:05, Israeli forces positioned in the vicinity of Billal Bin Rabah mosque located in North Bethlehem fired live ammunition, rubber coated steel bullets, stun and tear gas grenades towards several residents for alleged stoning.
- (iv) At 18:30, Israeli forces positioned at the entrance of Taqou' fired live ammunition, rubber coated steel bullets, and stun and tear gas grenades towards several residents for alleged stoning and as a result injured Mohammad Al-Amour.

• Closure:

- (i) The Israeli army continues to close Khuzq Al-Far areas, as well as the old gold market in Hebron's Old City. In addition to closing the entrance to Al-Qeisi neighbourhood, the Israeli army continues to close the entrances to the area of Al-Hisba (the fruits and vegetables market) with an electronic gate; Al-Laban Market also remains closed.
- (ii) Since 05 January 2009, the Israeli army has closed the area located along the Green Line south of the town of Yatta. Having seized land for Wall construction, the Israeli army evicted the Palestinian residents and denied them access to the area.

• Closure of Main Roads:

- (i) The Israeli army continues to close the entrances to Al-Karmil villages.
- (ii) The Israeli army continues to prohibit Palestinian vehicles from travelling along the old Al-Shalala Street leading to Hebron's Old City.
- (iii) The Israeli army continues to close all roads leading to Road # 60 as well as detour roads along the settler bypass road leading to Yatta town.
- (iv) The Israeli army continues to close with dirt mounds a detour road leading to e to Al-Simiya village, the southern entrance of Al-Samou' and the entrance of Beit Annun with cement blocks.
- (v) Since July 25th 2012, Israeli forces closed the road connecting Al-Safa and Al-Dirat and also closed the entrance of south Yatta with cement blocks.
- (vi) At 11:00 on August 6th 2015, Israeli forces closed the entrance of Al-Hajara village located in south Dura with cement blocks.

• Flying Checkpoint:

- (i) At 09:00, Israeli forces set up a checkpoint at the entrance of Wadi Qabbun area located in North Hebron.
- (ii) At 17:20, Israeli forces set up a checkpoint at the entrance of Beit Ummar.
- (iii) At 19:15, Israeli forces set up a checkpoint at the entrance of Al-Fahs area located in Hebron.
- (iv) At 19:55, Israeli forces set up a checkpoint at the bypass road located near "Hadji" settlement in south Hebron.
- Raid: At 18:30, Israeli forces raided Hebron, detained a resident, clashed with several residents as they stormed a home and summoned Mahmoud Ibrahim Murqatan to report to Israeli intelligence for questioning then withdrew at 04:50.

• Attack:

- (i) At 09:55, Israeli forces positioned near the entrance of Beit Kahil fired rubber coated steel bullets, stun and tear gas grenades towards several residents for alleged stoning and as a result injured 4 residents including Ziyad Anwar Asafra.
- (ii) At 10:00 and again at 18:50, Israeli forces positioned in Bab Al-Zawiya area in Hebron fired live ammunition, rubber coated steel bullets, stun and tear gas grenades towards several residents for alleged stoning and as a result injured 5 residents: Ahmad Mohammad Ahmad Al-Sa'aydeh Suhayeb Jihad Al-Rajabi, Taha Hassan Ahmad Al-Tarda, Thaer Anwar Masak and Ahmad Mohammad Samara.
