JERUALEM	<ul style="list-style-type: none"> • <u>Closure:</u> <ul style="list-style-type: none"> (i) On October 22nd 2015, the Israeli army, intensified their restrictions at the entrance to Jerusalem city, set up several flying checkpoints on the main road leading to the city and prevented worshippers from conducting prayers at Al-Aqsa mosque compound. (ii) The Israeli army continues to close the ‘demarcation area’ along the Wall in the area surrounding occupied East Jerusalem and restricts access to local residents as well as to civilians holding special permits. (iii) The Israeli army continues to impose a blockade and deny civilian access to a hill between Biddu and Beit Iksa villages. • <u>Closure of Main Roads:</u> <ul style="list-style-type: none"> (i) The Israeli army continues to close with cement blocks and dirt mounds the entrance to Jaba’ village. (ii) The Israeli army continues to close with an iron gate the eastern entrance to Beit Iksa village and forces civilians to access Jerusalem city through Qalandiya checkpoint. (iii) On October 14th 2015, Israeli forces closed the main road leading to Al-Eisawiya village with cement blocks. (iv) On October 14th 2015, Israeli forces closed the four entrances of Jabal Al-Mukabir neighbourhood with cement blocks. (v) On October 14th 2015, Israeli forces closed the three entrances of Sur Bahar with Cement blocks. (vi) On October 14th 2015, Israeli forces closed the entrance of Al-Tur neighbourhood (leading to Al-Za’im village in Jericho and Al-Eizariya) and Suliman French road with cement blocks. (vii) On October 14th 2015, Israeli forces closed the entrance of Wadi Al-Rabaybeh area in Silwan neighbourhood in Jerusalem with cement blocks. • <u>Checkpoints:</u> <ul style="list-style-type: none"> (i) Israeli authorities continue to consider Qalandiya checkpoint a “border crossing point” and designate a special crossing lane for holders of Jerusalem IDs and another for those possessing permits to access Jerusalem city. (ii) On September 19th 2012, Israeli forces closed Ras Khamis checkpoint near Shu’fat camp and impeded the free flow of traffic in order to construct the wall. (iii) At 18:05, Israeli forces closed Jaba’ checkpoint, which connects Jerusalem, Ramallah and Jericho and impeded the free flow of traffic then reopened it later. • <u>Flying Checkpoint:</u> At 12:40, Israeli forces set up a checkpoint at the entrance of Biddu until 15:00.

	<ul style="list-style-type: none"> • <u>Raid:</u> <ul style="list-style-type: none"> (i) At 04:00 on October 22nd 2015, Israeli forces raided Biddo, detained two residents and temporarily detained the child Ahmad Mohammad Jaber Ayash (14 years old) then released him at 08:10. (ii) At 13:30, Israeli forces raided Al-Ram and clashed with several residents. (iii) At 18:30 and again at 23:00, Israeli forces raided Al-Eisawiya village , clashed with several residents and as a result injured Loa'i Faysal Obied (critically injured and as a result lost his left eye) and again clashed with residents as they stormed and searched a home and as a result injured Malik Obied. • <u>Attack:</u> <ul style="list-style-type: none"> (i) At 12:30, Israeli forces positioned in Al-Jabal area junction near Abu Dis fired stun and tear gas grenades towards several residents for alleged stoning. (ii) At 13:35, Israeli forces positioned near the wall gate in Al-Eizariya fired stun and tear gas grenades towards several residents for alleged stoning. (iii) At 22:40, Israeli forces positioned near the entrance of Hizma village fired stun and tear gas grenades towards several residents for alleged stoning. (iv) At 23:50, Israeli forces positioned in Dahiyat Al-Barid area in Al-Ram fired stun and tear gas grenades towards several residents for alleged stoning. • <u>Detention:</u> <ul style="list-style-type: none"> (i) At 00:45 on October 22nd 2015, Israeli forces detained eight residents in Jerusalem neighbourhoods: Tariq Al-Saman, Amer Al-Muhtaseb, Ahmad Abu Maialeh, Moath Idris, Moa`yad Idris, Khaled Waleed Obied, Mahmoud Abu Ta'a and Bassam Hijazi. (ii) Israeli forces detained Ayman Obied and Ahmad Zahran in Biddo. • <u>Assault on Places of Worship:</u> At 08:00, Israeli settlers under the protection of Israeli forces and Israeli Police stormed Al-Aqsa mosque compound in the old city of Jerusalem and provoked worshippers. • <u>Wall Gates:</u> <ul style="list-style-type: none"> (i) The Israeli army continues to close with cement blocks the Wall gate in Abu Dis town. (ii) The Israeli army continues to deny civilian access through the Wall gate on Al-Shayyah road in the area between Al-Sawahira Al-Sharqiya and Al-Slewahira Al-Gharbiya villages, only allowing civilians holding Jerusalem IDs to cross, after subjecting them to thorough searches using electronic devices.

(ii) Since October 3rd 2015, Israeli forces closed the main road near "Bet El" settlement leading to Al-Jalazoun camp with cement blocks. (iii) At 23:30 on October 20th 2015, Israeli forces closed the entrance of Ni'lin with cement blocks. • <u>Flying Checkpoint:</u> <ul style="list-style-type: none"> (i) At 08:45, Israeli forces set up a checkpoint at Beit Ur Al-Foqa village until 09:00.

(ii) At 22:20, Israeli forces raided Ramallah until 00:35. (iii) At 23:05, Israeli forces raided Khirbitha Al-Misbah village, searched two homes then withdrew at 24:00. (iv) At 23:20, Israeli forces raided Beit Ur Al-Tahta and clashed with several residents. (v) At 24:00, Israeli raided Safa village, clashed with several residents as they stormed a home and summoned Mohammad Naser to report to Israeli Intelligence for questioning then withdrew at 01:00. (vii) At 02:15, Israeli forces raided Beituniya, detained a resident then withdrew at 03:10. • <u>Attack:</u> <ul style="list-style-type: none"> (i) At 12:30, Israeli forces positioned in the vicinity of "Pesagout" settlement located in east Al-Bireh city fired rubber coated steel bullets, stun and tear gas grenades towards several residents for alleged stoning and detained 5 residents including a child and temporarily detained Mohammad Ahmad Ali Khalil (12 years old) then released him at a later time and damaged a vehicle owned by Nabeel Al-Hindi (A they detained him) then withdrew at 13:15. (ii) At 14:50, Israeli forces positioned near the entrance of "Ofar" Military Base/Prison fired stun and tear gas grenades towards several residents for alleged stoning. (iii) At 17:30, Israeli forces positioned in the vicinity of "Al-Mahakma checkpoint" located near "Bet El" settlement in North Al-Bireh fired live ammunition, rubber coated steel bullets, stun and tear gas grenades towards several residents for alleged stoning as they were protesting against the Israeli Military and settler acts of aggression and their assault on Al-Aqsa mosque compound and acts of violence against residents. • <u>Detention:</u> <ul style="list-style-type: none"> (i) Israeli forces detained Munthir Othman Zahran in Deir Abu Mash'al village. (ii) Israeli forces detained Ahmad Harish in Beituniya. (iii) Israeli forces detained 5 residents: Ibrahim Abu Sayf (16 years old), Mohammad Na'im Al-Shafi'i, Akram Al-Hindi, Samer Issa Abu Yacoub and Nabeel Al-Hindi near Pesagout" settlement located in east Al-Bireh city. • <u>Settler Violence:</u> At 16:00, a group of Israeli settlers positioned near "Bet El" settlement located in North Al-Bireh city set fire to three Olive trees in an agricultural land near Al-Jalazoun camp.
<p style="text-align: center;">JENIN</p>	<ul style="list-style-type: none"> • <u>Closure of Main Road:</u> <ul style="list-style-type: none"> (i) The Israeli army continues to close with dirt mounds the road leading to the town of 'Arraba east of the illegal settlement Dotan. (ii) Since the evening of November 25th 2012, Israeli forces closed the western entrance of Ya'bad. • <u>Raid:</u> At 12:20, Israeli forces raided Al-Jabriyat area in Jenin.

	<ul style="list-style-type: none"> • <u>Detention:</u> At dawn on October 22nd 2015, Israeli detained Khaled Mahmoud Mansour during their raid into Beit Qad village in addition to those mentioned in the previous report. • <u>Wall Gates:</u> Israeli forces continue to close the wall gate and only allow those holding special permits to enter through it.
TUBAS	<ul style="list-style-type: none"> • <u>Raid:</u> At 01:30, Israeli forces raided Al-Far'a camp until 02:00.
TULKAREM	<ul style="list-style-type: none"> • <u>Checkpoint:</u> Israeli forces continue to intensify their restrictions at "Eniv" checkpoint located along the main road connecting Tulkarem and Nablus and impeded the free flow of traffic. • <u>Flying Checkpoint:</u> At 19:40, Israeli forces set up a checkpoint at Beit Lid junction until 21:05. • <u>Attack:</u> <ol style="list-style-type: none"> (i) At 09:20, Israeli forces positioned in "Ghishouri" factory area located in West Tulkarem fired live ammunition, rubber coated steel bullets, stun and tear gas grenades towards several residents for alleged stoning and as a result injured 4 residents: Islam Ayman Rajeh Abed, Husam Waleed Zaghoul and Islam Wajeeh Mohammad Salameh and also suffocated Naseem Na'im Shakourah from tear gas inhalation and Israeli forces assaulted and injured Mujahid Amar Fakhouri. (ii) At 14:10, Israeli forces positioned near wall gate (664) located near Shwakiya neighbourhood in Tulkarem opened fire towards several residents and farmers as they were collecting Olive harvest on agricultural land in the area.
QALQILIYA	<ul style="list-style-type: none"> • <u>Closure of Roads:</u> <ol style="list-style-type: none"> (i) Israeli forces continue to close with cement blocks agricultural roads east of Azzun town. (ii) In addition to closing the gate installed since the outbreak the second Intifada, the Israeli army continues to close with dirt mounds the eastern entrance to Kafr Qaddum village. (iii) Since 10:40 on September 1st 2015, Israeli forces closed an agricultural road leading to Far'ata village, which is located near "Gillad" settlement with a steel gate. • <u>Raid:</u> At 14:05, Israeli forces raided Qalqiliya until 15:20. • <u>Attack:</u> At 20:50, Israeli forces positioned at Jaljouliya gate located in south Qalqiliya fired stun and tear gas grenades towards several residents for alleged stoning. • <u>Wall Gates:</u> <ol style="list-style-type: none"> (i) The Israeli army continues to restrict access at 'Azzun 'Atma Wall gate and impeded the free flow of traffic. The Israeli army continues to close with an iron gate the entrance to the village of Wadi Al- Rasha and to deny civilian access. (ii) The Israeli army allows residents to access the village through Gate #109. Having removed the gate at the entrance to the village of Ras Atiya; the Israeli army only allows students to cross to their schools outside the village through the Habla gate.
	<ul style="list-style-type: none"> • <u>Closure:</u> Since December 17th 2013, Israeli forces ordered the closure 500 dunums of land in Qusra village as a closed military area. • <u>Closure of Main Roads:</u> <ol style="list-style-type: none"> (i) The Israeli army continues to close the roads of Til-Burin and Beit Furik-Salem; the settler bypass road connecting the village of Deir al Hatab to the settlement of Alon Moreh; the road connecting the town of 'Aqraba to the village of Osrin; and the detour road between the town of Qabalan and the village of Osrin.

<p>NABLUS</p>	<ul style="list-style-type: none"> (ii) The Israeli army continues to close the northern entrance to Qabalan town; the southern entrances to the town of Jamma'in and the villages of Duma and Qaryut. (iii) At 22:00 on October 3rd 2015, Israeli forces closed the North entrance of Awarta village with dirt mounds. <ul style="list-style-type: none"> • Checkpoint: At 19:05, Israeli forces intensified their restrictions at Huwara checkpoint and impeded the free flow of traffic until 20:30. • Flying Checkpoint: <ul style="list-style-type: none"> (i) At 20:50, Israeli forces set up a checkpoint at the entrance of Aqraba until 22:00. (ii) At 21:55, Israeli forces set up a checkpoint in the area between Madma and Burin villages. • Raid: <ul style="list-style-type: none"> (i) At 19:05, Israeli forces raided Huwara (for the alleged throwing of a Molotov cocktail fire bomb towards an Israeli settler vehicle travelling along the main road), clashed with several residents as they stormed several merchant shops, and temporarily detained 3 residents: Nour Khier Khamous, Salah Khier Khamous and Mahdi Salah Khier Khamous then withdrew at 20:30. (ii) At 01:45, Israeli forces raided Kafr Qalil village. • Detention: At 19:30, Israeli forces positioned at a checkpoint near the entrance of Beit Furiq detained Sadek Sadki Khatatba and Imad Badi' Khatatba.
<p>SALFIT</p>	<ul style="list-style-type: none"> • Closure of Main Roads: <ul style="list-style-type: none"> (i) The Israeli army continues to close with dirt mounds the entrance to two detour roads connecting Marda village to its farmland. (ii) On 15.04.2012, the Israeli army has opened the northern entrance to Salfit city to civilian which was closed since the year 2000 and prevented access from 08:00 until 09:20. (iii) Since 11:00 on July 30th 2012, Israeli forces have closed two roads leading to Abu Nasar and Qatan Al-Jama' located in western area of Deir Istiya with cement blocks. (iv) At 09:20 on October 13th 2015, Israeli forces closed the West entrance of Kafr Al-Dik with cement blocks. • Checkpoint: Israeli forces intensified their restrictions at Za'tara checkpoint and impeded the free flow of traffic. • Flying Checkpoint: At 17:00, Israeli forces set up a checkpoint at the west entrance of Deir Istiya.
<p>JERICHO</p>	<ul style="list-style-type: none"> • Checkpoints: Israeli forces intensified its restrictions at Al-Hamra checkpoint set up along the road connecting Jericho and Nablus District. • Flying Checkpoint: At 23:30, Israeli forces set up a checkpoint along road (90) near Al-Nuwe'meh village located at the North entrance of Jericho until 24:00. • Raid: At 02:20, Israeli forces raided Ain Al-Sultan camp in Jericho, detained a resident then withdrew at 02:55. • Detention: Israeli forces detained Ahmad Ismail Safi in Ain Al-Sultan camp in Jericho.

BETHLEHEM

- **Closure:**
 - (i) The Israeli army continues to close roads to An Nu'man village, with the exception of the road leading to the Wall gate in the south-eastern area of the village.
 - (ii) Since 15 September 2007, the Israel army has prevented civilians from accessing or staying on 22 dunumes of confiscated land in Al Mazmuriya area in Beit Sahur and Bethlehem cities.
- **Closure of Main Roads:**
 - (i) The Israeli army continues to close the Beit Jala-Wadi Ahmed road; a road between Um Tuba and Al-Jass ; a road between Um Tuba and Khilat Nu'man: a road between Um Tuba and the wall; a road between Al-Khas village and the wall; the 2 by pass roads located south of Al-Walaja; a road between Talita Qumi and Nazlat Al-Sider in Beit Jala; the eastern road of Al-Khader; the road between Al-Khader and Beit Jala ; Wadi Rahal road near "Ifrat" settlement ,the road between Al-Khader and road #60 which lead to the eastern neighbourhoods of Bethlehem; a road leading to Wadi Rahal, and a road east of Beit Fajjar town with dirt mounds.
 - (ii) The Israeli army continues to close the road leading to "Newe Daniyyel" settlement and agricultural land in Al-Khader; a road between Um Tuba and Wadi Al-Hums: Wadi Fukin, Al-Jaba, the Green Line; a road between Za'tara and a detour road, and a road between Taqou and Khirbet Al-Deir with cement blocks.
 - (iii) Since August 2nd 2012, Israeli forces closed a road leading to Beit Jalla.
 - (iv) Since May 8th 2013, Israeli forces closed the road connecting Al-Carmisan area in Beit Jalla and Al-Walaja with a steel gate and barbed wires.
 - (v) Since June 3rd 2013, the Israeli army closed the road connecting Nihalin and road 60 with dirt mounds.
 - (vi) Since 13:20 on September 29th 2013, the Israeli army closed a road leading to 50 acres of agricultural land in Wadi Salem area in Al-Khadr with dirt mounds.
 - (vii) Israeli forces closed the main road connecting Surif and Al-Jub'a village with dirt mounds.
 - (viii) On January 28th 2014, Israeli forces closed the steel gate at the entrance of Nihalin { replacing the dirt mounds placed at the entrance since the year 2002 } and placed time schedule for opening the gate from 06:00 until 14:00 on a daily bases.
 - (ix) Since 10:45 on September 8th 2015, Israeli forces closed the agricultural road located in Arab Al-Rashaydeh village located near "Malee Amous" settlement with dirt mounds.
 - (x) Since 14:10 on October 20th 2015, Israeli forces closed the North entrance of Taqou'.
- **Checkpoint:** At 10:15 on October 22nd 2015, Israeli forces closed checkpoint (300) and impeded the free flow of traffic until October 26th 2015.
- **Flying Checkpoint:**
 - (i) At 13:35, Israeli forces set up 2 checkpoints at the east and west entrances of Husan village until 16:30.
 - (ii) At 13:50, Israeli forces set up a checkpoint near "Kafr Itsiyon" settlement located along the main road connecting Bethlehem and Hebron and confiscated a vehicle (BMW) owned by Ahmad Ishaq Abu Eisheh (A resident of Hebron).

	<ul style="list-style-type: none"> (iii) At 16:45, Israeli forces set up a checkpoint near Dar Salah village located at the east entrance of Beit Sahour until 17:30. (iv) At 22:10, Israeli forces set up a checkpoint in Aqbat Husna area located near Husan village until 23:10. (v) At 22:10, Israeli forces set up a checkpoint at the west entrance of Husan village until 23:15. • <u>Raid:</u> <ul style="list-style-type: none"> (i) At dawn on October 22nd 2015, Israeli forces raided Beit Sahur and detained a resident. (ii) At 00:45, Israeli forces raided Taqou’then stormed and searched several homes. (iii) At 03:30, Israeli forces raided Al-Obidiya until 03:40. (iv) At 04:25, Israeli forces raided Ayda camp in Bethlehem, stormed and searched a home, detained a resident then withdrew at 05:10. • <u>Attack:</u> <ul style="list-style-type: none"> (i) At 13:00, Israeli forces positioned near the North entrance of Taqou’ fired stun and tear gas grenades towards several residents for alleged stoning. (ii) At 16:05, Israeli forces positioned near Billal Bin Rabah mosque located in North Bethlehem fired rubber coated steel bullets, stun and tear gas grenades towards several residents for alleged stoning and as a result injured the child Yazan Hamza Mohammad Al-Kurd (12 years old). • <u>Detention:</u> <ul style="list-style-type: none"> (i) At 20:30, Israeli forces detained two residents: Eid Hassan Nimer Najajrah, Mohammad Waleed Ibrahim Najjajrah {Both residents of Nihalin village} as they were working in “Beter Aliyat” settlement. (ii) Israeli forces detained Husam Samih Abu Daya in Beit Sahour. (iii) Israeli forces detained Khader Akram Mohammad Abu Khdeir in Bethlehem. • <u>Injury:</u> At 23:20, Israeli forces assaulted Khalil Raed Mahmoud Fanoun (A resident of Nihalin) and as a result left him hospitalised with a fractured leg and contusions as he was working in “Modo’in” settlement. • <u>Settler Violence:</u> <ul style="list-style-type: none"> (i) At 08:00, Israeli settlers stormed Ush Al-Ghurab area located in east Beit Sahour and raised Israeli flags then withdrew later. (ii) At 23:35, a Israeli settler positioned near Al-Jisir area located between Husan and Nihalin villages opened fire towards several residents for allegedly throwing a molotov cocktail fire bomb. (iii) At 07:50, 3 Israeli settlers driving a vehicle (Volks Wagen Golf) near Um Salmouna village ran over Taye’ Khalil Jaber Taqatqa (42 years old) and as he attempted to flee an settler opened the vehicle door which hit him and as a result left him hospitalised with contusions.
	<ul style="list-style-type: none"> • <u>Closure:</u> <ul style="list-style-type: none"> (i) The Israeli army continues to close Khuzq Al-Far areas, as well as the old gold market in Hebron’s Old City. In addition to closing the entrance to Al-Qeisi neighbourhood, the Israeli army continues to close the entrances to the area of Al-Hisba (the fruits and vegetables market) with an electronic gate; Al-Laban Market also remains closed. (ii) Since 05 January 2009, the Israeli army has closed the area located along the Green Line south of the town of Yatta. Having seized land for Wall construction, the Israeli army evicted the Palestinian residents and denied them access to the area.

- **Raid:**
 - (i) At dawn on October 22nd 2015, Israeli forces raided Al-Samou' and detained a child after storming his home.

 - (iii) At 03:30, Israeli forces raided Al-Fuwar camp, clashed with several residents and stormed 2 homes and as a result injured Mohammad Al-Darbashi and detained a resident.

- **Attack:**
 - (i) At 10:15, Israeli forces positioned near Beit Einoun village fired stun and tear gas grenades towards several residents for alleged stoning.
 - (ii) At 13:15, Israeli forces positioned near Abu Al-Rish checkpoint located in the old city of Hebron and in Al-Zawiya area fired live ammunition, rubber coated steel bullets, stun and tear gas grenades towards several residents at the entrance of the camp for alleged stoning and as a result injured 6 residents: Mohammad Faraj Ahmad Taha, Alaa Nabil Zahada, Omar Taha Yassin Abu Senieneh, Ghassan Omar Abdallah Al-Sa'id, Islam Yassin Abdel-Fattah Al-Karaki and Karam Saleh Kamil Shahin.
 - (iii) At 13:30, Israeli forces positioned in the old city of Hebron opened fire towards a resident for allegedly spraying pepper spray onto the face of an Israeli soldier before he was able to flee the area.
