Killing	1	1	2	A child was killed after Israeli forces opened fire towards him near Al-Jalma checkpoint in North Jenin for allegedly attempting to stab an Israeli soldier and a resident died of serious injuries sustained during confrontations with Israeli forces in Al-Farahin area located in east El Burije refugee camp in central Gaza on October 11 th 2015.

Destruction of Property	3	-	3	Israeli settlers set fire to a vehicle in Um Tuba village, damaged an agricultural Green house and several planted crops on agricultural land near "Movo Dotan" settlement and set fire to 5 Olive trees in east Burin village in Jerusalem, Jenin and Nablus.
Assault on Property	1	-	1	Israeli forces prevented several residents from collecting Olive harvest on their agricultural land located in Ayoun Al-Haramiya area in North Silwad village in Ramallah.
Closure (per District)	8	-	8	Including 2 in Bethlehem, 1 in Jerusalem, 1 in Nablus, 1 in Tubas and 4 in Hebron.
Closure of Crossings	-	7	7	All border crossings are closed.
Closure of Main Roads	69	-	69	Including 4 in Jerusalem, 3 in Ramallah, 3 in Jenin, 3 in Qalqiliya, 5 in Nablus, 6 in Salfit, 25 in Bethlehem and 20 in Hebron.
Settler Violence	7	-	7	Israeli settlers set fire to a vehicle and spray painted anti-Arab slogans in Um Tuba village, chased several residents in an attempt to stab them in Sur Bahar village, assaulted several residents in Al-Thuri neighbourhood, stormed agricultural land and damaged several agricultural crops in Jenin., set fire to a plot of agricultural land approximately 2 dunums and burned 5 Olive trees in east Burin village, stormed agricultural land in south Qusra village in Nablus, attacked several homes and attempted to breakdown mosque door as they attacked it in the old city of Hebron.

JERUSALEM	<ul style="list-style-type: none"> • <u>Closure:</u> <ul style="list-style-type: none"> (i) On October 24th 2015, the Israeli army, continues to intensify their restrictions at the entrance to Jerusalem city, set up several flying checkpoints on the main road leading to the city and prevented worshipers from conducting prayers at Al-Aqsa mosque compound and prevented residents entering the mosque. (ii) The Israeli army continues to close the ‘demarcation area’ along the Wall in the area surrounding occupied East Jerusalem and restricts access to local residents as well as to civilians holding special permits. (iii) The Israeli army continues to impose a blockade and deny civilian access to a hill between Biddu and Beit Iksa villages. • <u>Closure of Main Roads:</u> <ul style="list-style-type: none"> (i) The Israeli army continues to close with cement blocks and dirt mounds the entrance to Jaba’ village. (ii) The Israeli army continues to close with an iron gate the eastern entrance to Beit Iksa village and forces civilians to access Jerusalem city through Qalandiya checkpoint. (iii) On October 14th 2015, Israeli forces closed the main road leading to Al-Eisawiya village with cement blocks. (iv) On October 14th 2015, Israeli forces closed the entrance of Jabal Al-Mukabir neighbourhood with cement blocks. (v) On October 14th 2015, Israeli forces closed the North entrance of Sur Bahar with Cement blocks. (vi) On October 14th 2015, Israeli forces closed the entrance of Al-Tur neighbourhood (leading to Al-Za’im village in Jericho and Al-Eizariya) and Suliman French road with cement blocks. (vii) On October 14th 2015, Israeli forces closed the entrance of Wadi Al-Rabaybeh area in Silwan neighbourhood in Jerusalem with cement blocks. • <u>Checkpoint:</u> <ul style="list-style-type: none"> (i) Israeli forces considers Qalandiya checkpoint to be a border crossing point and only allows residents with Jerusalem Identification cards to enter the checkpoint. (ii) Since September 19th 2012, Israeli forces closed Ras Khamis and Shu’fat checkpoints and impeded the free flow of traffic in order to complete the construction of the wall. • <u>Raid:</u> <ul style="list-style-type: none"> (i) At 18:35, Israeli forces raided Abu Dis. (ii) At dawn on October 25th 2015, Israeli forces raided Al-Eisawiya and detained a resident. • <u>Attack:</u> <ul style="list-style-type: none"> (i) At 20:00, Israeli forces positioned at the entrance of Al-Eisawiya village and Al-Tur neighbourhood fired stun and tear gas grenades towards residents for alleged stoning. (ii) At 20:15, Israeli forces positioned in Ras Al-Amoud neighbourhood fired stun and tear gas grenades towards several residents for alleged stoning.

	<p>(iii) At 20:40, Israeli forces positioned near Hizma village fired live ammunition, rubber coated steel bullets, stun and tear gas grenades towards several children for alleged stoning and as a result injured the child Ward Eyad Ahmad Al-Khatib (15 years old) leaving her hospitalised with contusions.</p> <ul style="list-style-type: none"> • <u>Detention:</u> <ul style="list-style-type: none"> (i) At dawn on October 24th 2015, Israeli forces detained Sufiyan Naser Mahmoud during their raid into Al-Eisawiya village. (ii) At 05:30, Israeli forces detained two residents: Mohammad Rakan and Faraj Al-Joulani in Ras Al-Amoud neighbourhood in Jerusalem. (iii) At 11:30, Israeli forces detained 4 resident: Akram Al-Ghazawi, Sameh Al-Ghazawi, Nidal Al-Bazlamit and Radwan Ahmad Abdel-Rahman in Al-Thuri neighbourhood. (iv) On October 24th 2015, Israeli forces detained Mohammad Ma'moun Al-Razim in Wadi Qaddum area in Silwan. (v) On October 24th 2015, Israeli forces detained Tawfiq Abu Adham in Jabal Al-Mukabir neighbourhood. (vi) At dawn on October 25th 2015, Israeli forces detained 3 residents: Amjad Al-Awar, Mansour Abu Gharbiya and Ahmad Abu Gharbiya in Silwan neighbourhood. (vii) Israeli force detained Yusef Obied in Al-Eisawiya village • <u>Home Demolition:</u> On October 24th 2015, Israeli forces forced Abeer Eliyas Al-Rajabi to demolish her 100m² home in Beit Hanina and imposed a financial penalty for allegedly being built without a licence. • <u>Settler Violence:</u> <ul style="list-style-type: none"> (i) At dawn on October 24th 2015, Israeli settlers stormed Um Tuba village and set fire to a vehicle and spray painted anti-Arab slogans on it. (ii) At 19:30, Israeli settlers stormed Sur Bahar and chased several residents as they attempted to assault and stab them with knives then withdrew under the protection of Israeli forces. (iii) At 20:00, Israeli settlers stormed Al-Thuri neighbourhood and assaulted several residents. • <u>Wall Gates:</u> <ul style="list-style-type: none"> (i) The Israeli army continues to close with cement blocks the Wall gate in Abu Dis town. (ii) The Israeli army continues to deny civilian access through the Wall gate on Al-Shayyah road in the area between Al-Sawahira Al-Sharqiya and Al-Slewahira Al-Gharbiya villages, only allowing civilians holding Jerusalem IDs to cross, after subjecting them to thorough searches using electronic devices.
<p>RAMALLAH & AL BIREH</p>	<ul style="list-style-type: none"> • <u>Closure of Main Roads:</u> <ul style="list-style-type: none"> (i) The Israeli army continues to close the entrances to Sinjil village well as the junction to Kafr Malik and 'Ein Samiya villages. (ii) On October 3rd 2015, Israeli forces closed the main road located near "Bet El" settlement and leading to Al-Jalazoun camp with cement blocks. (iii) At 23:30 on October 20th 2015, Israeli forces closed the entrance to Ni'lin with cement blocks. • <u>Checkpoint:</u> Since October 24th 2015, Israeli forces closed Al-Mahkama checkpoint located near "Bet El" settlement located in North Al-Bireh city and impeded the free flow of traffic (for the firebombing of an Israeli settler vehicle as alleged by the Israeli Military). • <u>Flying Checkpoint:</u> <ul style="list-style-type: none"> (i) At 09:25, Israeli forces set up a checkpoint in Eyoun Al-Haramiya junction located along the road connecting Ramallah and Nablus, detained a resident then withdrew at 15:45.

	<ul style="list-style-type: none"> (ii) At 24:00, Israeli forces set up a checkpoint near Atarah bridge located in North Bir Ziet until 05:30. • Raid: At 24:00, Israeli forces raided Ein Yabroud and Wadi Al-Qari' villages until 01:00. • Attack: <ul style="list-style-type: none"> (i) At 11:50, Israeli forces positioned at Al-Makhakma checkpoint located near "Bet El" settlement in North Al-Bireh city fired live ammunition, rubber coated steel bullets, stun and tear gas grenades towards several residents for alleged stoning as they were protesting against the continued Israeli military and settler assault on Al-Aqsa mosque compound in the old city of Jerusalem and as a result injured 2 residents including a child: Ahmad Abdel-Rahman Hamad (15 years old) and Mohammad Musa Nu'man Assi. (ii) At 17:30, Israeli forces positioned near the wall gate in Budrus village fired stun and tear gas grenades towards several residents for alleged stoning. • Detention: Israeli forces positioned at a checkpoint in Eyoun Al-Haramiya junction located along the road connecting Ramallah and Nablus detained Haytham Amin Salah Dar Salah (A resident of Silwad). • Assault on Property: At 09:30, Israeli forces positioned near Eyoun Al-Haramiya junction located in North Silwad prevented several residents from entering their agricultural land to collect Olive harvest.
<p>JENIN</p>	<ul style="list-style-type: none"> • Closure of Main Road: <ul style="list-style-type: none"> (i) The Israeli army continues to close with dirt mounds the road leading to the town of 'Arraba east of the illegal settlement Dotan. (ii) Since the evening of November 25th 2012, Israeli forces closed the western entrance of Ya'bad. • Checkpoint: At 11:45, Israeli forces closed "Movo Dotan" checkpoint located in south Ya'bad along the main road connecting Jenin and Tulkarem and impeded the free flow of traffic then reopened it later. • Raid: <ul style="list-style-type: none"> (i) At 20:20, Israeli forces raided Zabuba village, clashed with several residents and as a result injured the child Talib Mohammad Talib (15 years old) and left several others suffocated from tear gas inhalation, detained a resident then withdrew at 21:20. (ii) At 22:20, Israeli forces raided Qabatiya. • Killing: At 10:10, the child Ahmad Mohammad Sa'id Kamil (16 years old) {A resident of Qabatiya in Jenin} was killed after Israeli forces positioned in the vicinity of Al-Jalma checkpoint located in North Jenin opened fire towards him for allegedly attempting to stab an Israeli soldier {As alleged by the Israeli Military} during which Israeli forces opened fire towards an Ambulance thus preventing medical units from reaching the corpse. • Detention: Israeli forces detained Ibrahim Mohammad Jaradat in Zubaba village. • Settler Violence: On October 24th, Israeli settlers from "Movo Dotan" settlement stormed agricultural land located near the settlement and destroyed a Green house and damaged several planted crops owned by Kayed Abu Bakr. • Wall Gates: Israeli forces continue to close the wall gate and only allow those holding special permits to enter through it.

<p>TULKAREM</p>	<ul style="list-style-type: none"> • Checkpoint: At 07:30 on October 24th 2015, Israeli forces continue to intensify their restrictions at "Eniv" checkpoint located along the main road connecting Tulkarem and Nablus and impeded the free flow of traffic until 17:20. • Flying Checkpoint: At 07:10 on October 24th 2015, Israeli forces set up a checkpoint at Beit Lid junction until 11:00.

	<ul style="list-style-type: none"> • <u>Raid:</u> At 21:40, Israeli forces raided Zieta, clashed with several residents then withdrew at 22:40. • <u>Detention:</u> At 18:00, Israeli forces positioned at “Eniv” checkpoint located along the main road connecting Tulkarem and Nablus detained Yasser Ibrahim Badrasawi (A resident of Balata camp in Nablus).

(ii) In addition to closing the gate installed since the outbreak the second Intifada, the Israeli army continues to close with dirt mounds the eastern entrance to Kafr Qaddum village. (iii) Since 10:40 on September 1st 2015, Israeli forces closed an agricultural road leading to Far’ata village, which is located near “Gillad” settlement with a steel Gate. • <u>Temporary Detention:</u> At 20:30, Israeli forces positioned near “Qadumim” settlement temporarily detained Shireen Fathi Yusef Ghanam (A resident of Sarah village in Nablus) for allegedly attempting to stab an Israeli soldier then released her at 23:00. • <u>Attack:</u> At 16:00, Israeli forces positioned at the wall gate in Al-Naqqar neighbourhood in Qalqiliya fired stun and tear gas grenades towards several residents for alleged stoning. • <u>Demonstration:</u> At 16:00, a demonstration took place in Kafr Qaddum village protesting against the Israeli militaries closure of the village east entrance during which Israeli forces fired rubber coated steel bullets, stun and tear gas grenades towards several residents to prevent them from reaching the demonstration site. • <u>Wall Gates:</u> <ul style="list-style-type: none"> (i) The Israeli army continues to restrict access at ‘Azzun ‘Atma Wall gate and impeded the free flow of traffic. The Israeli army continues to close with an iron gate the entrance to the village of Wadi Al- Rasha and to deny civilian access. (ii) The Israeli army allows residents to access the village through Gate #109. Having removed the gate at the entrance to the village of Ras Atiya; the Israeli army only allows students to cross to their schools outside the village through the Habla gate.
<p style="text-align: center;">NABLUS</p>	<ul style="list-style-type: none"> • <u>Closure:</u> Since December 17th 2013, Israeli forces ordered the closure 500 dunumes of land in Qusra village as a closed military area. • <u>Closure of Main Roads:</u> <ul style="list-style-type: none"> (i) The Israeli army continues to close the roads of Til-Burin and Beit Furik-Salem; the settler bypass road connecting the village of Deir al Hatab to the settlement of Alon Moreh; the road connecting the town of ‘Aqraba to the village of Osrin; and the detour road between the town of Qabalan and the village of Osrin. (ii) The Israeli army continues to close the northern entrance to Qabalan town; the southern entrances to the town of Jamma’in and the villages of Duma and Qaryut. (iii) At 22:00, Israeli forces closed the North entrance of Awarta with dirt mounds. (ii) Since 11:00 on July 30th 2012, Israeli forces have closed two roads leading to Abu Nasar and Qatan Al-Jama' located in western area of Deir Istiya with cement blocks. (iii) At 09:20 on October 13th 2015, Israeli forces closed the west entrance of Kafr Al-Dik with cement blocks. • <u>Checkpoint:</u> At 09:40, Israeli forces intensified their restrictions at Za'tara checkpoint and impeded the free flow of traffic. • <u>Raid:</u> <ul style="list-style-type: none"> (i) At 20:10, Israeli forces raided Bruqin village until 24:00. BETHLEHEM	<ul style="list-style-type: none"> • <u>Closure:</u> <ul style="list-style-type: none"> (i) The Israeli army continues to close roads to An Nu'man village, with the exception of the road leading to the Wall gate in the south-eastern area of the village. (ii) Since 15 September 2007, the Israel army has prevented civilians from accessing or staying on 22 dunums of confiscated land in Al Mazmuriya area in Beit Sahur and Bethlehem cities. • <u>Closure of Main Roads:</u> <ul style="list-style-type: none"> (i) The Israeli army continues to close the Beit Jala-Wadi Ahmed road; a road between Um Tuba and Al-Jass ; a road between Um Tuba and Khilat Nu'man: a road between Um Tuba and the wall; a road between Al-Khas village and the wall; the 2 by pass roads located south of Al-Walaja; a road between Talita Qumi and Nazlat Al-Sider in Beit Jala; the eastern road of Al-Khader; the road between Al-Khader and Beit Jala ; Wadi Rahal road near "Ifrat" settlement ,the road between Al-Khader and road #60 which lead to the eastern neighbourhoods of Bethlehem; a road leading to Wadi Rahal, and a road east of Beit Fajjar town with dirt mounds. (ii) At 01:00, Israeli forces raided Bethlehem, clashed with several residents as they stormed a steel mill owned by Al-Sayih family and summoned Issam Atta Al-Sha’er to report to Israeli Intelligence for questioning then withdrew at 05:00. • <u>Attack:</u> At 16:00, Israeli forces positioned near Billal Bin Rabah mosque located in North Bethlehem fired live ammunition; rubber coated steel bullets, stun and tear gas grenades towards several residents for alleged stoning and as a result injured Islam Mahmoud Ahmad Qanis as well as leaving several others suffocated from tear gas inhalation. • <u>Detention:</u> Israeli forces detained three residents: Zidan Ahmad Abed Radaydeh (16 years old), Ahmad Mohammad Radaydeh and Hisham Nabil Ahmad Radaydeh in Al-Obidiya.

HEBRON	<ul style="list-style-type: none"> • <u>Closure:</u> <ul style="list-style-type: none"> (i) The Israeli army continues to close Khuzq Al-Far areas, as well as the old gold market in Hebron's Old City. In addition to closing the entrance to Al-Qeisi neighbourhood, the Israeli army continues to close the entrances to the area of Al-Hisba (the fruits and vegetables market) with an electronic gate; Al-Laban Market also remains closed. (ii) Since 05 January 2009, the Israeli army has closed the area located along the Green Line south of the town of Yatta. Having seized land for Wall construction, the Israeli army evicted the Palestinian residents and denied them access to the area. • <u>Closure of Main Roads:</u> <ul style="list-style-type: none"> (i) The Israeli army continues to close the entrances to Al-Karmil villages. (ii) The Israeli army continues to prohibit Palestinian vehicles from travelling along the old Al-Shalala Street leading to Hebron's Old City. (iii) The Israeli army continues to close all roads leading to Road # 60 as well as detour roads along the settler bypass road leading to Yatta town. (iv) The Israeli army continues to close with dirt mounds a detour road leading to e to Al-Simiya village, the southern entrance of Al-Samou' and the entrance of Beit Annun with cement blocks. (v) Since July 25th 2012, Israeli forces closed the road connecting Al-Safa and Al-Dirat and also closed the entrance of south Yatta with cement blocks. (vi) At 11:00 on August 6th 2015, Israeli forces closed the entrance of Al-Hajara village located in south Dura with cement blocks. • <u>Flying Checkpoint:</u> <ul style="list-style-type: none"> (i) At 10:40, Israeli forces set up a checkpoint at Al-Fuwar camp junction and detained a resident. (ii) At 19:20, Israeli forces set up a checkpoint at the entrance of Sa'ir.
