• Closure:

- (i) The Israeli army, intensified their restrictions at the entrance to Jerusalem city, set up several flying checkpoints on the main road leading to the city and prevented worshipers under the age of 50 from conducting prayers at Al-Aqsa mosque compound.
- (ii) The Israeli army continues to close the 'demarcation area' along the Wall in the area surrounding occupied East Jerusalem and restricts access to local residents as well as to civilians holding special permits.
- (iii) The Israeli army continues to impose a blockade and deny civilian access to a hill between Biddu and Beit Iksa villages.

• Closure of Main Roads:

- (i) The Israeli army continues to close with cement blocks and dirt mounds the entrance to Jaba' village.
- (ii) The Israeli army continues to close with an iron gate the eastern entrance to Beit Iksa village and forces civilians to access Jerusalem city through Qalandiya checkpoint.

• Checkpoints:

- (i) Israeli authorities continue to consider Qalandiya checkpoint a "border crossing point" and designate a special crossing lane for holders of Jerusalem IDs and another for those possessing permits to access Jerusalem city and closed the checkpoint at 01:20 and impeded the free flow of traffic until 04:05.
- (ii) On September 19th 2012, Israeli forces closed Ras Khamis checkpoint near Shu'fat camp and impeded the free flow of traffic in order to construct the wall.
- **<u>Killing:</u>** On September 7th 2014, the child Mohammad Sinukrut (15 years old) {A resident of Jerusalem} died of a serious head injury sustained during confrontations between Israeli forces and residents in Wadi Al-Juz neighbourhood in Jerusalem as mentioned in the report of September 1st 2014.
- **Detention:** At dawn on September 7th 2014, Israeli forces detained five residents including a child: Ibrahim Abu Jum'a (17 years old), Ahmad Abu Sabatin, Basel Al-Sayad, Mohammad Abu Sbatin and Walid Al-Bajhari.

• Attack:

- (i) At 15:00, Israeli forces positioned in Wadi Al-Juz neighbourhood in Jerusalem fired rubber coated steel bullets, stun and tear gas grenades towards several residents for alleged stoning and as a result injured 15 residents including Musa Adeli (A Paramedic) and left several others suffocated from tear gas inhalation.
- (ii) At 20:15, Israeli forces positioned at the entrance of Al-Eisawiya village, Al-Tur and Wadi Al-Juz neighbourhoods and Ein Al-Lawza area in Silwan in Jerusalem fired rubber coated steel bullets, stun and tear gas grenades towards several residents for alleged stoning.
- (iii) At 23:15, Israeli forces positioned at the entrance of Silwan neighbourhood in Jerusalem fired rubber coated steel bullets, stun and tear gas grenades towards several residents for alleged stoning and closed the entrance with cement blocks.

- <u>Checkpoint:</u> At 14:55, Israeli forces intensified their restrictions at the Container checkpoint until 17:30.
- <u>Flying Checkpoint:</u> At 12:45, Israeli forces set up a checkpoint at the East entrance of Beit Fajjar until 14:15.

Raid:

- (i) At 15:00, Israeli forces raided Beit Sahur, stormed a home then withdrew at 15:45.
- (ii) At 16:05, Israeli forces raided Beit Jallah, temporarily detained 3 children: Mustafa Hanhin (15 years old), Musa Osama Faraj (15 years old) and Munir Khaled Al-Ja'bari then released them later.
- (iii)At 17:35, Israeli forces raided Al-Obidiya until 17:50.
- (iv)At 03:10, Israeli forces raided Al-Ayda camp in Bethlehem, stormed several homes, detained two residents then withdrew at 04:50.
- (v) At 03:50, Israeli forces raided Bethlehem, stormed and searched two homes and detained a resident.

• <u>Detention</u>:

- (i) At 16:30, Israeli forces positioned at the container checkpoint detained Mohammad Khaled Al-Jindi (A resident of Al-Urub camp in Hebron).
- (ii) At 18:30, Israeli forces positioned at the container checkpoint detained Thaer Abdallah Taha (A resident's of Ramallah).
- (iii)Israeli forces detained two residents: Odau Abu Odeh and Yacoub Hamad Yacoub in Al-Ayda camp.
- (iv)Israeli forces detained Mohammad Salameh in Bethlehem.

• Closure:

- (i) The Israeli army continues to close Al-Shuhada' Street, Al-Sahleh and Khuzq Al-Far areas, as well as the old gold market in Hebron's Old City. In addition to closing the entrance to Al-Qeisi neighbourhood, the Israeli army continues to close the entrances to the area of Al-Hisba (the fruits and vegetables market) with an electronic gate; Al-Laban Market also remains closed.
- (ii) Since 05 January 2009, the Israeli army has closed the area located along the Green Line south of the town of Yatta. Having seized land for Wall construction, the Israeli army evicted the Palestinian residents and denied them access to the area.

• Closure of Main Roads:

- (i) The Israeli army continues to close the entrances to Al-Thahiriya and Al-Samoa' towns, Al-'Arrub refugee camp, and Al-Tuwani and Al-Karmil villages.
- (ii) The Israeli army continues to prohibit Palestinian vehicles from travelling along the old Al-Shalala Street leading to Hebron's Old City.
- (iii) The Israeli army continues to close all roads leading to Road # 60 as well as detour roads along the settler bypass road leading to Yatta town.
- (iv) The Israeli army continues to close with dirt mounds a detour road leading to e to Al-Simiya village, the southern entrance of Al-Samou' and the entrance of Beit Annun with cement blocks.
- (v) Since July 25th 2012, Israeli forces closed the road connecting Al-Safa and Al-Dirat and closed the entrance of south Yatta with cement blocks.
- (vi) On September 4th 2014, Israeli forces closed a road in Eiwn Al-Bas and Al-Bayda and Al-Ras area in Ithna locat6ed near the wall gate.
- <u>Settler Violence</u>: On September 7th 2014, Israeli settlers chopped the limbs of 25 fruit bearing trees owned by Hamad Salaibi in Wadi Al-Rish area located in Beit Ummar in Hebron.

- At 19:00 on August 26th 2014, Palestinian Gunmen and the Israeli military agreed to a cease fire agreement (brokered by the Arab Republic of Egypt) which includes the opening of border crossings to allow the entry of emergency supplies and humanitarian goods as well as construction material and agreed to increase the fishing limit to 6 nautical miles with possibility of increase to 12 nautical miles by the end of the year and to decrease the Military area to 100 meters, allow freedom of movement and a halt to targeted killings and assassinations and negotiations will be held for discussion on rebuilding the sea port and airports in the coming month.
- Israeli Naval vessels broke the cease-fire agreement by opening fire towards Palestinian fishing boats off the shores of North Gaza.

NORTHERN GAZA

- <u>Closure of Crossing Point:</u> Beit Hanun (Erez) is partially open for the passage of critical patients.
- Attack: On the morning of September 8th 2014, Israeli Naval vessels opened fire towards Palestinian fishing boats off the shores of Al-Sudaniya beach in West Beit Lahiya for allegedly crossing beyond the agreed upon fishing limit of 6 nautical miles.

(ii) Al-Shija'iya (Nahal 'Oz) Crossing is closed. Beginning on 04 January 2010, the Crossing has closed following a unilateral Israeli decision.
RAFAH	 Closure of Crossing Points: Yasser 'Arafat International Airport remains closed. Rafah (Al 'Awdah) Crossing is open for the entry and exit of residents, students, tourists and businessmen Sufa Crossing is closed. Karm Abu Salem (Karem Shalom) Crossing is open for the entry of tourist and foreign diplomats and the entry of Humanitarian assistance and construction material funded by UNRWA.
