• Closure:

- (i) On September 11th 2015,the Israeli army, intensified their restrictions at the entrance to Jerusalem city, set up several flying checkpoints on the main road leading to the city and prevented worshipers from conducting prayers in Al-Aqsa mosque compound except for Women over the age of 55, Permit holders and men ages 50.
- (ii) The Israeli army continues to close the 'demarcation area' along the Wall in the area surrounding occupied East Jerusalem and restricts access to local residents as well as to civilians holding special permits.
- (iii) The Israeli army continues to impose a blockade and deny civilian access to a hill between Biddu and Beit Iksa villages.

• Closure of Main Roads:

- (i) The Israeli army continues to close with cement blocks and dirt mounds the entrance to Jaba' village.
- (ii) The Israeli army continues to close with an iron gate the eastern entrance to Beit Iksa village and forces civilians to access Jerusalem city through Qalandiya checkpoint.

• Checkpoints:

- (i) Israeli authorities continue to consider Qalandiya checkpoint a "border crossing point" and designate a special crossing lane for holders of Jerusalem IDs and another for those possessing permits to access Jerusalem city.
- (ii) On September 19th 2012, Israeli forces closed Ras Khamis checkpoint near Shu'fat camp and impeded the free flow of traffic in order to construct the wall.

• Flying Checkpoint:

- (i) At 18:30, Israeli forces set up a checkpoint at the entrance of Bir Nabala.
- (ii) At 01:30, Israeli forces set up a checkpoint at the entrance of Anabta.
- Raid: At 01:30, Israeli forces raided Qalandiya camp, clashed with several residents as thy stormed a home and summoned Wa'ed Fayez to report to Israeli Intelligence for questioning then withdrew at 02:50.

- (i) At 13:30 and again at 21:00, Israeli forces positioned in Ras Al-Amoud neighbourhood fired stun and tear gas grenades towards several residents for alleged stoning and as a result left them suffocated from tear gas infibulation.
- (ii) At 19:50, Israeli forces positioned in Abu Dis village junction fired rubber coated steel bullets, stun and tear gas grenades towards several residents for alleged stoning.
- (iii) At 20:00, Israeli forces positioned near the north junction of Al-Ram fired stun and tear gas grenades towards several residents for alleged stoning.
- (iv) At 20:30, Israeli forces positioned in Al-Tur neighbourhood fired stun and tear gas grenades towards several residents for alleged stoning.
- (v) At 20:30, Israeli forces positioned in Silwan neighbourhood fired rubber coated steel bullets, stun and tear gas grenades towards several residents for alleged stoning and as a result left 3 residents including a child and 2 Elderly residents: Tulin Jamjoum (7 years old), Abdallah Abu Nab (60 years old) and Adel Tawfiq (68 years old) leaving them hospitalised from tear gas inhalation.

- <u>Attack:</u> At 18:50, Israeli forces positioned at the west entrance of Taqou' fired stun and tear gas grenades towards several residents for alleged stoning.

• Closure:

In addition to closing the entrance to Al-Qeisi neighbourhood, the Israeli army continues to close the entrances to the area of Al-Hisba (the fruits and vegetables market) with an electronic gate; Al-Laban Market also remains closed.
- (ii) Since 05 January 2009, the Israeli army has closed the area located along the Green Line south of the town of Yatta. Having seized land for Wall construction, the Israeli army evicted the Palestinian residents and denied them access to the area.

At 19:00 on August 26th 2014, Palestinian Gunmen and the Israeli military agreed to a cease fire agreement (brokered by the Arab Republic of Egypt) which includes the opening of border crossings to allow the entry of emergency supplies and humanitarian goods as well as construction material and agreed to increase the fishing limit to 6 nautical miles with possibility of increase to 12 nautical miles by the end of the year and to decrease the Military area to 100 meters, allow freedom **ALL DISTRICTS** of movement and a halt to targeted killings and assassinations and negotiations will be held for discussion on rebuilding the sea port and airports in the coming month. Israeli forces broke the ceasefire agreement by opening fire from their positions behind the Green Line towards Gaza. Israeli Naval vessels broke the cease-fire agreement by opening fire towards Palestinian fishing boats off the shores of North Gaza. Closure of Crossing Point: Beit Hanun (Erez) is open for the passage of critical patients, journalists, NGO staff, businesspersons and passengers travelling abroad **NORTHERN** through Al-Karama crossing with previous coordination. **GAZA** Attack: At 18:00, Israeli Naval vessels opened fire towards Palestinian fishing boats off the shores of Al-Sudaniya area located in east Beit Lahiya. **Closure of Crossing Points:** (i) Al-Muntar (Karni) Crossing is closed. Beginning on 02 March 2011, the Crossing has been effectively closed following a unilateral Israeli decision. **GAZA** (ii) Al-Shija'iya (Nahal 'Oz) Crossing is closed. Beginning on 04 January 2010, the Crossing has closed following a unilateral Israeli decisions.
