WEST BANK

• Closure:

- (i) The Israeli army continues to intensify its restrictions at checkpoints located at the entrances to the city of Jerusalem and to set up flying checkpoints in the old city of Jerusalem and around the Al Aqsa Mosque compound.
- (i) On 05 January 2009, the Israeli authorities issued Military Order # S/02/09 on the closure of and denial of civilian access to the "demarcation area" along the Wall in the area surrounding the city of Jerusalem. Accordingly, local residents and civilians holding permits can access this area through crossings and gates set up at the entrances to the city of Jerusalem. (The demarcation area is defined by a set of military orders relating to land confiscation for Wall construction).
- (ii) The Israeli army continues to impose a blockade and deny civilian access to a hill between the village of Biddu and Beit Iksa due to its geographical significance as it overlooks the city of Jerusalem.

• Closure of Main Roads:

- (i) The Israeli army continues to close with cement blocks and dirt barricades the entrance to the village of Jaba'.
- (ii) The Israeli army continues to close the iron gate along the Wall section, separating the area of Dahiyat al Bareed from the town of Ar Ram.
- (iii) The Israeli army continues to close with an iron gate the eastern entrance to the village of Beit Iksa and force civilians to access Jerusalem city through Qalandiya checkpoint.
- <u>Checkpoint</u>: The Israeli army continues to consider Qalandiya checkpoint a "border crossing point" and has designated a special crossing lane for holders of Jerusalem IDs and those possessing permits to access the city of Jerusalem.

- Attack on Religious Site: At 09:00, five groups of Israeli settlers gained access under protection of Israeli troops to and walked around the grounds of the Al Aqsa Mosque compounds in the old city of Jerusalem.

• Wall Gates:

- (i) The Israeli army continues to close the Wall gate in the town of Abu Dis with cement blocks.
- (ii) The Israeli army continues to deny civilian access through the Wall gate on Ash Shayyah road in the area between the villages of As Sawahira ash Sharqiya and As Sawahira al Gharbiya, only allowing civilians holding Jerusalem IDs to cross, after subjecting them to thorough searches using electronic devices.

GAZA STRIP

At 02:00 on 18 January 2009, the unilateral ceasefire declared by the Israeli authorities came into effect. At a later time on the same day, armed Palestinian groups announced an agreement to cease fire for a week. Later, armed Palestinian groups extended the ceasefire until 05 February 2009. Despite the fact that the extension period expired, the ceasefire continues to hold pending negotiations carried out by Egypt. ALL **Violations** of the Ceasefire: **DISTRICTS** The Israeli army raided Palestinian territory and opened fire on civilian (i) houses and property in Central Gaza and Khan Yunis districts. Israeli troops opened fire from their location on the Green Line on Khan Yunis and Rafah districts. Armed Palestinian groups detonated an explosive device near an Israeli (ii) army patrol near the Green Line in Khan Yunis district.

(iii) Sufa Crossing is closed. **RAFAH** Karm Abu Salem (Karem Shalom) Crossing is partially open for (iv) transportation of food supplies, humanitarian aid, vehicle spare parts, diesel designated for the Gaza Electricity Generation Station, and cooking gas. Attack: In the morning of 13 September 2010, the Israeli army opened intensive fire from its location on the Green Line towards agricultural land and civilian houses on the outskirts of Ash Shoka town east of Rafah city. Air Patrol: On 13 September 2010, Israeli combat helicopters and reconnaissance aircraft patrolled the skies over Rafah district.
