<b>JERUSALEM</b>	<ul style="list-style-type: none"> <li>• <b>Closure:</b> <ul style="list-style-type: none"> <li>(i) The Israeli army continues to intensify its restrictions at checkpoints located at the entrances to the city of Jerusalem and to set up flying checkpoints in the old city of Jerusalem and around the Al Aqsa Mosque compound.</li> <li>(i) On 05 January 2009, the Israeli authorities issued Military Order # S/02/09 on the closure of and denial of civilian access to the "demarcation area" along the Wall in the area surrounding the city of Jerusalem.</li> <li>(ii) The Israeli army continues to impose a blockade and deny civilian access to a hill between Biddu and Beit Iksa villages.</li> </ul> </li> <li>• <b>Closure of Main Roads:</b> <ul style="list-style-type: none"> <li>(i) The Israeli army continues to close with cement blocks and dirt barricades the entrance to the village of Jaba'.</li> <li>(ii) The Israeli army continues to close the iron gate along the Wall section, separating the area of Dahiyat al Bareed from the town of Ar Ram.</li> <li>(iii) The Israeli army continues to close with an iron gate the eastern entrance to Beit Iksa village and force civilians to access Jerusalem city through Qalandiya checkpoint.</li> </ul> </li> <li>• <b>Checkpoint:</b> The Israeli army continues to consider Qalandiya checkpoint a "border crossing point" and has designated a special crossing lane for holders of Jerusalem IDs and those possessing permits to access the city of Jerusalem.</li> <li>• <b>Attack:</b> In the evening of 20 September 2010, the Israeli army fired rubber-coated steel bullets and tear gas grenades on civilians, who attempted to confront Israeli settler attacks in Silwan neighbourhood in Jerusalem city.</li> <li>• <b>Settlement Activity:</b> The Israeli army has continued to level land and expand Road # 1 in the area between Az Za'ayem checkpoint and junction to the French Hill in Jerusalem city.</li> <li>• <b>Wall Gates:</b> <ul style="list-style-type: none"> <li>(i) The Israeli army continues to close the Wall gate in the town of Abu Dis with cement blocks.</li> <li>(ii) The Israeli army continues to deny civilian access through the Wall gate on Ash Shayyah road in the area between the villages of As Sawahira ash Sharqiya and As Sawahira al Gharbiya, only allowing civilians holding Jerusalem IDs to cross, after subjecting them to thorough searches using electronic devices.</li> </ul> </li> <li>• <b>Wall Construction:</b> Wall construction continues in Al 'Eizariya area to Ash Shayyah, from Beit Surik village to Biddu; in the areas of Al Judeira, Bir Nabala, and Beit Hanina; west of the village of Al Jib; in the vicinity of the village of Qatanna; south of the village of Beit Hanina; and in the area surrounding the checkpoint set up at the entrance to Shu'fat refugee camp.</li> </ul>

<p style="text-align: center;"><b>RAMALLAH &amp; EL BIREH</b></p>	<ul style="list-style-type: none"> <li>• <b><u>Closure of Main Roads:</u></b></li> <li>(i) The Israeli army continues to close with dirt barricades and cement blocks the entrances to the town of Sinjil, the village of Saffa; and the junction to the villages of Kafr Malik – ‘Ein Samiya.</li> <li>(ii) The Israeli authorities continue to declare the area located between civilian houses and the Wall in Ni’lin town and Bil’in village a closed military zone between 08:00 and 20:00 on Fridays. Civilian access to the area is denied to prevent weekly demonstrations against Wall construction.</li> <li>• <b><u>Flying Checkpoint:</u></b> At 17:35, the Israeli army set up a flying checkpoint on the settler bypass road near Al Mughayyir village and searched civilians and vehicles.</li> <li>• <b><u>Raids:</u></b></li> <li>(i) At 14:25, the Israeli army raided Bil’in village. Confrontations took place between the Israeli army and civilians.</li> <li>(ii) At 20:00, the Israeli army raided and patrolled El Bireh city.</li> <li>(iii) At 02:45, the Israeli army raided and patrolled Rafah village.</li> <li>• <b><u>Wall Construction:</u></b> Wall construction continues west of the town of ‘Abud; in the village of Bil’in; and in the areas of Al Midya to Ni’lin and Ni’lin to Deir Qaddis.</li> </ul>
<p style="text-align: center;"><b>JENIN</b></p>	<ul style="list-style-type: none"> <li>• <b><u>Closure of Main Road:</u></b> The Israeli army continues to close with dirt barricades the road leading to the town of ‘Arraba east of Dotan settlement.</li> <li>• <b><u>Raids:</u></b></li> <li>(i) At 03:00 on 20 September 2010, the Israeli army raided Silat adh Dhahr town, searched two houses, and arrested two civilians.</li> <li>(ii) At 11:15, the Israeli army raided and patrolled Ya’bad town.</li> <li>• <b><u>Arrests:</u></b> The Israeli army arrested two civilians in Silat adh Dhahr town: <ul style="list-style-type: none"> <li>(i) ‘Adnan Mohammed Yaloul; and</li> <li>(ii) ‘Allam Ma’zouz Zeid al Kilani.</li> </ul> </li> <li>• <b><u>Wall Gates:</u></b> Passage through the Wall gates is restricted to civilians granted special Israeli permits, which affects the educational and health conditions of civilians living behind the Wall.</li> </ul>
<p style="text-align: center;"><b>TUBAS</b></p>	<ul style="list-style-type: none"> <li>• <b><u>Checkpoint:</u></b> Though allowing civilian access to the Northern Jordan Valley between 06:00 and 22:00, the Israeli army continues to intensify its restrictions at Tayasir checkpoint east of the city of Tubas.</li> <li>• <b><u>Raid:</u></b> At 21:40, the Israeli army raided Bardala village and patrolled the area until 23:00.</li> </ul>
<p style="text-align: center;"><b>TULKAREM</b></p>	<ul style="list-style-type: none"> <li>• <b><u>Closure of Main Roads:</u></b> The Israeli army continues to close with dirt barricades the road connecting the town of Kafr al Labad to the village of Shufa as well as the road connecting the villages of Shufa and ‘Izbat Shufa.</li> <li>• <b><u>Checkpoint:</u></b> The Israeli army continues to intensify restrictions at ‘Einav checkpoint set up on Tulkarem-Nablus main road.</li> </ul>

	<ul style="list-style-type: none"> <li>• <b>Raid:</b> At 20:30, the Israeli army raided and patrolled Zeita town.</li> <li>• <b>Wall Gates:</b> Passage through the wall gates is restricted to civilians granted special Israeli permits.</li> </ul>
<b>QALQILYA</b>	<ul style="list-style-type: none"> <li>• <b>Closure of Roads:</b> The Israeli army continues to close with cement blocks agricultural roads east of the town of ‘Azzun.</li> <li>• <b>Flying Checkpoints/Detention:</b> <ul style="list-style-type: none"> <li>(i) At 09:00, and again at 21:50, the Israeli army set up a flying checkpoint on the junction to Jinsafut village and searched civilians and vehicles.</li> <li>(ii) At 12:50, the Israeli army set up a flying checkpoint at the eastern entrance to Qalqiliya city, searched civilians and vehicles, detained Omar Abdullah Mar’i, a Palestinian Police officer, and released him after coordination with the Israeli authorities (through the DCO). At 22:35, the Israeli army set up another checkpoint and opened fire on a civilian vehicle, claiming that it had not stopped at the checkpoint.</li> <li>(iii) At 18:20, the Israeli army set up a flying checkpoint at the entrance to Immatin village and searched civilians and vehicles.</li> <li>(iv) At 23:40, the Israeli army set up a flying checkpoint at the entrance to Habla tunnel (the southern entrance to Qalqiliya city) and searched civilians and vehicles.</li> </ul> </li> <li>• <b>Raids/Attack on Property:</b> <ul style="list-style-type: none"> <li>(i) At 10:50, the Israeli army raided Kafr Thulth town and distributed notices for the cessation of building 11 houses under construction, claiming that they were being built without the required construction licences and located in Area C, which is under full Israeli control. Affected houses belong to: <ul style="list-style-type: none"> <li>(i) Hasan Mohammed Ghanem;</li> <li>(ii) Ayman Sa’id Gharabeh;</li> <li>(iii) Raed Farid Miqbel;</li> <li>(iv) Ali Theeb Gharabeh;</li> <li>(v) Subhi Theeb Gharabeh;</li> <li>(vi) Thaer Kamal as Seifi;</li> <li>(vii) Abdul Qader Ghannam;</li> <li>(viii) Wasef Mohammed Theeb Gharabeh;</li> <li>(ix) Ahmed Mohammed Shawahneh;</li> <li>(x) Zaki Abdullah Thaher; and</li> <li>(xi) Muhannad Sa’id Gharabeh.</li> </ul> </li> <li>(ii) At 19:05, the Israeli army raided Jit village and patrolled the area until 19:30.</li> </ul> </li> <li>• <b>Arrest:</b> At 10:30, Israeli troops arrested Miqdad Mohammed Ibrahim ‘Azem, a resident of Qalqiliya city, allegedly because he had attempted to gain access into Israel without the required permit.</li> <li>• <b>Wall Gates:</b> <ul style="list-style-type: none"> <li>(i) The Israeli army continues to intensify its restrictions at ‘Azzun ‘Atma Wall gate and to search civilians, including students, with a metal detector.</li> </ul> </li> </ul>

	<p>(ii) The Israeli army continues close with an iron gate the entrance to the village of Wadi ar Rasha and to deny civilian access. The Israeli army allows residents to access the village through Gate #109. Having removed the iron gate at the entrance to the village of Ras 'Atiya, the Israeli army only allows students to cross to their schools outside the village through the Habla gate.</p>
<p>NABLUS</p>	<ul style="list-style-type: none"> <li>• <b>Closure of Main Roads:</b> <ul style="list-style-type: none"> <li>(i) The Israeli army continues to close the roads of Till-Burin and Beit Furik-Salem; the settler bypass road connecting the village of Deir al Hatab to the settlement of Alon Moreh; the road connecting the town of 'Aqraba to the village of Osarin; and the detour road between the town of Qabalan and the village of Osarin.</li> <li>(ii) The Israeli army continues to close the northern entrance to the town of Qabalan; the southern entrances to the town of Jamma'in and the villages of Duma and Qaryut; and the western entrance to An Naqura village opposite the settlement of Shavei Shomron.</li> </ul> </li> <li>• <b>Checkpoints:</b> The Israeli army continues to regulate times for crossing checkpoints set up around the city of Nablus: <ul style="list-style-type: none"> <li>(i) At Tur neighbourhood checkpoint (set up on Jerzim Mount) is closed on Fridays and Saturdays as well as during Jewish holidays. On all other days, it is open for civilian residents of the neighbourhood only between 07:00 and 02:00.</li> <li>(ii) At 'Awarta commercial checkpoint, civilians are allowed to cross between 05:00 and 20:00, but between 05:00 and 15:00 on Fridays. All civilian vehicles are allowed to access the city of Nablus, but only commercial vehicles and ambulances can leave the city through the checkpoint.</li> <li>(iii) At 00:10, the Israeli army closed Huwwara checkpoint and denied civilian access until 22:25.</li> </ul> </li> <li>• <b>Flying Checkpoints:</b> <ul style="list-style-type: none"> <li>(i) At 08:25, the Israeli army set up a flying checkpoint on the junction to Sarra village on the Nablus-Qalqiliya main road and searched civilians.</li> <li>(ii) At 16:00, the Israeli army set up a flying checkpoint near Shavei Shomron settlement on the Nablus-Jenin main road and denied civilian access until 17:15.</li> <li>(iii) At 19:20, the Israeli army set up a flying checkpoint at the entrance to Sarra village and searched civilians and vehicles.</li> <li>(iv) At 21:40, the Israeli army set up a flying checkpoint on the junction to Yatma village and searched civilians and vehicles.</li> </ul> </li> <li>• <b>Raid:</b> At 01:10, the Israeli army raided and patrolled 'Urif village.</li> <li>• <b>Settler Violence/Raid/Attack:</b> At 10:30, a group of Israeli settlers stole olive harvest on civilian land in Burin village. As he attempted to confront them, Israeli settlers severely beat Bashir Jibreel Qadous, leaving him with contusions. Qadous was transported to hospital for medical treatment. The Israeli army also raided the area, fired rubber-coated steel bullets and tear gas grenades on civilians, and evacuated settlers at 11:00.</li> </ul>

<p style="text-align: center;"><b>SALFIT</b></p>	<ul style="list-style-type: none"> <li>• <b><u>Closure of Main Roads:</u></b> <ul style="list-style-type: none"> <li>(i) The Israeli army continues to close with dirt barricades the northern entrance to the city of Salfit.</li> <li>(ii) The Israeli army continues to close with cement blocks the northern entrance to the town of Bruqin.</li> <li>(iii) The Israeli army continues to close with dirt barricades the entrance to two detour roads connecting the village of Marda to respective agricultural land.</li> </ul> </li> <li>• <b><u>Checkpoint:</u></b> The Israeli army continues to intensify its restrictions and impede civilian access at the Za'tara junction checkpoint.</li> <li>• <b><u>Flying Checkpoints:</u></b> At 08:45, the Israeli army set up a flying checkpoint at the eastern entrance to Yasuf village and searched civilians and vehicles until 12:00.</li> <li>• <b><u>Raids/Attacks on Property:</u></b> <ul style="list-style-type: none"> <li>(i) At 10:05, the Israeli army raided and patrolled Yasuf village.</li> <li>(ii) At 11:30, the Israeli army raided and patrolled Deir Istiya town.</li> <li>(iii) In the morning of 20 September 2010, the Israeli army raided Deir Ballut town and distributed notices for the cessation of building eight houses under construction, claiming that they were being built without the required construction licences and located in Area C, which is under full Israeli control. However, the Israeli army allows civilian access between 06:00 and 22:00.</li> <li>(ii) The Israeli army continues to intensify its restrictions at the checkpoint set up on the junction to the village of Al 'Auja along Al-Mu'arrajat road that connects the districts of Jericho and Ramallah, only allowing access to civilians whose IDs indicate that their place of residence of the district of Jericho as well as to others holding access permits.</li> </ul> </li> </ul>

Giving him a respite of 12 hours, the Israeli army delivered a notice to Majed Mufdhi for the evacuation and demolition of his barracks. The Israeli army claimed that both structures needed construction licences and were located in Area C, which is under full Israeli control.</li> <li>(ii) At 03:10, the Israeli army raided 'Aqbat Jaber refugee camp in Jericho city and arrested three civilians.</li> </ul> </li> <li>• <b><u>Arrests:</u></b> The Israeli army arrested three unidentified civilians in 'Aqbat Jaber refugee camp in Jericho city.</li> </ul>
BETHLEHEM	<ul style="list-style-type: none"> <li>• <b><u>Closure:</u></b> <ul style="list-style-type: none"> <li>(i) The Israeli army continues to close the roads to the village of An Nu'man, with the exception of the road leading to the Wall gate in the south-eastern area of the village.</li> <li>(ii) According to Military Order # 07/02/S, the Israeli army has continued since 15 September 2007 to deny civilian access to an area measuring 22 <i>dunums</i> (5.436 acres) of land in the area of Mazmuriya in the cities of Beit Sahur and Bethlehem. The land was confiscated pursuant to Military Order # 07/31/T.</li> </ul> </li> <li>• <b><u>Closure of Main Roads:</u></b> The Israeli army continues to close with dirt barricades the road of Beit Jala-Wadi Ahmad; a road east of Beit Fajjar town; and a rural road connecting Tuqu' town to Khirbet al Baq'a village.</li> <li>• <b><u>Flying Checkpoints:</u></b> <ul style="list-style-type: none"> <li>(i) At 13:20, the Israeli army set up a flying checkpoint on An Nashash junction (the southern entrance to Bethlehem city) and searched civilians and vehicles.</li> <li>(ii) At 13:45, the Israeli army set up a flying checkpoint at the entrance to Husan village and searched civilians and vehicles.</li> <li>(iii) At 16:40, the Israeli army set up a flying checkpoint at the entrance to Tuqu' town and searched civilians and vehicles.</li> <li>(iv) At 22:20, the Israeli army set up a flying checkpoint at the entrance to Battir village and searched civilians and vehicles.</li> </ul> </li> <li>• <b><u>Raids:</u></b> <ul style="list-style-type: none"> <li>(i) At 12:50, the Israeli army raided Husan village and arrested four civilians, including two brothers.</li> <li>(ii) At 20:45, the Israeli army raided and patrolled Nahhalin village.</li> </ul> </li> <li>• <b><u>Arrests:</u></b> The Israeli army arrested four civilians in Husan village: <ul style="list-style-type: none"> <li>(i) Ziyad Haydar Abdul 'Aziz Hamed;</li> <li>(ii) Shakir Hasan Abdullah Najajreh;</li> <li>(iii) Husan Mash'hour Abdul Hamid Hamamreh; and</li> <li>(iv) Sameh Mash'hour Abdul Hamid Hamamreh.</li> </ul> </li> </ul>

Israeli troops allowed access to pupils after coordination with the Israeli authorities (through the DCO).</li> <li>• <b><u>Wall Construction:</u></b> Wall construction continues in the area northwest of the town of Al Khadr; northwest of the city of Beit Jala; in the area of Wadi Rahhal east of Efrat settlement; and in the area surrounding Al Walaja.</li> </ul>
