- Since September 17th 2013, Israeli forces increased their restrictions at (i) checkpoints located at the entrance to Jerusalem city, set up several flying checkpoints on the main road leading to the city and prevented worshipers under the age of 50 from conducting prayers at Al-Aqsa mosque compound.
- (ii) The Israeli army continues to close the 'demarcation area' along the Wall in the area surrounding occupied East Jerusalem and restricts access to local residents as well as to civilians holding special permits.
- The Israeli army continues to impose a blockade and deny civilian access to a (iii) hill between Biddu and Beit Iksa villages.

Closure of Main Roads:

- The Israeli army continues to close with cement blocks and dirt mounds the (i) entrance to Jaba' village.
- The Israeli army continues to close with an iron gate the eastern entrance to (ii) Beit Iksa village and forces civilians to access Jerusalem city through Qalandiya checkpoint.

Checkpoints:

- (i) Israeli authorities continue to consider Qalandiya checkpoint a "border crossing point" and designate a special crossing lane for holders of Jerusalem IDs and another for those possessing permits to access Jerusalem city and at 06:00, Israeli forces closed the checkpoint impeded the free flow of traffic.
- (ii) On September 19th 2012, Israeli forces closed Ras Khamis checkpoint near Shu'fat camp and impeded the free flow of traffic in order to construct the wall.
- Raid: At 16:45, Israeli forces raided Abu Did and clashed with several students near Abu Dis University.

Detention:

(i) At 05:00 on September 22nd 2013, Israeli forces detained 2 residents including a child: Mohammad Al-Awar (14 years old) and Na'im Hadadi after storming their home in Silwan neighbourhood in Jerusalem.

JERUSALEM

- (ii) At 09:30, Israeli forced detained Baha Suliman inAl-Aqsa mosque compound in the old city of Jerusalem.
- <u>Home Demolition:</u> At 14:00, Israeli forces stormed Silwan neighbourhood and served a demolition orders for a home owned by Isam Da'ana, a merchant shop owned by Majdi Al-Abbas and a car wash owned by Al-Qara'ien family.
- <u>Assault on Places of Worship:</u> At 09:30, Israeli settlers under the protection of Israeli forces stormed Al-Aqsa mosque compound in the old city of Jerusalem and provoked worshipers.

• Settler Violence:

- (i) At dawn on September 22nd 2013, Israeli settlers punctured the tires of 6 vehicles owned by Salam, Zahran, Al-Kiwasni, Muhesien, Hajja and Shamsana families in Sheikh Jarrah neighbourhood in Jerusalem and sprayed racist graffiti on the vehicles.
- (ii) At 22:30, Israeli settler assaulted and injured several residents in Al-Wad Street in the old city of Jerusalem.

• Wall Gates:

- (i) The Israeli army continues to close with cement blocks the Wall gate in Abu Dis town.
- (ii) The Israeli army continues to deny civilian access through the Wall gate on Al-Shayyah road in the area between Al-Sawahira Al-Sharqiya and Al-Slewahira Al-Gharbiya villages, only allowing civilians holding Jerusalem IDs to cross, after subjecting them to thorough searches using electronic devices.
- Wall Construction: Wall construction continued in the areas north and south of Qalandiya village; south of Al-Za'ayyem village; and in Wadi Al-Eizariya west of the illegal settlement Ma 'ale Adumim.

• Closure of Main Roads:

- (i) The Israeli army continues to close the entrances to Sinjil village well as the junction to Kafr Malik and 'Ein Samiya villages.
- (ii) At 09:35, on September 3rd 2013, Israeli forces closed the north east entrance of Al-Mughier village with dirt mounds.
- **Flying Checkpoint:** At 19:30, Israeli forces set up a checkpoint at the entrance of Deir Abu Mash'al village, detained a resident then withdrew at a later time.

Raid:

- (i) At 02:35, Israeli forces raided Beituniya and opened fire as they surveyed the area.
- (ii) At 02:50, Israeli forces raided Silwad and detained a resident.
- (iii) At 03:40, Israeli forces raided Abboud and detained 6 residents.
- (iv) At 03:50, Israeli forces raided Ramallah, opened fire then withdrew at 06:00.

• Detention:

- (i) Israeli forces detained Mohammad Al-Farr (Special Need Patient) in Deir Abu Mash'al.
- (ii) Israeli forces detained Mouath Hammad in Siwlad.
- (iii) Israeli forces detained 6 residents: Tariq Al-Barghouthi, Mohammad Jabr, Ahmad Abu Hassan, Moath Sabti, Jihad Al-Barghouthi and Abdallah Bargouthi in Abboud.
- Attack: At 17:15, Israeli forces positioned at the entrance of Al-Jalazoun camp fired rubber coated steel bullets and tear gas grenades towards several residents for alleged stoning and as a result injured Ibrahim Safi.
- Wall Construction: Wall construction continued in the area west of 'Abud town in the area surrounding the illegal settlement 'Ofarim and north of Al-

QALQILIYA

- (ii) In addition to closing the gate installed since the outbreak the second Intifada, the Israeli army continues to close with dirt mounds the eastern entrance to Kafr Qaddum village.
- **Flying Checkpoint:** At 10:40 and again at 21:10, Israeli forces set up a checkpoint at the entrance of Azzun.

• Raid:

- (i) At 13:30, Israeli forces raided Beit Ammin and Sinariya villages, took photographs of a home (under construction) owned by Nidal Amr (the man convicted of killing an Israeli soldier as mentioned in the previous report.
- (ii) At 01:25, Israeli forces raided Qalqiliya, stormed several homes, opened fire on a vehicle, detained 3 residents, assaulted and injured Ahmad Zied leaving him hospitalised with contusions then withdrew at 05:00.

• Detention:

- (i) At 09:30, Israeli forces positioned at the wall gate leading to Azzun Atma detained Banan Ahmad a resident of Azzun Atma.
- (ii) Israeli forces detained 3 residents: Mohammad Sharim, Shadi Haedan and Yahya Dahoud in Qalqiliya.

• Settler Violence:

- (i) At 12:45, Israeli settlers stormed Al-Jit village and uprooted 50 Olive trees owned by Maher Yammin.
- (ii) At 22:10, Israeli settlers stoned vehicles and residents passing along Kafr Laqif village junction

• Wall Gates:

- (i) The Israeli army continues to restrict access at 'Azzun 'Atma Wall gate and to search civilians, including students, using a metal detector.
- (ii) The Israeli army continues to close with an iron gate the entrance to the village of Wadi Al-Rasha and to deny civilian access. The Israeli army allows residents to access the village through Gate #109. Having removed the gate at the entrance to the village of Ras Atiya; the Israeli army only allows students to cross to their schools outside the village through the Habla gate.

• Wall Construction:

(i) Wall construction continued in Kafr Laqif village north of Karnei Shomron settlement; in Immatin village northeast of Immanuel settlement; and east of Kafr Thulth town near Ma 'ale Shomron settlement.

• Closure of Main Roads:

- (i) The Israeli army continues to close the roads of Til-Burin and Beit Furik-Salem; the settler bypass road connecting the village of Deir al Hatab to the settlement of Alon Moreh; the road connecting the town of 'Aqraba to the village of Osrin; and the detour road between the town of Qabalan and the village of Osrin.
- (ii) The Israeli army continues to close the northern entrance to Qabalan town; the southern entrances to the town of Jamma'in and the villages of Duma and Qaryut.
- <u>Checkpoint:</u> At 11:25 and again at 20:45, Israeli forces increased their restrictions at Huwara checkpoint and impeded the free flow of traffic.
- **Flying Checkpoint:** At 10:05 Israeli forces set up a checkpoint at the entrance of Deir Sharaf.

- Since August 2nd 2012, Israeli forces closed a road leading to Beit Jalla. Since May 8th 2013, Israeli forces closed the road connecting Al-Carmisan (iv) area in Beit Jalla and Al-Walaja with a steel gate and barbed wires.
- Since June 3rd 2013, the Israeli army closed the road connecting Nihalin and (v) road 60 with dirt mounds.
- Since 11:30 on June 8th 2013, the Israeli army closed a road leading to 50 acres of agricultural land in Wadi Salem area in Al-Khadr with dirt mounds.

Flying Checkpoint:

- (i) At 10:50, Israeli forces set up a checkpoint near Al-Kahdr.
- (ii) At 19:50, Israeli forces set up a checkpoint at the west entrance of Taqou'.

Wall Construction:

- (i) Wall construction continued in North West of Beit Jala town for Sabath holiday.
- (ii)On May 1st 2103, an Israeli court ordered the halt of wall construction near Betar village.
- (iii) On July 21st 2013, Israeli courts ordered the halt of construction of the wall in Al-Carmisan area in the west area of Beit Jalla.

Closure:

- (i) The Israeli army continues to close Al-Shuhada' Street, Al-Sahleh and Khuzq Al-Far areas, as well as the old gold market in Hebron's Old City. In addition to closing the entrance to Al-Qeisi neighbourhood, the Israeli army continues to close the entrances to the area of Al-Hisba (the fruits and vegetables market) with an electronic gate; Al-Laban Market also remains closed.
- (ii) Since 05 January 2009, the Israeli army has closed the area located along the Green Line south of the town of Yatta. Having seized land for Wall construction, the Israeli army evicted the Palestinian residents and denied them access to the area.
- (iii) At 17:40, Israeli forces closed checkpoints and steel gates leading into the old city of Hebron, installed several checkpoints around the city, stormed and searched several homes after an Israeli soldier was shot and killed by an unidentified individual.

• Closure of Main Roads:

- (i) The Israeli army continues to close the entrances to Al-Thahiriya and Al-Samoa' towns, Al-'Arrub refugee camp, and Al-Tuwani and Al-Karmil villages.
- (ii) The Israeli army continues to prohibit Palestinian vehicles from travelling along the old Al-Shalala Street leading to Hebron's Old City.
- (iii) The Israeli army continues to close all roads leading to Road #60 as well as detour roads along the settler bypass road leading to Yatta town.
- (iv) The Israeli army continues to close with dirt mounds a detour road leading to e to Al-Simiya village, the southern entrance of Al-Samou' and the entrance of Beit Annun with cement blocks.
- (v) Since July 25th 2012, Israeli forces closed the road connecting Al-Safa and Al-Dirat and also closed the entrance of south Yatta with cement blocks.
- (vi) Since December 27th 2012, Israeli forces closed the west entrance of Swiesiya village which connects Yatta and Al-Samou' village with cement blocks.
- (vii)At 22:40, Israeli forces closed the entrance leading to Sa'ir village with Cement blocks.

Flying Checkpoint:

HEBRON

- (i) At 09:00, Israeli forces set up checkpoints at the north entrance of Hebron, the entrance of Farsh Al-Hawa area, the entrance of Beit Kahil and the entrance of Nabi Na'im.
- (ii) At 19:00, Israeli forces set up 9 checkpoints at the north entrance of Hebron, the entrance of Farsh Al-Hawa area, the entrance of Beit Kahil and the entrance of Nabi Na'im, at Beit Anun junction, in the area located between Hebron and Dura, at the entrance leading to South Hebron and the area between Yatta and Al-Samou'.

Raid:

- (i) At 03:000 on September 22nd 2013, Israeli forces raided Surif and detained 2 residents.
- (ii) At 04:00 on September 22nd 2013, Israeli forces raided Beit Ummar and detained a resident.
- (iii)At 04:00 on September 22nd 2013, Israeli forces raided Duraand detained a resident

• Attack:

- (i) At 15:10, Israeli forces positioned near Al-Ramadin village and opened fire towards several labourers as they were attempting to cross into Israel for work.
- (ii) At 12:00, Israeli forces positioned near Bab Al-Zawiya fired rubber coated steel bullets, tear and stun grenades towards several residents for alleged stoning and as a result injured 3 residents: Nimr Salima, Azam Al-Qadi and Mohammad Hijeh as well as detaining 2 children.
- (iii)At 17:20, Israeli forces positioned at the entrance of Al-Fuwar camp fired tear gas grenades towards several residents for alleged stoning.
- (iv)At 21:15, Israeli forces positioned at Al-Shalalat road in the old city of Hebron fired rubber coated steel bullets and tear gas grenades towards several resident a for alleged stoning and as a result injured Osama Abu Turki, Firas Faraj, Samer Al-Tarada, Amir Nassar, Ibrahim Abu Hammed and Ibrahim Abu Eisheh.

• Detention:

- (i) At 12:00, Israeli forces detained the child Suliman Idris (14 years old).
- (ii) At 22:25, Israeli forces detained 8 residents: Mahdi Al-Qamari (Police Officer), Majd Salaymeh, Mu'tasim Al-Salaymeh, Zaki Al-Rajabi, , Osama Ghayth , Wasfi Ghayth, Shager Salaymeh and Hazem Salaymeh in the old city of Hebron.
- (iii)Israeli forces detained Saher Al-Hih and Anas Al-Hur in Surif village.
- (iv)Israeli forces detained Mohammad Abu Mariya in Beit Umar.
- (v) Israeli forces detained Bashir Al-Sahahiyat and Munir AL- Sahahiyat in Dura.
- (vi) Israeli forces detained 2 children: Abdallah Dweik (17 years old) and Mohammad Gayth (15 years old) near Bab AlZawiya in the old city of Hebron.
- **Physical Assault:** At 23:00, Israeli forces assaulted and injured Reem Al-Karari (Pregnant Woman) after storming her home in the old city of Hebron leaving her hospitalised with contusions.

• Obstruction of Educational Sector:

- (i) At 08:00, Israeli forces stormed the main Boys school in the old city of Hebron, occupied its roof top and converted it into a military post then fired stun and tear gas grenades towards several school children for alleged stoning.
- (ii) At 23:15, Israeli forces stormed Tarik Bin Zaued School in the old city of Hebron, occupied its roof top and converted it into a military post

Home Demolition:

- (i) At 22:00 on September 22nd 2013, Israeli forces occupied the home of Salem Salaymeh in the old city of Hebron and converted its roof top into a military post.
- (ii) At 08:00, Isareil forces Israeli forces occupied a home in Beit Kahil and converted its roof top into a military post.
- (iii)At 17:15, Israeli forces occupied a home owned by Jihad Al-Ja'bari in Beit Anun village and converted its roof top into a military post.

• Settler Violence:

- (i) At 15:50, Israeli settlers stormed agricultural land in Yatta and uprooted 10 olive trees owned by Fadil Rab'I and assaulted and injured him as he attempted to prevent the settler attack during which Israeli forces fired stun and tear gas grenades towards several residents as they attempted to prevent the settler attack.
- (ii) At 22:00, Israeli settlers stoned several homes near Tel Al-Rumayda neighbourhood in the old city of Hebron.
- <u>Assault on Places of Worship:</u> On September 22nd 2013, Israeli forces closed access to the Ibrahimi mosque in the old city of Hebron in order to allow Israeli settler to perform Talmudic rituals in the mosque.
- <u>Demonstration:</u> At 09:35, a demonstration took place in front of the International Rd Cross headquarters in Hebron in solidarity with Palestinian detainees and demanding their released from Israeli prisons.
- <u>Wall Construction:</u> Wall construction was halted in the area surrounding the illegal settlement Eshkolot, west of Al-Thahiriya town for Jewish holiday.

GAZA STRIP

At 21:00 on November 21st 2012, the unilateral ceasefire declared by Israel came into effect. At a later time on the same day, armed Palestinian groups announced an agreement to cease fire. On November 14th 2011 Israeli forces placed floating marks 3 miles from Gaza's seashore and warned fishermen against passing beyond the mark and on November 24th 2012, Israeli forces imposed floating marks of 6 miles and on March 21st 2013 re imposed fishing restrictions of 3 miles.
