MONTHLY SUMMARY OF ISRAELI VIOLATIONS

01 July 2008 - 31 July 2008

The following summary table and overview of events is a survey of Israeli violations during the period 01 July 2008 to 31 July 2008. The report includes a summary table of events by type throughout the West Bank and Gaza Strip, in addition to a comparative table surveying events over the past three months. The survey is compiled from Daily Situation Reports of the Palestinian Monitoring Group (PMG), Negotiations Affairs Department (NAD), Palestine Liberation Organization (PLO). The PMG monitors all aspects of ground conditions in the West Bank and Gaza Strip, including Israeli violations, Palestinian violations, and Palestinian achievements. The PMG Daily Situation Reports are a survey of daily events collated from information provided by Palestinian Authority civil ministries and security agencies. The information reported through the PMG process represents data available at the time of distribution only.

SAMPLE OF ISRAELI ARMY VIOLATIONS DURING THE MONTH OF JULY 2008

- On July 03, a public march set out in the town of Ni'lin in Ramallah district, with the participation of international peace activists and supporters, in protest of the Wall construction. The Israeli army clashed with civilian protestors and injured 8 civilians, including 1 child, and 2 international peace activists.
- On July 09, the Israeli army raided an area located to the west of the city of Jenin, opened fire intensively, assassinated 1 civilian, and injured and arrested another.
- On July 10, in violation of the cease fire agreement in the Gaza Strip, the Israeli army opened fire from its posts inside the Green Line towards 1 civilian for coming close to Kisofim Gate on the Green Line east of the city of Deir al-Balah, and killed him instantly.
- On July 11, the Israeli army raided the refugee camp of al-Jalazon in Ramallah district, clashed with civilians and seriously injured 1 civilian.
- On July 14, in violation of the ceasefire agreement in the Gaza Strip, the Israeli army opened fire from its posts inside the Green Line and injured 1 civilian east of the city of Deir al-Balah.
- On July 15, the Israeli army raided the town of Beit Fajjar in Bethlehem district, imposed curfew, and closed its entrances with dirt mounds. In addition, the Israeli army occupied rooftops of a number of civilian houses and converted them into military posts. Moreover, the Israeli army clashed with civilians, injured 1 child and arrested 2 civilians.
- On July 15, Israeli navy boats opened fire towards fishing boats on Soudaniyyeh shore west of northern Gaza and injured 1 fisherman.
- On July 23, the Israeli army raided the city of Hebron, and a military jeep ran over and seriously wounded a 6-year-old child.
- On July 29, a public march set out in the town of Ni'lin in Ramallah district, with the participation of international peace activists and supporters, in protest of the Wall construction. The Israeli army clashed with civilian protestors and killed an 11-year-old child and injured 3 civilians. The next day, confrontations between the Israeli army and Palestinian civilians renewed during the funeral procession of the deceased child. During the confrontations, the Israeli army injured 6 civilians, including 1 child who was seriously injured, and 2 officials from the Civil Defence who were putting off fire that broke out in a commercial store.





ANALYSIS OF EVENTS

1. Assassinations

The Israeli army assassinated 1 civilian west of the city of Jenin and injured and arrested another.

2. Deaths/Killings

The Israeli army killed 6 Palestinian civilians in July, 5 in the West Bank and 1 in the Gaza Strip. The Israeli army killed Palestinians in the following districts: Jerusalem, Ramallah, Salfit, Hebron, and Central Gaza. Of these, the Israeli army killed one 11-year-old child during confrontations in protest against the Wall construction in the town of Ni'lin in Ramallah district, and 2 armed individuals.

3. Injuries

The total number of injuries reported during the month of July was 160, 156 Palestinians in the West Bank and 4 in the Gaza Strip. Most injuries were reported in the districts of Ramallah (103), Toubas (21) Bethlehem (9) and Hebron (9). Of those injured, 20 were children, including 1 child who was run over by an Israeli military jeep; 1 female civilian; 1 advisor to Prime Minister Salam Fayyad; 2 journalists; 6 international peace activists; 1 fisherman; 1 military officer.

4. Arrests

The Israeli army arrested 428 Palestinian civilians in July, 423 Palestinians in the West Bank and 5 in the Gaza Strip. The majority of arrests were reported to have taken place in the districts of Nablus (150); Hebron (68); Bethlehem (40); Jenin (34); Ramallah (32); Jerusalem (27). Among those arrested were 30


children; 6 female civilians, including 1 PLC deputy; 3 injured civilians; 1 civilian with special needs; 17 university students; 10 military officers; 3 armed individuals.

5. Closure

Especially on Fridays, the Israeli army has continued to intensify its restrictions at checkpoints located at the entrances to the city of Jerusalem and prevented civilians from accessing the al-Aqsa Mosque compound. Throughout the month of July, the Israeli army has continued to intensify its restrictions at permanent checkpoints set up throughout the West Bank districts. The Israeli army continued as well to isolate the northern districts from the central and southern districts of the West Bank, impeding civilian movement between these districts. Israeli troops positioned at the Za'tara junction checkpoint and at the entrances to the cities of Tulkarem and Nablus continued to impede access to civilian residents. Additionally, the Israeli army also continued to isolate the Jordan Valley and impede civilian access by adopting harsher measures at permanent checkpoints set up in Tayaseer.

Special permits are still required for private civilian vehicles to cross Huwara and Beit Iba checkpoints at the entrances to the city of Nablus and for vehicles leaving the city of Jericho through the checkpoint set up at the southern entrance to the city as well as through Ma'ale Efrayim, al-Hamra, and al-'Auja checkpoints leading to the area of the Jordan Valley. Considering it a "border crossing point," the Israeli army continued to prevent Palestinian West Bank civilian vehicles from crossing Qalandya checkpoint towards the towns of al-Ram and Qalandya, as well as Dahiyat al-Bareed north of the city of Jerusalem.

Further impeding civilian access, the Israeli army set 551 flying checkpoints in and around Palestinian residential locales throughout the West Bank during the month of July, compared to 519 flying checkpoints in June and 515 in May. The chart below shows the distribution of flying checkpoints in the West Bank for July 2008.




Distribution of flying checkpoints in the West Bank – July 2008

6. Attacks

A total of 155 attacks were reported during the month of July, 139 attacks in the West Bank and 16 in the Gaza Strip.

The Israeli army carried out 52 attacks during raids into Palestinian residential areas; 80 attacks during confrontations between the Israeli army and Palestinians; 9 attacks from Israeli army military posts towards civilian houses and property; 5 attacks were carried out by settlers; 8 attacks from navy boats. In addition, Israeli combat aircraft, helicopters and UAVs carried out 1 air attack.

On 19 June 2008, through Egyptian mediation, armed individuals in the Gaza Strip and the Israeli army reached a ceasefire agreement, but during the month of July the Israeli army violated the agreement on 16 occasions (compared to 6 occasions last June), while Palestinian armed individuals violated the agreement on 11 occasions and fired 11 mortars towards the Green Line 3 of which fell in Palestinian areas (compared to 13 last June). In addition, armed individuals opened fire towards the Green Line on 1 occasion resulting in the death of 1 civilian, the injury of 1 female civilian, 1 fisherman and 2 civilians.




Israeli attacks in the West Bank and Gaza Strip – July 2008

7. Raids

1. The Israeli army carried out a total of 920 raids into Palestinian residential locales during the month of July. The majority of Israeli army raids took place in the districts of Hebron (144); Ramallah (124); Bethlehem (111); Jenin (106); Nablus (105).

The Israeli army opened fire during 52 raids, approximately 5.7% of the total number of raids into Palestinian residential areas. Additionally, the Israeli army imposed curfew 15 times on 9 residential locales in the West Bank during raids (compared to 9 times in June and 6 times in May). During the raids, the Israeli army occupied and converted into military posts 13 civilian houses and residential buildings. The following graph shows the correlation between the number of raids and resulting human losses:

- 2. The Israeli army also continued to intensify its raids on Palestinian Authority controlled territory (Areas A under the Oslo Agreement), which the Israeli army re-occupied in 2002. The Israeli army conducted 521 raids, approximately 56.6% of the total number of raids, into Palestinian Authority controlled territory in the West Bank.
- 3. In an unceasing attempt to thwart the Palestinian security plan in the city of Nablus and the refugee camps in it, the Israeli army raided the city and its refugee camps 214 times during the month of July (178 raids in June, 121 raids in May). In addition, the Israeli army opened fire on 31 occasions during raids (28 times in June, 21 times in May), killed 1 civilian (3 civilians last June) and injured 24 civilians, including 22 children (10 civilians last June, 2 civilians in May) Furthermore, the Israeli army arrested 116 civilians, including 3 children, 1 civilian with special needs, 4 female civilians, and 3 military officers (compared to 49 arrestees last May), and set up military posts in front of national security and civil police headquarters.

8. House Demolitions

During the month of July, the Israeli army demolished 7 civilian houses in the West Bank, including one 5-storey building, 1 civilian house in Beit Hanina village, and 2 civilian houses in al-Issawiyyeh village in Jerusalem district for unlicensed construction; 1 civilian house between the city of Hebron and the town of Tafouh; partial demolition of 2 civilian houses in the city of Hebron.

9. Provocation of Palestinian Military and Security Forces

The Israeli army provoked Palestinian forces in West Bank districts on 12 occasions during the month of July (not including the 10 Palestinian military officers who were arrested by the Israeli army). The provocation was reported to have taken place in the West Bank as follows:

10. Attacks on Public and Private Property

A total of 126 incidents of destruction and confiscation of public and private property were reported during the month of July, 125 in the West Bank and 1 in the Gaza Strip.

The Israeli army (and settlers) demolished furniture of 6 civilian houses in the cities of Jerusalem, Jenin, Nablus and Bethlehem; set 1 civilian house on fire and blew up an entrance of another in the city of Hebron; damaged the windshields of 1 Civil Defence vehicle in Ramallah district and of 1 civilian vehicle in Nablus district; blew up 1 vehicle in Tulkarem district; caused damage to 2 civilian vehicles and tore civilian IDs in Qalqilya district; caused damage to 1 commercial store and 1 internet café in Ramallah district; shut down commercial stores in Jericho, Hebron and Nablus districts; damaged doors of 2 municipal councils in the cities of al-Bireh and Nablus; caused damage to contents of 4 Islamic charitable societies and shut down 10 charitable societies in the city of Nablus; caused damage to contents of 1 mosque and damaged door of 1 clinic in Hebron district; caused damage to 1 communication room and 1 water well in Nablus district; caused damage to electric network in Northern Gaza district; cut down olive trees in Ramallah, Qalqilya, Nablus and Hebron

district.

Israeli troops confiscated computers from mosques in Jerusalem and Ramallah districts, and from the municipal council of the city of al-Bireh, as well as from several charitable societies in the city of Nablus; 1 machine gun in Tulkarem district; 1 hunting rifle in the city of Nablus; 1 pistol in Hebron district; furniture of 1 clinic; 7 school buses in the city of Nablus; 20 instruments, including bulldozers and drilling tools in Bethlehem district.

11. Settlement Activity

Settlers carried out settlement activities in West Bank districts on 2 occasions during the month of July. Settlers razed land in the area of Jabal Hadara that is located between the villages of Bourin and Arraq Bourin in Nablus district; expanded Avraham Avino settlement outpost in the city of Hebron.

12. Settler Violence

Israeli settlers carried out 46 violent incidents in West Bank districts during the month of July.

Israeli settlers fired 5 missiles towards the village of Bourin in Nablus district; assaulted and injured civilians with daggers; attacked children in a summer camp; physically assaulted 1 civilian and tied him to an electric post near Asfer settlement in Hebron district; attacked children and international peace activists, including 1 American peace activist and a German delegation, in the old city of Hebron; attacked a number of civilians in Nablus district; stoned civilian vehicles travelling on Jerusalem-Ramallah Road and Qalqilya-Nablus Road, as well as on the bypass road alongside Yitzhar settlement in Nablus district; stoned 1 civilian house in the old city of Hebron; set on fire 1 civilian house in Nablus district and attempted to seize another civilian house in Jerusalem district; entered a Palestinian neighbourhood in the city of Ramallah; demolished Bedouin tents in Ramallah district; entered 2 villages in Jericho district; entered the previously evacuated military camp of Ush Ghurab in Bethlehem district and attempted to set up a new settlement outpost; cut down olive trees in Ramallah and set land planted with olive trees on fire in Qalqilya, Nablus and Hebron districts; caused damage to plants north of the town of Halhul; prevented labourers from building an electric room between the village of Kafr Qadum and the settlement of Qadumim in Qalqilya district; damaged 1 communication room and 1 water well in Nablus district; sprinkled toxic substances on an agricultural land in the town of Tekoa and killed 14 sheep and poisoned 18.

13. Medical Obstruction

In July, the Israeli army carried out 8 incidents of medical obstruction in the West Bank. The Israeli army searched 2 hospitals in Jerusalem and Ramallah, and 3 clinics in Nablus and Hebron districts; denied access to 2 ambulance vehicles carrying wounded Palestinians access through a checkpoint in Bethlehem district; detained medical crew and denied it access into a town in Ramallah district.

14. School Disruption

The Israeli army carried out 6 incidents of school disruption during the month of July. The Israeli army entered and searched 1 UNRWA elementary school for girls in the city of Qalqilya; entered 1 kindergarten and 2 schools in the city of Nablus; detained officials from the Ministry of Higher Education who were carrying exam papers to prisoners from Tulkarem and Hebron districts.

15. Closure of Crossing Points

The Israeli army completely closed crossing points in the Gaza Strip, including Green Line crossing points on 112 occasions, in July. The Israeli army closed crossing points into the Green Line on 50 occasions. Al-Muntar (Karni) Crossing was opened 24 days only to let in good and cement. Karm Abu Salem –

Kerem Shalom was closed the whole month. Sufa Crossing (designated for construction cargo transportation) was opened on 25 occasions. Al-Shuja'iya (Nahal 'Oz) Crossing (designated for fuel transportation) was opened on 25 occasions.

Israel closed Rafah international crossing point and Arafat International Airport on 62 occasions. Rafah Crossing bordering with Egypt was closed the entire month of June, as was Yasser Arafat International Airport. The airport has remained closed since the outbreak of the current Intifada (Uprising) in 2002.

16. Palestinian Security Measures

During the month of July, Palestinian Security Forces carried out security measures 12 different times in the West Bank. The security measures were reported to have taken place in the districts of Ramallah (2); Nablus (4); Jericho (6). The Palestinian forces handed over to the Israeli side through the D.C.O. 6 settlers, damaged and detonated 6 explosive devices.
