JERUSALEM	<ul style="list-style-type: none"> • <u>Closure:</u> <ul style="list-style-type: none"> (i) Israeli forces continue to intensify their restrictions at checkpoints located at the entrance to Jerusalem city, set up several flying checkpoints on the main road leading to the city and prevented worshipers under the age of 50 from conducting prayers at Al-Aqsa mosque compound. (ii) The Israeli army continues to close the 'demarcation area' along the Wall in the area surrounding occupied East Jerusalem and restricts access to local residents as well as to civilians holding special permits. (iii) The Israeli army continues to impose a blockade and deny civilian access to a hill between Biddu and Beit Ikksa villages. • <u>Closure of Main Roads:</u> <ul style="list-style-type: none"> (i) The Israeli army continues to close with cement blocks and dirt mounds the entrance to Jaba' village. (ii) The Israeli army continues to close with an iron gate the eastern entrance to Beit Ikksa village and forces civilians to access Jerusalem city through Qalandiya checkpoint. • <u>Checkpoints:</u> <ul style="list-style-type: none"> (i) Israeli authorities continue to consider Qalandiya checkpoint a "border crossing point" and designate a special crossing lane for holders of Jerusalem IDs and another for those possessing permits to access Jerusalem city and at 06:00, Israeli forces closed the checkpoint impeded the free flow of traffic. (ii) On September 19th 2012, Israeli forces closed Ras Khamis checkpoint near Shu'fat camp and impeded the free flow of traffic in order to construct the wall.

	<ul style="list-style-type: none"> • <u>Assault on Property:</u> On October 1st 2013 stormed residential cave 20m (resided by Khalid Al-Zir after Israeli forces demolished his home as reported in August 21st 2013) near an area confiscated by Israeli authorities for the purpose of settlement construction and served a halt to rehabilitation construction on the cave. • <u>Settler Assault:</u> <ul style="list-style-type: none"> (i) At 03:00 on October 1st 2013, Israeli settlers stormed a cemetery near the Latin church located in Nabi Daoud gate in the old city of Jerusalem , damaged several tomb stones and spray painted racist graffiti on several tomb stones. (ii) On the morning of October 1st 2013, Israeli settlers stormed Al-Nabi Samuel village and vandalised a carwash owned by Anas Abied. • <u>Wall Gates:</u> <ul style="list-style-type: none"> (i) The Israeli army continues to close with cement blocks the Wall gate in Abu Dis town. (ii) The Israeli army continues to deny civilian access through the Wall gate on Al-Shayyah road in the area between Al-Sawahira Al-Sharqiya and Al-Slewahira Al-Gharbiya villages, only allowing civilians holding Jerusalem IDs to cross, after subjecting them to thorough searches using electronic devices. • <u>Wall Construction:</u> Wall construction continued in the areas north and south of Qalandiya village; south of Al-Za'ayem village; and in Wadi Al-Eizariya west of the illegal settlement Ma 'ale Adumim.
RAMALLAH & AL BIREH	<ul style="list-style-type: none"> • <u>Closure of Main Roads:</u> <ul style="list-style-type: none"> (i) The Israeli army continues to close the entrances to Sinjil village well as the junction to Kafr Malik and 'Ein Samiya villages. (ii) At 09:35, on September 3rd 2013, Israeli forces closed the north east entrance of Al-Mughier village with dirt mounds. (iii) At 24:00, Israeli forces closed the main entrance gate leading to "Bet El" Settlement which leads to Al-Jalazun camp main road. • <u>Flying Checkpoint:</u> At 22:25, Israeli forces set up a checkpoint at Surda village junction until 00:35. • <u>Raid:</u> <ul style="list-style-type: none"> (i) At 01:20, Israeli forces raided Bir Zeit. (ii) At 02:00, Israeli forces raided Al-Mazra'a Al-Gharbiya village, stormed several homes, detained 2 residents and summoned Hamada Abu Qar' to report to Israeli Intelligence for questioning then withdrew at 03:00. (ii) Israeli forces detained Ibrahim Qassim in Dur Al-Kara' village. • <u>Attack:</u> <ul style="list-style-type: none"> (i) At 15:15, Israeli forces positioned at the entrance of Al-Jalazun camp fired rubber coated steel bullets and tear gas grenades towards several residents for alleged stoning, temporarily detained the child Yazan Zied after injuring him and released him at 22:30. (ii) At 17:05, Israeli forces positioned at the entrance of Ofar prison fired rubber coated steel bullets and tear gas grenades towards several residents for alleged stoning. • <u>Wall Construction:</u> Wall construction continued in the area west of 'Abud town in the area surrounding the illegal settlement 'Ofarim and north of Al-Lubban Al-Gharbi and Rantis villages.

(ii) Since the evening of November 25th 2012, Israeli forces closed the western entrance of Ya’bad. • <u>Raid:</u> At 00:30, Israeli forces raided Arraba, clashed with residents as they stormed a home, temporarily detained Mohammad Mardawi then released him after questioning then withdrew at 04:50. • <u>Settler Violence:</u> At 18:30, Israeli settlers stormed the entrance of Ya’bad, stoned several vehicles and closed the road connecting Ya’bad and Imrihiya village then withdrew at 19:30. • <u>Wall Gates:</u> Passage through the Wall gates is restricted to civilians granted special Israeli permits, which undercuts the access to education and health services for civilians living behind the Wall.

(ii) The Israeli army continues to close with dirt mounds the detour road leading to Ramin village along the Tulkarem-Nablus main road. • <u>Checkpoint:</u> At 13:15, Israeli forces continue to intensify their restrictions at “Eniv” checkpoint and impeded the free flow of traffic until 15:30. • <u>Raid:</u> At 23:25, Israeli forces raided Zeita, stormed 2 homes then withdrew at 00:10. • <u>Settler Violence:</u> At 13:15, Israeli settler stormed Beit Lid junction set fire to several tires along the main road connecting Nablus and Tulkarem then withdrew under the protection of Israeli forces at 15:30. • <u>Demonstration:</u> At 11:00, a demonstration took place in front of the International Red Cross headquarters in Tulkarem in solidarity with Palestinian detainees and demanding their release from Israeli prisons. • <u>Wall Gates:</u> Passage through the Wall gates is restricted to civilians granted special Israeli permits, which undercuts the access to education and health services for civilians living behind the Wall.

(ii) In addition to closing the gate installed since the outbreak the second Intifada, the Israeli army continues to close with dirt mounds the eastern entrance to Kafr Qaddum village. • <u>Flying Checkpoint:</u> <ul style="list-style-type: none"> (i) At 09:00, Israeli forces set up a checkpoint between Hajja and Al-Fanduc villages. (ii) At 09:20, Israeli forces set up a checkpoint between Jayyus and Kafr Jammal village, temporarily detained several residents then released them after questioning. • <u>Raid:</u> <ul style="list-style-type: none"> (i) At 14:15 and again at 01:35, Israeli forces raided Qalqiliya, detained a University student then withdrew at 03:10. (ii) At 23:20, Israeli forces raided Azzun, stormed a home, detained 2 residents then withdrew at 05:00. (iii) At 00:15, Israeli forces raided Hajja village, opened fire as they stormed 2 homes, detained 2 residents then withdrew at 01:05. • <u>Detention:</u>

	<ul style="list-style-type: none"> (i) Israeli forces detained Abdel-Rahman Barham in Qalqiliya. (ii) Israeli forces detained Jihad Hussien and Nidal Hussien in Azzun. (iii) Israeli forces detained Shadi Basalat and Samer Basalat in Hajja village. • <u>Wall Gates:</u> <ul style="list-style-type: none"> (i) The Israeli army continues to restrict access at ‘Azzun ‘Atma Wall gate and to search civilians, including students, using a metal detector and at 21:40, Israeli forces closed the steel gate and prevented residents from entering or exiting the village the reopened it at a later time. (ii) The Israeli army continues to close with an iron gate the entrance to the village of Wadi Al-Rasha and to deny civilian access. The Israeli army allows residents to access the village through Gate #109. Having removed the gate at the entrance to the village of Ras Atiya; the Israeli army only allows students to cross to their schools outside the village through the Habla gate. • <u>Wall Construction:</u> Wall construction continued in Kafr Laqif village north of Karnei Shomron settlement; in Immatin village northeast of Immanuel settlement; and east of Kafr Thulth town near Ma ’ale Shamron settlement.
<p style="text-align: center;">NABLUS</p>	<ul style="list-style-type: none"> • <u>Closure of Main Roads:</u> <ul style="list-style-type: none"> (i) The Israeli army continues to close the roads of Til-Burin and Beit Furik-Salem; the settler bypass road connecting the village of Deir al Hatab to the settlement of Alon Moreh; the road connecting the town of ‘Aqraba to the village of Osrin; and the detour road between the town of Qabalan and the village of Osrin. (ii) The Israeli army continues to close the northern entrance to Qabalan town; the southern entrances to the town of Jamma’in and the villages of Duma and Qaryut. • <u>Flying Checkpoint:</u> <ul style="list-style-type: none"> (i) At 11:15, Israeli forces set up a checkpoint between Tel and Iraq Burin villages until 13:15. (ii) At 18:45, Israeli forces set up a checkpoint in Jabal Al-Tur area in Nablus, temporarily detained residents including a National Security officer: Wael Massmi and Qusay Hashash then released them at 20:00. • <u>Raid:</u> <ul style="list-style-type: none"> (i) At 10:25, Israeli forces raided Sabastiya village while escorting a group of Israeli settlers as they stormed archeological site in the area and served a demolition order for a restaurant owned by Nahid Yusef for allegedly being built without proper licencing because of its location in area C which is under Israeli administrative and military control. (ii) At 20:00, Israeli forces raided Beita village, stormed several homes and detained 3 residents including a child. (iii) At 03:30, Israeli forces raided Beit Furiq village until 03:45. • <u>Detention:</u> Israeli forces detained 3 residents: Amjad Jamil (17 years old), Sakher Hamayil and Ibrahim Hamayil in Beita.

(ii) On 15.04.2012, the Israeli army has opened the northern entrance to Salfit city to civilian which was closed since the year 2000 and prevented access from 08:00 until 09:20. (iii) Since 11:00 on July 30th 2012, Israeli forces have closed two roads leading to Abu Nasar and Qatan Al-Jama’ located in western area of Deir Istiya with cement blocks. • <u>Checkpoints:</u> Israeli forces continue to intensify their restrictions at Za’tara Al-checkpoint and impeded the free flow of traffic. • <u>Raid:</u> At 01:55, Israeli forces raided Salfit, clashed with several residents as they stormed a home and summoned Yusef Al-Arid to report to Israeli Intelligence for

(ii) Since 15 September 2007, the Israel army has prevented civilians from accessing or staying on 22 dunumes of confiscated land in Al Mazmuriya area in Beit Sahur and Bethlehem cities. • Closure of Main Roads: <ul style="list-style-type: none"> (i) The Israeli army continues to close the Beit Jala-Wadi Ahmed road; a road between Um Tuba and Al-Jass ; a road between Um Tuba and Khilat Nu'man: a road between Um Tuba and the wall; a road between Al-Khas village and the wall; the 2 by pass roads located south of Al-Walaja; a road between Talita Qumi and Nazlat Al-Sider in Beit Jala; the eastern road of Al-Khader; the road between Al-Khader and Beit Jala ; the road between Al-Khader and road #60 which lead to the eastern neighbourhoods of Bethlehem; a road leading to Wadi Rahal, and a road east of Beit Fajjar town with dirt mounds. (vi) Since 11:30 on June 8th 2013, the Israeli army closed a road leading to 50 acres of agricultural land in Wadi Salem area in Al-Khadr with dirt mounds. (vii) Since 13:20 on September 29th 2013, Israeli forces closed the road connecting Beit Jalla and Al-Khadr with dirt mounds. • Flying Checkpoint: At 20:35, Israeli forces set up a checkpoint at the entrance of Beit Fajjar until 23:00. • Raid: <ul style="list-style-type: none"> (i) At 09:30, Israeli forces raided Dar Ali area located in east Bethlehem. (iii) At 15:25 and again at 02:50, Israeli forces raided Al-Khadr , stormed a local school (Sa'ed A'as school) for alleged stoning, stormed several homes, temporarily detained its residents and questioned them then

(ii) On May 1st 2103, an Israeli court ordered the halt of wall construction near Betar village. (iii) On July 21st 2013, Israeli courts ordered the halt of construction of the wall in Al-Carmisan area in the west area of Beit Jalla.
<p style="text-align: center;">HEBRON</p>	<ul style="list-style-type: none"> • <u>Closure:</u> <ul style="list-style-type: none"> (i) The Israeli army continues to close Al-Shuhada' Street, Al-Sahleh and Khuzq Al-Far areas, as well as the old gold market in Hebron's Old City. In addition to closing the entrance to Al-Qeisi neighbourhood, the Israeli army continues to close the entrances to the area of Al-Hisba (the fruits and vegetables market) with an electronic gate; Al-Laban Market also remains closed. (ii) Since 05 January 2009, the Israeli army has closed the area located along the Green Line south of the town of Yatta. Having seized land for Wall construction, the Israeli army evicted the Palestinian residents and denied them access to the area. (iii) Since 17:40 on September 22nd 2013, Israeli forces closed checkpoints and steel gates leading into the old city of Hebron, installed several checkpoints around the city, stormed and searched several homes after an Israeli soldier was shot and killed by an unidentified individual and as a result left 3 schools closed. • <u>Closure of Main Roads:</u> <ul style="list-style-type: none"> (i) The Israeli army continues to close the entrances to Al-Thahiriya and Al-Samoa' towns, Al-'Arrub refugee camp, and Al-Tuwani and Al-Karmil villages. (ii) The Israeli army continues to prohibit Palestinian vehicles from travelling along the old Al-Shalala Street leading to Hebron's Old City. (iii) The Israeli army continues to close all roads leading to Road # 60 as well as detour roads along the settler bypass road leading to Yatta town. (iv) The Israeli army continues to close with dirt mounds a detour road leading to e to Al-Simiya village, the southern entrance of Al-Samou' and the entrance of Beit Annun with cement blocks. (v) Since July 25th 2012, Israeli forces closed the road connecting Al-Safa and Al-Dirat and also closed the entrance of south Yatta with cement blocks. (vi) Since December 27th 2012, Israeli forces closed the west entrance of Swiesiya village which connects Yatta and Al-Samou' village with cement blocks. (vii) At 22:40, Israeli forces closed the entrance leading to Sa'ir village with Cement blocks. (viii) Since 09:45 on September 23rd 2013, Israeli forces closed the main road leading to "Haji" settlement and impeded the free flow of traffic.

<p style="text-align: center;">ALL DISTRICTS</p>	<ul style="list-style-type: none"> • At 21:00 on November 21st 2012, the unilateral ceasefire declared by Israel came into effect. At a later time on the same day, armed Palestinian groups announced an agreement to cease fire. • On November 14th 2011 Israeli forces placed floating marks 3 miles from Gaza's seashore and warned fishermen against passing beyond the mark and on November 24th 2012, Israeli forces imposed floating marks of 6 miles and on March 21st 2013 re imposed fishing restrictions of 3 miles. • Israeli forces broke the ceasefire agreement by opening fire from their positions behind the Green Line towards Rafah.
