    - (ii) At 11:35, Israeli forces set up a checkpoint near Um Salmouna village then searched residents and vehicles.
    - (iii) At 19:55, Israeli forces set up a checkpoint at the west entrance of Beit Fajjar then searched residents and vehicles until 00:50.
    - (iv) At 21:50, Israeli forces set up a checkpoint near Al-Faradis village then searched residents and vehicles until 23:30.
  - **Raid:** At 22:25, Israeli forces raided Al-Abiyat area located in Bethlehem, clashed with several residents, detained a child then withdrew at 23:30.
  - **Detention:** Israeli forces detained Ayman Ameen Hussien Al-Khateeb (17 years old) in Al-Abiyat area located in Bethlehem.
  - **Attack:** At 15:35, Israeli forces positioned near the west entrance of Taqou' fired stun and tear gas grenades towards several residents for alleged stoning during which Israeli forces occupied 2 homes owned by Issa Ibrahim Al-Sha'ir and Ibrahim Hussien Jadallah and converted their rooftops into Military posts.
  - **Assault on Property:** At 12:55, Israeli forces stormed Um Al-Rakaba area in Al-Khader and served a military order to halt construction on 3 homes owned by Ibrahim Musa Salah, Nour Khalil Salah and Alaa Rizq Salah.

**HEBRON**

- **Closure:**
  - (i) The Israeli army continues to close Al-Shuhada' Street, Al-Sahleh and Khuzq Al-Far areas, as well as the old gold market in Hebron's Old City. In addition to closing the entrance to Al-Qeisi neighbourhood, the Israeli army continues to close the entrances to the area of Al-Hisba (the fruits and vegetables market) with an electronic gate; Al-Laban Market also remains closed.
  - (ii) Since 05 January 2009, the Israeli army has closed the area located along the Green Line south of the town of Yatta. Having seized land for Wall construction, the Israeli army evicted the Palestinian residents and denied them access to the area.
- **Closure of Main Roads:**
  - (i) The Israeli army continues to close the entrances to Al-Thahiriya and Al-Samoa' towns, Al-'Arrub refugee camp, and Al-Tuwani and Al-Karmil villages.
  - (ii) The Israeli army continues to prohibit Palestinian vehicles from travelling along the old Al-Shalala Street leading to Hebron's Old City.
  - (iii) The Israeli army continues to close all roads leading to Road # 60 as well as detour roads along the settler bypass road leading to Yatta town.
  - (iv) The Israeli army continues to close with dirt mounds a detour road leading to e to Al-Simiya village, the southern entrance of Al-Samou' and the entrance of Beit Annun with cement blocks.
  - (v) At 05:50 on November 5<sup>th</sup> 2015, Israeli forces closed the entrance leading Farsh Al-Hawa area in Hebron with Cement blocks.
  - (vi) At 10:30 on November 8<sup>th</sup> 2015, Israeli forces closed the junction located near "Hagi" settlement located in south Hebron with cement blocks.
  - (vii) At 21:00 on November 11<sup>th</sup> 2015, Israeli forces closed the main road connecting Beit Awwa and Al-Majd village with cement block and dirt mounds.
  - (viii) At 15:45 on November 15<sup>th</sup> 2015, Israeli forces closed Al-Samiya village junction located at the west entrance of Al-Samou' with cement blocks.
  - (ix) On November 15<sup>th</sup> 2015, Israeli forces closed the entrances of Khliat Al-Miya and Al Dirat and the two bypass roads leading east Yatta with cement blocks.
  - (x) Since 14:10 on November 23<sup>rd</sup> 2015, Israeli forces closed the entrance of Al-Qom village located in Beit Awwa with cement blocks.
  - (xi) At 08:00 on December 1<sup>st</sup> 2015, Israeli closed a checkpoint located at the entrance of Al-Shuhada road and impeded the free flow of traffic and redirected traffic towards Jabal Al-Rahmeh {for a period of 2 weeks}.
  - (xii) At 22:20 on December 9<sup>th</sup> 2015, Israeli forces closed Jabal Jales area in the old city of Hebron and closed a bypass road in the area.
  - (xiii) At 16:00, on December 11<sup>th</sup> 2015, Israeli forces closed Sa'ir entrance located along highway (60) with earth mounds.

  - (i) At 08:30, Israeli forces set up a checkpoint near Ithna junction then searched residents and vehicles.
