JERUSALEM	<ul style="list-style-type: none"> • <u>Closure:</u> <ul style="list-style-type: none"> (i) Since 07:40 on November 18th 2014, the Israeli army, intensified their restrictions at the entrance to Jerusalem city, set up several flying checkpoints on the main road leading to the city and prevented worshipers under the age of 40 from conducting prayers at Al-Aqsa mosque compound. (ii) The Israeli army continues to close the ‘demarcation area’ along the Wall in the area surrounding occupied East Jerusalem and restricts access to local residents as well as to civilians holding special permits. (iii) The Israeli army continues to impose a blockade and deny civilian access to a hill between Biddu and Beit Iksa villages. • <u>Closure of Main Roads:</u> <ul style="list-style-type: none"> (i) The Israeli army continues to close with cement blocks and dirt mounds the entrance to Jaba’ village. (ii) The Israeli army continues to close with an iron gate the eastern entrance to Beit Iksa village and forces civilians to access Jerusalem city through Qalandiya checkpoint. (iii) At 08:00, Israeli forces closed the entrance of Al-Thuri neighbourhood with cement blocks. (iv) At 09:00, Israeli forces closed the entrance of Sur Bahar village with cement blocks. (v) At 09:55, Israeli forces closed the entrance of Jabal Al-Mukabir neighbourhood with cement blocks. (vi) At 22:00, Israeli forces closed the entrance of North Al-Ram junction with dirt mounds. • <u>Checkpoints:</u> <ul style="list-style-type: none"> (i) Israeli authorities continue to consider Qalandiya checkpoint a “border crossing point” and designate a special crossing lane for holders of Jerusalem IDs and another for those possessing permits to access Jerusalem city. (ii) On September 19th 2012, Israeli forces closed Ras Khamis checkpoint near Shu’fat camp and impeded the free flow of traffic in order to construct the wall. (iii) At 08:00, Israeli forces closed Jaba’ checkpoint which connects Jerusalem, Ramallah and Jericho, impeded the free flow of traffic reopened it at later time then closed it at 22:30 before opening it later. (iv) At 08:00, Israeli forces intensified their restrictions at Hizma and Al-Za’im checkpoints and impeded the free flow of traffic. • <u>Raid:</u> At 20:15, Israeli forces raided Abu Dis, stormed several homes, clashed with several residents and as a result injured seven residents: including Malik Affanah. • <u>Attack:</u> <ul style="list-style-type: none"> (i) At 09:00, Israeli forces positioned near the wall gate in Abu Dis fired rubber coated steel bullets, stun and tear gas grenades towards several residents for alleged stoning and attempted to stormed a school before

- school administration prevented the troops from entering the school.
- (ii) At 09:55, Israeli forces positioned in Jabal Al-Mukabir neighbourhood fired stun and tear gas grenades towards several residents for alleged stoning.
 - (iii) At 10:00, Israeli forces positioned at the north junction in Al-Ram fired stun and tear gas grenades towards several residents for alleged stoning.
 - (iv) At 10:00, Israeli forces positioned near the entrance of Al-Eisawiya fired stun and tear gas grenades towards several residents for alleged stoning.
 - (v) At 12:45 and again at 22:00, Israeli forces positioned at Shu'fat checkpoint fired rubber coated steel bullets, stun and tear gas grenades towards several residents for alleged stoning.
 - (vi) At 20:15, Israeli forces positioned near Anata junction fired rubber coated steel bullets, stun and tear gas grenades towards several residents for alleged stoning and as a result injured Amin Aliyan.
 - (vii) At 20:30, Israeli forces positioned in Wadi Al-Juz neighbourhood fired rubber coated steel bullets, stun and tear gas grenades towards several residents for alleged stoning.
 - (viii) At 22:00, Israeli forces positioned in Jabal Al-Mukabir fired stun and tear gas grenades towards several residents for alleged stoning as they stormed the condolences event for the two residents: Ghassan Abu Jamal and Oday Abu Jamal who were killed in Jerusalem and as a result left several residents suffocated from tear gas inhalation.
 - (ix) At 22:30, Israeli forces positioned in Shu'fat neighbourhood fired stun and tear gas grenades towards several residents for alleged stoning.

- **Home Demolition:** On November 20th 2014, Israeli forces stormed Jabal Al-Mukabir neighbourhood, served demolition orders for two homes owned by Ghassan Abu Jamal and Oday Abu Jamal who were killed in Jerusalem and gave its residents 48 hours to remove their belongings and evacuate before implementing the demolition.
- **Assault on Places of Worship:** At 08:30, Israeli settlers under the protection of Israeli forces stormed Al-Aqsa mosque compound in the old city of Jerusalem and provoked worshippers.
- **Settler Violence:**
 - (i) At 19:20, a group of Israeli settlers stormed Jaba; village and stoned residents and vehicles then withdrew at 23:50.
 - (ii) At 20:15, a group of Israeli settlers Shu'fat neighbourhood, attempted to abduct children before being prevented by local residents.
 - (iii) At 22:00, 4 Israeli settlers positioned near "King George road" in the old city of Jerusalem assaulted a resident in his vehicle and sprayed pepper spray onto his face leaving him hospitalised with burnt eyes.
- **Detention:**
 - (i) At 07:30 on November 18th 2014, Israeli forces positioned near Al-Ram junction detained Amar Al-Qawasmi (A resident of Al-Ram).
 - (ii) At 09:00, Israeli forces positioned in Al-Sunah neighbourhood detained three residents: Mohammad Bakriyat, Obayda Amireh and Amireh Amireh.
 - (iii) At 09:00, Israeli forces positioned in Jabal Al-Mukabir neighbourhood detained three residents: Qasim Hamideh, Mo'awiya Abu Jamal and Talal Eiwisat.
 - (iv) At 11:00, Israeli force detained Dr. Alaa Atwan in Sur Bahar village.
 - (v) At 12:00, Israeli forces detained Yused Dari in Al-Eisawiya village.
 - (vi) At 13:00, Israeli forces detained two children: Ahmad Al-Rajabi (16 years old) and Mohammad Abu Nab (17 years old).
 - (vii) At 22:00, Israeli forces detained the child Tamer Sa'ida (17 years old) in Wadi Al-Juz neighbourhood.

	<p>(viii) At 22:30, Israeli forces detained Ibrahim Kanbar in Jabal Al-Mukabir neighbourhood.</p> <p>(ix) At 23:40, Israeli forces detained Ehab Al-Kasafi in Al-Ram.</p> <ul style="list-style-type: none"> • <u>Wall Gates:</u> <ul style="list-style-type: none"> (i) The Israeli army continues to close with cement blocks the Wall gate in Abu Dis town. (ii) The Israeli army continues to deny civilian access through the Wall gate on Al-Shayyah road in the area between Al-Sawahira Al-Sharqiya and Al-Slewahira Al-Gharbiya villages, only allowing civilians holding Jerusalem IDs to cross, after subjecting them to thorough searches using electronic devices.

(ii) Since September 3rd 2013, Israeli forces closed the north east entrance of Al-Mughier village with dirt mounds. (iii) Since 11:30 on October 27th 2014, Israeli forces blocked the main road near Al-Jalazoun camp and Bet El settlement with cement blocks. • <u>Flying Checkpoint:</u> <ul style="list-style-type: none"> (i) At 14:35, Israeli forces set up a checkpoint at the entrance of Ein Sina village until 16:00. (ii) At 14:05, Israeli forces set up a checkpoint near Atarah bridge located in north Bir Ziet until 15:55. (iii) At 15:30, Israeli forces set up a checkpoint at the entrance of Al-Nabi Saleh village until 16:20. (iv) At 17:05, Israeli forces set up a checkpoint at the entrance of Abboud. • <u>Raid:</u> At 10:20, Israeli forces raided Al-Bireh city, clashed with several residents as they stormed a supermarket then withdrew at 11:45. • <u>Attack:</u> <ul style="list-style-type: none"> (i) At 12:35, Israel forces positioned near "Pesagout" settlement located in east Al-Bireh city fired stun and tear gas grenades towards several residents for alleged stoning. (ii) At 15:35, Israeli forces positioned at the entrance of "Ofar" prison/Military base fired stun and tear gas grenades towards several residents for alleged stoning and detained a resident. • <u>Detention:</u> Israeli forces detained Rakan Khayal at the entrance of "Ofar" prison/Military base. • <u>Confiscation of Property:</u> At 12:30, Israeli forces positioned near Al-Taybeh confiscated several aluminium sheets donated by a local charity (used as roof sheltering for a Bedouin family). • <u>Settler Violence:</u> At 15:00, Israeli settlers positioned near "Bet El" settlement stoned residents and vehicles near Al-Jalazoun camp.
JENIN	<ul style="list-style-type: none"> • <u>Closure of Main Road:</u> <ul style="list-style-type: none"> (i) The Israeli army continues to close with dirt mounds the road leading to the town of 'Arraba east of the illegal settlement Dotan. (ii) Since the evening of November 25th 2012, Israeli forces closed the western entrance of Ya'bad. • <u>Land Confiscation:</u> On November 19th 2014, Israeli forces stormed Zabada and served a military order for the confiscation 200 km² of agricultural land in Dar Um, Nazlat Zied and Zubabada village in Ya'bad town in Tulkarem.
TUBAS	<ul style="list-style-type: none"> • <u>Flying Checkpoint:</u> At 10:05, Israeli forces set up a checkpoint near Al-Far'a village and detained a child. • <u>Raid:</u> At 14:25, Israeli forces raided Tamoun until 15:30.

TULKAREM	<ul style="list-style-type: none"> • <u>Closure of Main Roads:</u> <ul style="list-style-type: none"> (i) The Israeli army continues to close with dirt mounds the road connecting Kafr Al-Labad town to Shufa village. (ii) The Israeli army continues to close with dirt mounds the detour road leading to Ramin village along the Tulkarem-Nablus main road. • <u>Checkpoint:</u> At 18:20, Israeli forces intensified their restrictions at “Eniv” checkpoint located along the main road connecting Tulkarem and Nablus and impeded the free flow of traffic until 19:35.
QALQILIYA	<ul style="list-style-type: none"> • <u>Closure of Roads:</u> <ul style="list-style-type: none"> (i) Israeli forces continue to close with cement blocks agricultural roads east of Azzun town. (ii) In addition to closing the gate installed since the outbreak the second Intifada, the Israeli army continues to close with dirt mounds the eastern entrance to Kafr Qaddum village. • <u>Flying Checkpoint:</u> <ul style="list-style-type: none"> (i) At 11:30, Israeli forces set up a checkpoint at the entrance of Kafr Laqif and prevented vehicles from travelling to Qalqiliya city. (ii) At 13:50, Israeli forces set up a checkpoint at the east entrance of Qalqiliya . • <u>Raid:</u> At dawn on November 20th 2014, Israeli forces raided Azzun and detained two residents. • <u>Detention:</u> <ul style="list-style-type: none"> (i) On November 19th 2014, Israeli forces detained Amir Al-Ra'I in Qalqiliya. (ii) Israeli forces detained two residents: Abdallah Kharfan and Mohammed Kharfan in Azzun. • <u>Attack:</u> At 20:00, Israeli forces positioned at “Ayal” crossing point located on the Green Line in North Qalqiliya fired stun and tear gas grenades towards several children for alleged stoning. • <u>Wall Gates:</u> <ul style="list-style-type: none"> (i) The Israeli army continues to restrict access at ‘Azzun ‘Atma Wall gate and impeded the free flow of traffic. At 14:00, Israeli forces closed the Iron Gate entrance then reopened it at 14:25 The Israeli army continues to close with an iron gate the entrance to the village of Wadi Al- Rasha and to deny civilian access. (ii) The Israeli army allows residents to access the village through Gate #109. Having removed the gate at the entrance to the village of Ras Atiya, the Israeli army only allows students to cross to their schools outside the village through the Habla gate.

<p style="text-align: center;">NABLUS</p>	<ul style="list-style-type: none"> • <u>Closure:</u> Since December 17th 2013, Israeli forces ordered the closure 500 dunumes of land in Qusra village as a closed military area. • <u>Closure of Main Roads:</u> <ul style="list-style-type: none"> (i) The Israeli army continues to close the roads of Til-Burin and Beit Furik-Salem; the settler bypass road connecting the village of Deir al Hatab to the settlement of Alon Moreh; the road connecting the town of ‘Aqraba to the village of Osrin; and the detour road between the town of Qabalan and the village of Osrin. (ii) The Israeli army continues to close the northern entrance to Qabalan town; the southern entrances to the town of Jamma’in and the villages of Duma and Qaryut. • <u>Flying Checkpoint:</u> <ul style="list-style-type: none"> (i) At 10:00, Israeli forces set up a checkpoint along Al-Bithan road located at the east entrance of Nablus until 12:10. (ii) At 16:45, Israeli forces set up a checkpoint at the entrance of Beit Furiq, impeded the free flow of traffic for alleged fire-bombing of Israeli forces then allowed traffic to resume at 21:15. • <u>Raid:</u> At 12:40, Israeli forces raided Qusray village, served demolition orders for six water wells owned by Thaer Hassan, Ahmad Hassan, Sa’id Odeh, Haytham Odeh and Abdel-Rahman Hassan. • <u>Attack:</u> <ul style="list-style-type: none"> (i) At 12:30, Israeli forces positioned near Al-Sawiya village school fired stun and tear gas grenades towards several children for alleged stoning. (ii) At 13:20, Israeli forces positioned in east Orif village fired stun and tear gas grenades towards several residents for alleged stoning. (iii) On the evening of November 20th 2014, Israeli forces positioned near the by-pass road in east Deir Al-Hatab village fired rubber coated steel bullets, stun and tear gas grenades towards several residents for alleged stoning and injured the child Ahmad Odeh (16 years old). • <u>Settler Violence:</u> At 10:30, 2 Israeli settlers stormed Qusray village, attempted to attack a home during which local residents detained them then turned them over to Israeli Authorities.
<p style="text-align: center;">SALFIT</p>	<ul style="list-style-type: none"> • <u>Closure of Main Roads:</u> <ul style="list-style-type: none"> (i) The Israeli army continues to close with dirt mounds the entrance to two detour roads connecting Marda village to its farmland. (ii) On 15.04.2012, the Israeli army has opened the northern entrance to Salfit city to civilian, which was closed since the year 2000 and prevented access from 08:00 until 09:20. (iii) Since 11:00 on July 30th 2012, Israeli forces have closed two roads leading to Abu Nasar and Qatan Al-Jama’ located in western area of Deir Istiya with cement blocks. • <u>Checkpoints:</u> At 16:30, Israeli forces continue to intensify their restrictions at Za’tara checkpoint and impeded the free flow of traffic.
<p style="text-align: center;">JERICHO</p>	<ul style="list-style-type: none"> • <u>Checkpoints:</u> At 17:15, Israeli forces intensified its restrictions at Al-Hamra checkpoint set up along the road connecting Jericho and Nablus District. • <u>Flying Checkpoint:</u> <ul style="list-style-type: none"> (i) At 16:45 and again at 07:05, Israeli forces set up a checkpoint near Ein Dweik village located in North Jericho until 07:15. (ii) At 17:00, Israeli forces set up a checkpoint at the south entrance of Jericho, temporarily detained Mu’in Al-Sakran (Palestinian Intelligence officer) then released him later. (iii) At 20:10, Israeli forces set up a checkpoint at the entrance of Fasayil village.

BETHLEHEM	<ul style="list-style-type: none"> • <u>Closure:</u> <ul style="list-style-type: none"> (i) The Israeli army continues to close roads to An Nu'man village, with the exception of the road leading to the Wall gate in the south-eastern area of the village. (ii) Since 15 September 2007, the Israel army has prevented civilians from accessing or staying on 22 dunumes of confiscated land in Al Mazmuriya area in Beit Sahur and Bethlehem cities. • <u>Closure of Main Roads:</u> <ul style="list-style-type: none"> (i) The Israeli army continues to close the Beit Jala-Wadi Ahmed road; a road between Um Tuba and Al-Jass ; a road between Um Tuba and Khilat Nu'man: a road between Um Tuba and the wall; a road between Al-Khas village and the wall; the 2 by pass roads located south of Al-Walaja; a road between Talita Qumi and Nazlat Al-Sider in Beit Jala; the eastern road of Al-Khader; the road between Al-Khader and Beit Jala ; Wadi Rahal road near "Ifrat" settlement ,the road between Al-Khader and road #60 which lead to the eastern neighbourhoods of Bethlehem; a road leading to Wadi Rahal, and a road east of Beit Fajjar town with dirt mounds. (ii) The Israeli army continues to close the road leading to "Newe Daniyyel" settlement and agricultural land in Al-Khader; a road between Um Tuba and Wadi Al-Hums: Wadi Fukin, Al-Jaba, the Green Line; a road between Za'tara and a detour road, and a road between Taqou and Khirbet Al-Deir with cement blocks. (iii) Since August 2nd 2012, Israeli forces closed a road leading to Beit Jalla. (iv) Since May 8th 2013, Israeli forces closed the road connecting Al-Carmisan area in Beit Jalla and Al-Walaja with a steel gate and barbed wires. (v) Since June 3rd 2013, the Israeli army closed the road connecting Nihalin and road 60 with dirt mounds. (vi) Since 13:20 on September 29th 2013, the Israeli army closed a road leading to 50 acres of agricultural land in Wadi Salem area in Al-Khadr with dirt mounds. (vii) Israeli forces closed the main road connecting Surif and Al-Jub'a village with dirt mounds. (viii) On January 28th 2014, Israeli forces closed the steel gate at the entrance of Nihalin { replacing the dirt mounds placed at the entrance since the year 2002} and placed time schedule for opening the gate from 06:00 until 14:00 on a daily bases. • <u>Flying Checkpoint:</u> <ul style="list-style-type: none"> (i) At 07:00, Israeli forces set up a checkpoint near "Kafar Etsioyn" settlement, temporarily detained Ali Shu'fat (A resident of Al-Duhisheh camp then withdrew at 11:00. (ii) At 12:20, Israeli forces set up a checkpoint at the entrance of Betar village, detained two residents including a child then withdrew at 14:00. (iii) At 15:30, Israeli forces set up a checkpoint at Husan village junction. • <u>Raid:</u> <ul style="list-style-type: none"> (i) At 00:45, Israeli forces raided Beit Fajjar, stormed a home, and summoned two residents: Ali Taqatqa and Fayez Taqatqa to report to Israeli Intelligence for questioning then withdrew at 01:10. (ii) At 02:45, Israeli forces raided Wadi Fuqin village until 03:30. • <u>Detention:</u> <ul style="list-style-type: none"> (i) At 03:30 on November 20th 2014, Israeli forces detained Sa'eb Al-Marahba during their raid into Za'tara as mentioned in the previous report.

(ii) At 19:35, Israeli forces positioned at the entrance of Al-Jab'a village fired stun and tear gas grenades towards several children for alleged stoning and temporarily detained Bassam Hamdan (A National Security Force officer) then released him at 20:00. • <u>Settler Violence:</u> At 10:15, Israeli settlers positioned near "Kafar Itsiyon" settlement stoned residents and vehicles passing along the main road connecting Bethlehem and Hebron then withdrew at 14:00.
HEBRON	<ul style="list-style-type: none"> • <u>Closure:</u> <ul style="list-style-type: none"> (i) The Israeli army continues to close Al-Shuhada' Street, Al-Sahleh and Khuzq Al-Far areas, as well as the old gold market in Hebron's Old City. In addition to closing the entrance to Al-Qeisi neighbourhood, the Israeli army continues to close the entrances to the area of Al-Hisba (the fruits and vegetables market) with an electronic gate; Al-Laban Market also remains closed. (ii) Since 05 January 2009, the Israeli army has closed the area located along the Green Line south of the town of Yatta. Having seized land for Wall construction, the Israeli army evicted the Palestinian residents and denied them access to the area. • <u>Closure of Main Roads:</u> <ul style="list-style-type: none"> (i) The Israeli army continues to close the entrances to Al-Thahiriya and Al-Samoa' towns, Al-'Arrub refugee camp, and Al-Tuwani and Al-Karmil villages. (ii) The Israeli army continues to prohibit Palestinian vehicles from travelling along the old Al-Shalala Street leading to Hebron's Old City. (iii) The Israeli army continues to close all roads leading to Road # 60 as well as detour roads along the settler bypass road leading to Yatta town. (iv) The Israeli army continues to close with dirt mounds a detour road leading to e to Al-Simiya village, the southern entrance of Al-Samou' and the entrance of Beit Annun with cement blocks.
